Dear Clinton Community Members,  
After harsh winter weather this year, I am eager to welcome spring. When the weather does break, we continue and begin several improvement projects in Town.

Almost complete, the Clinton Dam and Dike restoration project awaits some finishing touches. In addition, the historic grandstands at Gebhardt Field will be reconstructed this spring. Please don't worry players; the field will remain open during construction. This project is funded through the Hunterdon County Open Space Program, the Clinton Parks and Recreation Commission and capital reserves from the Town.

Good news! The Town of Clinton was recently awarded \$125,000 from the NJ Department of Transportation for the East Main Street improvement project.

We will rاند sidewalks simultaneously. All three projects are completed funded through state grants.

This winter, a car accident caused the closure of the historic Pony Truss Bridge on Main Street. My gratitude to the Hunterdon County Bridge Department and Freeholders for giving their immediate attention to the repair and reopening of the bridge as it is vital to our local economy.

In closing, I'd like to thank and congratulate several people who continue to make Clinton a wonderful place to live and visit. Once again, Sean Rogan and countless volunteers planned a successful winter bonfire where residents gathered in the cold to watch the Christmas trees burn while enjoying entertainment. Thanks also to our Parks and Recreation Commission, Fire Department, Rescue Squad and Police Department for their contribution in a safe and wonderful family event.

Last month, long time business owners and Town volunteers, Carol Beder and Craig Reuter, were recognized as Volunteers of the Year by the Clinton Mayor and Council for their countless hours of volunteerism and contributions to Clinton. Carol, owner of Heartstrings, has spent years working with others to plan parades, festivals and events for the Town. Craig, owner of Main Street Communications, has contributed posters and ads to help market these events.


Finally, it's my pleasure to welcome our new Public Works/ Business Administrator, Jim Naples. I am pleased to report a smooth transition and look forward to continuing to work with Jim.

## Code Enforcement by Jack Daniels

There are many recalls of various consumer products that we as consumers never hear about. I strongly encourage everyone to log onto the Consumer Safety Product Commission webpage and review recalls to see if you have a recalled item. The Web site is as follows

<http://www.cpsc.gov/cpscpub/prereel/prereel.html>. The following are only some of the recalls listed for February 2011.

**Portable Space Heaters Recalled by PD Sixty Distributor Due to Fire Hazard Incidents/Injuries:** The firm has received one report of the heater overheating, resulting in the unit catching fire and causing minor property damage. No injuries have been reported.

**Description:** This recall involves Creative Heating Solutions brand portable space heaters with model number CH-750, CH-750FC, CH-1500 or CH-1500FC. The heater is wooden on three sides, with metal on the fourth side. The front of the heater includes a vent and a clear plastic faceplate with six black buttons. Some units have "Creative Heating Solutions" stamped into the rear metal panel and the model number on a white label on the rear metal panel.

**Lasko Recalls Portable Electric Heaters Due To Fire Hazard**

**Incidents/Injuries:** Lasko received a

total of 36 reports of the electrical connection overheating with no reports of injury. There were 18 reports of minor burn damage to floors or carpets.

**Description:** The portable, electric, tower heaters are 20.5 inches tall x 8.25 inches wide x 9.25 inches deep. They are dark grey with silver front covers and black vent slats. The brand names Lasko or Air King are on the top, center of the front cover. The Lasko Model 5540 and Air King Model 8540 subject to this recall were manufactured in 2002 and have date codes that begin with a "2." The date code is on the label located on the bottom of the unit. The date code is a four-digit number on the bottom left area of the label, above the voltage number. Heaters with date codes beginning with "3," "4" or "5" are not subject to this recall.

**Hoover Recalls WindTunnel Canister Vacuums Due to Fire and Shock Hazards Incidents/Injuries:** Hoover has received 69 reports of overheating or electrical malfunction, including one report of fire and smoke damage, and two reports of carpet damage. There has been one report of a minor injury.

**Description:** This recall involves the Hoover Wind Tunnel Bagless Canister Vacuum model S3755. The vacuum is silver and black in color, and comes with a power nozzle. The model number can be found on a label on the bot-

tom of the canister.

**AmerTac Recalls Night Lights Due to Fire and Burn Hazard**

**Incidents/Injuries:** AmerTac has received 18 reports of the night lights smoking, burning, melting and/or charring, including three reports of minor property damage and one of a minor burn injury.

**Description:** Three night light models are being recalled: model numbers 71193, 71194 and 327879. Only those with KML molded on the back are being recalled. All three models have KML, ETL, the AmerTac™ logo and the model number molded on the back of the night lights' plastic housing. Model number 71193 is a square shaped, white plastic unit with a flat translucent square window on the front and a button for changing the screen color. Model 71194 and 327879 resemble a computer mouse with white plastic housing and inset translucent windows on the front and sides.

## Public Works / Bus. Administrator by James T. Naples



It is a privilege to be the next PW/ Administrator for the Town of Clinton. Since starting the job January 10 I have been impressed with the many historic and iconic assets throughout the Town. All of the residents and merchants I have had the opportunity to meet and speak with have gone out of their way to welcome me to the community and provide me with some of the exciting background to the events and concerns that are of interest.

The first few weeks of the New Year have seen an unusual amount of snow and ice. It has gotten to the point where it seems like every other day we are either cleaning up from a storm or preparing for the next one to hit. The Public Works staff has done a tremendous job keeping the Town streets safe and removing the snow in a timely fashion. Their hard work is evident when the streets are clear in Town and snow covered elsewhere. Please remember to remove the snow and ice from the sidewalks in front of your property so that pedestrians are able to walk downtown or to school safely after a storm. As the snow melts it is important to keep all storm drains clear. If you see one that is clogged please call the Public Works department and we'll have someone out to clear it as soon

as possible.

This spring will see the start or completion of several infrastructure improvements throughout Town, some of which may be more evident than others, but all are critical to maintaining the superior quality of life in the community. The Clinton Falls Dam and Dike restoration project is nearing completion and spring will see this Town resource reopen for public enjoyment. The resurfacing of Lower Center, Main St. and East Main St. will be designed with construction to begin in 2011. The Mayor and Council were successful in obtaining two separate NJDOT grants that the Town will use to fund these improvements. The Gephardt Field grandstands will be rebuilt beginning this spring. The contractor will work with the Town to keep the field open for use during construction. The Water Utility will begin construction of a new 2.5 million gallon storage tank to be located next to the existing tank on Petticoat Lane. This tank will provide much needed added reserve capacity to the system and allow for repairs and maintenance to the existing tank once in operation. The Water Utility is also working on the replacement of the water main on Leigh Street with construction to begin this summer.

The "Greening" of the Town continues at a commendable pace as we move towards implementing the energy efficient measures outlined in the completed audit of our municipal facilities. These will include new HVAC, lighting systems and motion sensors to shut off those lights where offices are not in use. These are just some of the examples of the measures the Town will be implementing to save energy and money in the upcoming year. The improvements themselves are largely funded through grants thus saving the residents both the initial costs and the reduced energy demand. The recycling amounts continue to increase saving the Town money and returning usable materials back to use instead of sending them to a landfill. This year a new law was passed making the recycling of electronic goods mandatory. The County will be sponsoring a free electronics recycling day on March 26 from 9-1 at the Route 12 complex. If you have any old electronics this would be an excellent opportunity to dispose of them for free.

I look forward to an eventful spring with many positive projects happening throughout the Town.

## Road Department by Dan Shea

Well, it has been a busy winter with all this snow. As you are aware our DPW work crews and plow trucks have been very active and the amount of cost has been high to keep the roads in such good condition. Thank you for your patience with all our maintenance efforts. Recently, we have been very fortunate to receive a \$125,000 State grant to resurface the roads on East Main Street. We will be combining this with our existing State grants for repaving Main & Lower Center Streets to create a single project with construction to begin early this fall. This will provide us the greatest value

and allow us to make a large step forward in our downtown renovation efforts with the least time impact on the area.

In early spring we will also continue with our "Pavers to Prosperity" project to enhance the sidewalks downtown with the landlord's participation. Our ultimate goal is to add attractive vintage street lights and planters to add more curb appeal for shoppers. We are accepting donations to help assist with lighting and planters. Our shopping district is vital to our Town's value and attrac-

tiveness; therefore please continue to shop downtown as our merchants need your support.

Finally, as a town we were honored with the 2010 Hunterdon County Planning award for our Transportation improvements with our "Allies Way" project. We want to commend the North Hunterdon Rotary, the numerous volunteers, the DPW road-screw and our administration staff (Ceil Covino and Bob Cutter) for playing such critical roles in making the project a success.

### PEDESTRIAN SAFETY

Clinton is a pedestrian friendly Town and it's extremely important that both pedestrians and motorists are aware of their separate but equal responsibilities at crosswalks. Pedestrians must STOP at the curb, look both ways and proceed only when safe to do so. Motorists must STOP for a pedestrian who has entered the crosswalk, and may proceed only when the pedestrian is clear of it. After dark, pedestrians should wear light or reflective clothing and motorists should pay extra attention at intersections and crosswalks for the unexpected. If either a pedestrian or motorist's neglect their responsibilities the results can be tragic and expensive for both. Every year hundreds of pedestrians are injured and many are killed nationwide, that's why the police department takes their safety very seriously and actively enforces laws related to their safety.

### HOUSE NUMBERS

Emergency responders frequently STILL have difficulty responding to emergency calls at some locations throughout Town because they are not properly marked with a street address that can readily be identified from the street or sidewalk. When an emergency happens seconds are critical to responding police, fire or rescue personnel. Please take the time to check

your property to make sure that your house, apartment or building number is clearly marked and visible from the street so that those critical seconds can be spent on your emergency and not trying to find it!

### OVERNIGHT PARKING RESTRICTIONS

Winter overnight parking restrictions for this season will end March 31<sup>st</sup>, but until then please do not park on any street in Town between 0200am and 0600am when snow is forecast during those hours or streets are already snow covered. Your car will receive a summons and may be towed at your expense.

### CELL PHONES/TEXTING WHILE DRIVING CAN BE EXPENSIVE

If you think your cell/texting bill was expensive last month, wait until you have to pay a \$100.00 ticket for getting caught using it while driving! Our Town is too busy and too small for motorists to be paying attention to anything else but driving. [WWW.NJSAFEROADS.COM](http://WWW.NJSAFEROADS.COM).

### SKATEBOARDS, SKATES, ROLLERBLADES and SCOOTERS

The Town receives hundreds of complaints and inquiries every year regarding laws governing skateboards, skates, scooters and other locomotion devices that are gas or electrically powered. Skateboards, skates and non-motorized scooters are considered "human powered" locomotion devices. They are prohibited from being operated on any street, highway or other area of Town designed for motor vehicles by ordinance. Additionally they are prohibited from being operated on the sidewalks of Main Street, Lower Center Street, East Main Street and the section of

Leigh Street from Route 173 to Center Street. Although they are sold in stores and on the internet, gas or electrically powered skateboards, scooters or any other "motorized" locomotion device are considered motor vehicles under current law and the operation of such powered devices is prohibited on any public street or sidewalk in New Jersey. Operation of these motorized devices on public streets can subject the operator to being charged under State motor vehicle law with operating an unregistered and uninsured vehicle in addition to any other traffic violation they may be committing, REGARDLESS OF AGE. If you have ANY questions regarding ANY motor vehicle law or Town ordinance regulating any of these devices PLEASE ASK an officer FIRST. Also, please remember that if you are under 18 years of age you MUST wear an approved helmet, even on a bicycle.

### FINGERPRINTING

Fingerprinting is required for a variety of public and private purposes. If you live in Clinton or your employer is in Town you may schedule an appointment to be fingerprinted by calling 908-735-2665 ext. 219 and leaving a message for Detective Sgt Jay Hunter.

### BUSINESS LISTINGS

The police department maintains emergency contact information for all commercial businesses and properties in Town. To keep this information current we must rely on you the business owner or manager to keep your contact information updated with new or retiring staff or tenant information. The Town of Clinton Summer Recreation Program will meet at Clinton Public School. The program will run from June 27th – July 22nd from 9am-12noon, Monday – Friday. Registration will be open to all children who have completed kindergarten

through grade and are residents of the Town of Clinton or Glen Gardner beginning February 21st. Registration will be open to any out-of-district student who has completed kindergarten through grade 8 as of March 15th. Registration is open to the first 250 children who enroll.

Construction to replace the bleachers and grandstand at Gebhardt Field will begin early this spring and should be completed by the summer.

## Clinton First Aid & Rescue Squad by Chad Newsome



### 2010 – A Year in Review

2010 was a very good year for the Clinton First Aid & Rescue Squad (CFARS), as we were able to answer 2,082 emergency calls for assistance. Of those calls, 297 were in the Town of Clinton.

Statistically speaking, our 2010 average response time into the Town of Clinton was four minutes and thirty-one seconds. That was directly related to the efforts of our members, many of whom are Town residents. Our members donated 27,591 hours for their on-duty responsibilities for emergency calls. It is worth noting that this does not include the four to six hours of time that each member donated for meetings and training each month.

There have been many news articles concerning the lack of volunteers over the past several months. Part of CFARS' good fortune in 2010 has been the fact that we have been very fortunate over the past year to continue to draw new talent into the organization. In 2010 alone, CFARS took on forty-nine new volunteers!

In keeping with our tradition of fiscally responsible actions, CFARS chose to remount a ten year old ambulance that had over 115,000 miles on it. By taking the old ambulance body and remounting it onto a new chassis, the squad was able to update the old unit at half the cost of a new ambulance. This saved both CFARS and the community \$90,000.

We continue to staff our station 24 hours a day, 7 days a week, 365 days

a year. This is a critical step so as to minimize response times in getting an ambulance to you or your loved one. The biggest benefit inherent with in-station staffing, our response time for first call was four minutes and twelve seconds, a nineteen second improvement over our overall response times for the Town of Clinton.

We continue to look for Community members who would like to donate their time to this vital community service. If you are interested, please call 908-735-4012 or just stop by the station. We are located at 48 Old Highway 22 in the Town (across from the A&P).
