# Department of Fire Prevention by Jack Daniels





I have discovered that there are a lot of tents that are used in Town for all types of events. All persons or entities MUST obtain the proper permit for these types of TEMPORARY structures. YES a tent is considered a structure!! As I drive around town, all to frequently I come across a tent that has been erected without the proper permits. As a result, everyone has to race around to obtain the proper permit application, submit the proper documentation, pay the appropriate fee/s, and finally receive an inspection and approval. In the end, after various violations are fixed, everything usually turns out fine. However the stress that is incurred could be avoided if a little planning were done before the event.

Use the table below to determine when a permit is required and what type of permit should be obtained.

Also note that a layout of the seating arrangement and the flame certificate/s is necessary at the time of submission for a permit.

Additionally, a UFC fire permit is required for the use of any flameproducing device. The flame does not have to be "open" or "visible" to be considered a flame-producing device. Portable propane heaters are considered flame-producing devices and require a UFC fire permit. Therefore, in some instances, 2 UFC fire permits may be required. The Town of Clinton Fire Prevention Department requires these permits to be obtained **BEFORE** the tent is erected. The UFC fire permit applications can be downloaded from the Town's official website. The fee for each UFC fire permit is \$42.00 payable at the time of application. Please note that a UCC building permit will have different fees.

Don't forget to practice **HOLIDAY** 

FIRE SAFETY. This includes the servicing of your heating systems, checking your holiday decorations before placing them around your home or office, checking the operation of your smoke detectors, practicing caution when using candles, verifying the nearby fire hydrant remains clear during the snow season, and having your chimney checked and cleaned as some examples.

Business owners: Remember that if you wish to use real holiday trees, only balled tress are allowed per the fire code. NO CUT HOLIDAY TREES IN ANY BUSINESS. Space heaters also pose a fire hazard. Caution must be used regarding these devices.

The owner, occupant or tenant of

premises abutting or bordering on any street in the town shall remove all snow and ice from the abutting sidewalks of the street or the abutting right-of-way actually used by the public, or in the event of ice which may be so frozen as to make removal impractical, shall cause the same to be thoroughly covered with sand or ashes, within 12 hours of daylight after the snow falls or the ice forms thereon

The owner, occupant or tenant of premises used by the public or business invitees shall remove all snow and ice from the sidewalks, streets, right-of-ways and parking areas used by the public in the transaction of business thereat, and in the event of ice which may be so frozen as to make removal

impractical, shall cause the ice to be thoroughly covered with sand or ashes, within 12 hours of daylight after the snow falls or the ice forms thereon.

The owner, occupant or tenant of premises abutting on a street shall deposit snow or ice on any street, it being the intent and purpose to prohibit all persons from depositing snow and ice which accumulates within the private property belonging to that person on the sidewalks or streets of the Town.

# WINTER OVERNIGHT MON-STREET PARKING

To facilitate snow plowing and snow removal by our Public Works depart-

ment, Ordinance 135-24 prohibits overnight parking on ALL public streets in Town from November 15 to April 1 every year during certain times. The hours of prohibited parking on Main Street and East Main Street are from 11pm and 6am, and between 2am and 6am for ALL other streets in Town.

If you have overnight guests, other special parking needs or your vehicle is disabled please contact the police department IMMEDIATELY and PRIOR to the hours of restriction so that we may try to accommodate your needs.

## SNOW REMOVAL FROM SIDE-WALKS

So that our school children and other pedestrians can find safe passage on our sidewalks, Ordinance 115-1 requires that the owner or tenant of property abutting or adjacent to a sidewalk must remove all snow and ice from that sidewalk or public right-of-way within 12 hours of daylight from the time that the snow or frozen precipitation ceased to fall or accumulate.

These are some lessons from years past about snow/ice removal:

- 1. Its much easier to remove the snow/ice IMMEDIATELY after it ceases to fall than it is after it melts and then re-freezes.
- 2. Don't count on the snow or ice melting and disappearing by itself within 12 hours of daylight after it ceased to fall (see lesson #1 above).
- 3. It is illegal to deposit snow or ice from your sidewalk or driveway onto the street AFTER the street has been plowed. You WILL be reported by the Public Works Department and you WILL receive a summons if you are caught doing this.
- 4. There are many seniors in Town

who find it difficult if not impossible to shovel their sidewalks and driveways, so help a neighbor who may need it. This is also a great opportunity for teenage entrepreneurs to make some extra spending money. If you would like to be contacted to help someone in need of shoveling assistance please contact the Clerk's Officer at the municipal building.

#### CHRISTMAS PARADE

On Friday December 1st at 7pm Clinton will again host our famous Christmas Parade. Here are some things that you should know and PLAN AHEAD to make this night fun, memorable and safe for everyone

- 1. The Halstead Street Bridge will still be closed to vehicular traffic, however pedestrian access will remain across the bridge. Your guests will be able to park on Halstead Street, at the Community Center and the County Library which are excellent places to park and walk into Town. Shuttle buses will also run regularly from the Community Church on Route 513 near Wal-Mart into Town.
- 2. There will be no parking on Main Street, East Main Street, Center Street and Leigh Street north of Route 173 from 5pm parade day until its conclusion and all streets are reopened. Any vehicle parked on these streets after 5pm is subject to be towed at the owner's expense.
- 3. To avoid inevitable traffic congestion and delays please let your guests know that it is best to arrive in Town as early as possible. I strongly suggest unless it is absolutely necessary for them to drive into Town, that after 5:30pm they park as far from downtown as possible and take a leisurely stroll in.
- 4. Access to Center Street will be restricted and controlled by police from both ends beginning at 5pm. Every effort will be made to accommodate residents and your guests however after 5:30pm all access to

Center Street must be from the east (McDonald's end).

- 5. Individual vehicles will not be permitted to make parade participant drop off's on Center Street after 6pm. Parade participants should be dropped off on perimeter streets such as Halstead, Georges Place, Leigh Street or Route 173 and then walk to their starting position or floats on Center Street.
- 6. For safety reasons, based upon the volume of pedestrian traffic in the downtown area Main Street, East Main Street, Lower Center Street and Leigh Street are subject to closure at anytime after 5:30pm.
- 7. Every year some residents and visitors try to reserve "their" seats on public sidewalks along the parade route, sometimes as early as the night before. Please remember that our streets and sidewalks are public property. Tickets are not sold to the parade and there are no "reserved seats" unless it's on YOUR private property. Space on public sidewalks and right-of-ways is on a first come basis only.
- 8. Please remember that this is a family parade with literally thousands of children and young adults in attendance. NO ALCHOLIC BEVERAGES are permitted to be consumed on public sidewalks or streets at anytime and there will be zero tolerance enforcement of this ordinance on parade night.
- 9. Above all, have any questions and/or concerns you may have answered or addressed well in advance of parade night because during the event parade organizers, police officers, firemen, EMS Personnel and other municipal officials will be very busy trying to bring you another enjoyable and safe holiday experience in Clinton.



# Clinton First Aid & Rescue Squad by Chad Newsome



We all share the responsibility of knowing and practicing proper driving behaviors. One of the most important "rules of the road" deals with yielding the right of way to emergency vehicles. Each day, emergency vehicles respond to urgent requests from the public. The call may be for a person that has stopped breathing, a fire alarm or a car accident. It is the concern of all Emergency Service agencies that response time to call locations be minimized. Precious minutes that are lost while driving to an emergency could be the difference between life and death.

With the advent of new sound-proof cars, high-decibel stereo systems, cell phones and, unfortunately, drivers who simply don't care about anyone but themselves, the idea of getting to an emergency scene quickly, safely and efficiently is very difficult. Many times we are often faced with drivers who cannot see or hear us. This creates an incredibly frustrating situation for the emergency vehicle driver as they weave their way through traffic.

All drivers must know their responsibilities when approached by an emergency vehicle with its red lights flashing or siren sounding.

## What Drivers Should Do:

- Remain calm. Don't panic!
- Pull to the right and come to a stop.
- When on a high-speed road or when there is no room to stop, slow down as much as possible.
- When in the left lane, pull over into the right lane as the traffic in the lane to your right moves over.

- If you cannot move to the right because of an obstacle such as a car to your right, simply stop.
- Your prompt action will let the driver of the emergency vehicle know what you are doing; it will allow the driver to anticipate where to drive.
- When an emergency vehicle approaches you from behind while you are stationary at an intersection stop sign or red light, do not move unless you can pull to the right.

#### What Drivers Should NOT Do:

- Don't stop in the middle lane when there is room to pull to the right.
- Don't pull to the left in the center lane or left turn lane.
- Don't drive through a red light or stop sign when an emergency vehicle approaches from behind.
- Don't turn quickly to the left into a driveway or street.
- Don't race ahead to get through a green light or turn before the emergency vehicle gets there.
- Don't disregard the presence of the emergency vehicle by continuing to drive.

In heavy traffic, motorists in the right hand lane must pull as close to the curb as possible with motorists in the left hand lane pulling as close as possible to them. The law states that traffic in both directions must pull to the right and stop. When they do, there is room for the emergency vehicle to pass safely.

Motorists are obligated by law to check what is happening behind them before making a left turn. Left turns must always be aborted if an emergency vehicle is approaching from behind. The motorist should usually proceed straight through the intersection, then pull to the right and stop. The motorist must abort the left turn, by pulling to the right and stopping, being sure, of course, not to block the intersection.

When motorists see an emergency vehicle approaching, they pull to the right and stop before they get to the intersection. They do not turn or go until they are sure all emergency vehicles have passed. Traffic in both directions must yield to an emergency vehicle. This is critical at intersections. Motorists should pull to the right and stop before they get to the intersection--and must always yield to an oncoming emergency vehicle making a left turn.

The law requires you to pull to the right and yield to an emergency vehicle, even before it gets on the road. Be alert. When you see that a fire truck or ambulance is coming out of its station, pull to the right and stop.

Pedestrians are also required to get out of the way for an emergency vehicle. If, as a pedestrian, you are already on the road, get off the road as soon as possible. If you are about to cross and you see or hear an emergency vehicle approaching, don't go on the road--stay on the sidewalk until the emergency vehicle has passed.

Please consider all of the above the next time you see the Clinton First Aid & Rescue Squad – or any emergency vehicle – responding to a call. The call for help could be for one of your friends or family members. Your assistance is greatly appreciated!

- ~Councilman DeCleene reported that a large piece of the original Halstead Bridge was recovered at the construction project and measures will be taken to put it on display at the Red Mill.
- ~Councilman Ragozine reported on the status of 47 Leigh Street and the Community Center renovations.
- ~Mr. Cutter reported on a Chamber of Commerce Survey regarding shared services to local municipalities, i.e. The Town of Clinton Police Dept. will be using the radar unit from Flemington.
- ~Mayor Schaumburg commended the Public Works Dept. on their great job on the recent storm.
- ~Police Chief Matheis reported on the success of the Rubber Ducky Race and Sprintin' Clinton.

#### August 8, 2006

- ~Mayor Schaumburg read the Resolution of Appreciation for Janice Kovach, former Councilwoman, who recently resigned to take a job as Director of the Division of Women in Trenton.
- ~Tara Braddish, Executive Director of HART commended the Town of Clinton on their recent award for the 2005-2006 HART Municipal Travel Demand Management Grant. The Town of Clinton has been pro-active and submitted their application with a Pedestrian Streetscape Study and a Bicycle & Pedestrian Circulation Plan. 
