





Code Enforcement by Jack Daniels

Now that we are into the winter months, think Spring. The seasons may change, but code enforcement does not take time off nor do code violations. Different seasons, economic conditions, and social levels are all factors in the increasing number of code violations that I have discovered throughout our Town. You would be amazed at the varying levels of code issues that have recently been discovered. Now is a time to again reinforce the fact that code compliance at all levels is paramount to our Town: remaining at a level of safety that everyone can enjoy. The following matters are just some concerns that I have or have seen throughout my inspections.

SIGN ORDINANCE

There are specific "zones" within the Town that have different requirements. Each property within the specific zone is subject to the sign ordinance regulations for that zone as well as the regulations that affect <u>ALL</u> signs. I am dealing with several issues that I have received complaints about which could easily be resolved if the information about the violation is known.

One such matter is any illuminated sign operating after 11:00 PM. The sign ordinance prohibits this. The only exception is when a business is OPEN after 11:00 PM in which case the sign illumination needs to cease within ½ hour after closing. This requirement may require some electrical modifications such as installing timers. If this is the case, a construction permit would be needed from the Construction Department. Also remember to correct the timers due to the recent time change.

Another concern is Neon, LED and flashing type signs. Section 88-64.B.4 (b) & (c) prohibit these types of signs. The exception is the "OPEN" neon or LED sign in a C-3 or C-4 zone. C-3 is from the intersection of Lingert Ave & Route 173 east along Route 173 down to the Shell Gas Station. C-4 is from

the edge of Town by the STS building west <u>along</u> Route 173/Old Highway 22 to New Street by the Clinton Fire Department. If your structure is <u>not</u> in these areas, neon or LED type "OPEN" signs are prohibited.

HOUSING REGULATIONS

There are several portions of the Town Code that come into play regarding housing in the Town of Clinton. Housing inspections have become one of the most challenging yet most interesting inspections to say the least. Our homes are the places that we typically consider to be a safe haven and the place where one can feel comfortable and secure. Yet, time and time again I receive complaints from renters about the condition of the unit they reside in. Most of the complaints are justified. I am commissioned to act on these complaints to determine if there are violations or not. Because of the potential consequence on an occupant, I take housing inspections and complaints very seriously. Any housing code violation found must be dealt with in the appropriate manner. Also be aware that typically a housing type violation will also involve other agencies that must be contacted. The Town Code is designed to protect occupants of housing units from unsafe, unsanitary and unhealthy conditions. The Town is not in the business of landlord/tenant disputes. I will address any **legitimate** housing complaint that can be substantiated by the complainant. This might include investigations and research. If a violation is found during such action, notices will need to be issued and abatement is expected within the allotted time frame. Already, I have discovered various occupancies in the Town that are illegal and unsafe.

ZONING REGULATIONS

Another regulation that I enforce is the zoning regulations. I do not grant any approvals but simply enforce what the regulations state. This regulation is section 88 of the Town

Code and is supported by the State Land Use Laws. There are various sections and items within this section of the Town Code that are dealt with by various agencies within the Town. For example, a developer may apply to the Planning Board for a purposed development of some sort. The Planning Board will review the application for compliance to the Town Land Use Code. Any requested variance to that code is dealt with and a resolution may be granted. This resolution is in writing and must be adhered to by the developer and more importantly by any future property owner. Any stipulations put into the resolution must be adhered to for the life of the development unless otherwise stated within the resolution. For example, if a developer agreed to put certain trees or shrubs along a public walkway, any property owner is subject to compliance with this agreement.

There are some properties in the Town where the approved resolution is not in compliance. These owners will be notified in writing and given an opportunity to correct the violation. Please be aware that I am not permitted to deviate from the approved resolution. If a deviation is to be requested, it must be brought back to the original approving agency for review and appropriate action.

In closing, I write this article in an effort to educate the public regarding the process and procedure regarding code compliance. It is not my intention to create violations or penalize folks, but to promote code compliance through education and knowledge. The regulations permit me to issue violations, penalties or summonses. However, this is done only as a result of someone failing to abate a violation in a timely fashion after being asked to do so.



Police Department by Chief R. Brett Matheis



To facilitate snow plowing and snow removal by our Public Works department,

Ordinance 135-24 prohibits overnight parking on ALL public streets in Town from November 15 to April 1 every year. The hours of prohibited parking on Main St. and East Main St. are from 11pm and 6am, and between 2am and 6am for ALL other streets in Town.

If you have overnight guests, other special parking needs or your vehicle is disabled please contact the police department IMMEDIATELY and PRIOR to the hours of restriction so that we may try to accommodate your needs.

WINTER OVERNIGHT OFF-STREET PUBLIC PARKING

Overnight **OFF-STREET** parking is permitted in the Water Street Lot, the Lower Center Street Lot, Municipal Building Lot and in authorized spaces in the Firehouse Parking Lot. Please remember however that the Water Street, Municipal Building and Firehouse Parking Lots are 24 hour lots and your vehicle must be moved after each 24 hour period to facilitate snow removal. If you have any questions please ask a police officer regarding parking in these lots.

SNOW REMOVAL FROM SIDE-WALKS

So that our school children and other pedestrians can find safe passage on our sidewalks, Ordinance 115-1 requires that the owner or tenant of property abutting or adjacent to a sidewalk must remove all snow and ice from that sidewalk or public right-of-way within 12 hours of daylight from the time that the snow or frozen precipitation ceased to fall or accumulate.

Here are some tips about snow/ice removal:

1. It's much easier to remove the snow/ice IMMEDIATELY after it ceases to fall than it is after it melts and then re-freezes.

- 2. Don't count on the snow or ice melting and disappearing by itself within 12 hours of daylight after it ceased to fall (see lesson #1 above).
- 3. It is illegal to deposit snow or ice from your sidewalk or driveway onto the street AFTER the street has been plowed. You WILL be reported by the Public Works Department and you WILL receive a summons if you are caught doing this.
- 4. There are many seniors in Town who find it difficult if not impossible to shovel their sidewalks and driveways, so help a neighbor who may need it. This is also a great opportunity for teenage entrepreneurs to make some extra spending money. If you would like to be contacted to help someone in need of shoveling assistance please contact the Clerk's Officer at the municipal building.

CHRISTMAS PARADE

On Friday December 5th at 7pm; Clinton will again host our famous Christmas Parade. Here are some things that you should know and PLAN AHEAD to make this night fun and safe for everyone.

- 1. The Halstead Street Bridge will be closed to vehicular traffic, however pedestrian access will remain across the bridge. Your guests will be able to park on Halstead Street, at the Community Center and the County Library which are excellent places to park and walk into Town. Shuttle buses will also run regularly from the Community Church on Route 513 near Wal-Mart into Town.
- 2. There will be no parking on Main St., East Main St., Center St. and Leigh St. north of Route 173 from 5pm parade day until its conclusion and all streets are reopened. Any vehicle parked on these streets after 5pm is subject to be towed at the owner's expense.
- 3. To avoid inevitable traffic congestion and delays please let your guests know that it is best to arrive in Town as early as possible. I strongly suggest unless it is absolutely necessary for them to drive into Town, that af-

- ter 5:30pm they park as far from downtown as possible and take a leisurely stroll in.
- 4. Access to Center Street will be restricted and controlled by police from both ends beginning at 5pm. Every effort will be made to accommodate residents and your guests. After 5:30pm all access to Center St. must be from the east (McDonald's end).
- 5. Individual vehicles will not be permitted to make parade participant drop off's on Center St. after 6pm. Parade participants should be dropped off on perimeter streets such as Halstead Street, Georges Place, Leigh St. or Route 173 and then walk to their starting position or floats on Center Street.
- 6. For safety reasons, based upon the volume of pedestrian traffic in the downtown area Main St., East Main St., Lower Center St. and Leigh St. are subject to closure at anytime after 5:30pm.
- 7. Every year some residents and visitors try to reserve "their" seats on public sidewalks along the parade route, sometimes as early as the night before. Please remember that our streets and sidewalks are public property. Tickets are not sold to the parade and there are no "reserved seats" unless it's on YOUR private property. Space on public sidewalks and right-of-ways is on a first come basis only.
- 8. Please remember that this is a family parade with literally thousands of children and young adults in attendance. NO ALCHOLIC BEVER-AGES are permitted to be consumed on public sidewalks or streets at anytime and there will be zero tolerance enforcement of this ordinance on parade night.
- 9. Above all, have any questions and/ or concerns you may have answered or addressed well in advance of parade night because during the event parade organizers, police officers, firemen, EMS personnel and other municipal officials will be very busy trying to bring you another enjoyable and safe holiday experience in Clinton.

Historic Commission by Rosemarie Platt

The historic Red Mill is known across the country as a photogenic symbol of early America's rural industry. The familiar red building can be found everywhere, including official New Jersey tourism posters, roadmaps and postcards. It is the most photographed spot in New Jersey and one of the top ten most photographed buildings in the U.S.

The ca. 1810 Red Mill was originally built as a woolen mill. Over the next 100 years, the Mill was used at different times to process grains, plas-

ter, talc and graphite. The Mill was also used to produce peach baskets, as well as to generate electricity and pump water for the Town.

Each fall season the Red Mill Museum turns into the Haunted Mill. The 2008 theme was Beyond the Shadows. Complete with a Haunted Hayride and Terror Trail, patrons were delightfully terrorized by the actors dressed in professional costumes and stage makeup. Some of 2008 frightful sights included the Voodoo doctor, clowns, blood seeking zombies, and terrifying

chain saws. Approximately 4,000 patrons attended this year's event along with dozens of volunteers to help support this astonishing fundraising event for Red Mill Museum.

It is gratifying to know that we can be involved in the preservation of this breathtaking landmark. Without preservation we would not have direction for our future.

Council Highlights by Susan Komorowski

August 4, 2008 Special Meeting

- ~ Mayor Schaumburg announced Douglas Paul was appointed to Planning Board to fill Michelle Harrison's vacancy.
- ~ P.M. Construction was awarded Phase II Clinton Knolls Water Main Replacement contract.

August 12, 2008

- ~ Chief Matheis attended I-78 Preconstruction Meeting July, 2008. The 13-month paving project to begin September 2008 using rubberized material, promising at least a 5-decibel noise reduction. All paving will take place at night.
- ~ Adoption of Ordinance to enforce parks and playground's hours of operation from 6am until 10pm.
- ~ Introduction of Ordinance to prohibit smoking by minors in public places in the Town of Clinton
- ~Introduction of Ordinance to prohibit smoking in all parks, playgrounds and park facilities.
- ~ Introduction of Ordinance providing the prohibition of graffiti and the responsibility by property owners for its removal.
- ~ Approved Special Event and Banner Application submitted by Clinton Guild to host 2nd Retro Music Fest on Sunday, October 5th as June event was very successful.
- ~ Fire Dept responded to 21 calls in July.
- ~ Motion made authorizing Mayor and Clerk to enter into agreement with State of NJ, and the issuance of a check for \$15,800 for a deed of easement between the State of NJ, Dept. of Corrections, and Town of Clinton granting an easement to build and maintain a water storage tank on the premises.

August 26, 2008

~ Public hearing on Capital Ordinance authorizing sewer utility improvements and appropriating the sum of \$125,000.

- ~ Public hearing of Bond Ordinance for Clinton Knolls appropriating \$580,000 and authorizing the issuance of \$430,000 bonds or notes to finance the cost thereof.
- ~ Adopted Ordinance amending the land use code of the Town—Carbonate Rock.
- ~ Notification was received from DOT that Route 78 paving to begin September 2nd.
- ~ Bob Cutter reported an amazing savings for solid waste. Averages up substantially from last year.
- ~ Councilwoman Valenta presented a Proclamation to the Rescue Squad for their 40th Anniversary!
- \sim Councilman Shea announced the Clinton Town Picnic is scheduled for September $6^{\mathrm{th.}}$

September 9, 2008

- ~ Mayor Schaumburg announced the improved Town recycling program earned a Recycling Tonnage Grant check for \$1225.58 thanks to Bob Cutter.
- ~ Adopted Ordinances to establish hours of operation for Town parks and playgrounds, to prohibit smoking by minors in any public place in Clinton Town, and the prohibition of smoking in all parks and park facilities in the Town of Clinton—adults at ballgames and Town functions can smoke in designated areas; and the prohibition of graffiti and its removal by property owners.
- ~ Councilman Pender announced the Emergency Services Foundation is hosting Casino Night October 10th.

September 23, 2008

- ~ Ben Sniecinski was appointed to the Board of Adjustment.
- ~ A resolution was made to award the Clinton Knolls Phase II paving contract to Z Brothers Concrete.
- ~ Accepted, with regrets, resignations of Tom and Sue Whiteley from their positions of Deputy Emergency Mgmt and Shade tree Commission respectively.
- ~ A motion was made to hire Jerry

Vogel for the Public Works position.

October 14, 2008

- ~ Mayor Schaumburg introduced Clinton Fire Department Chief, Scott Wintermute who replaces Tom Whiteley as Deputy Emergency Management Coordinator.
- ~ Adopted Resolution supporting County Referendum on the November 4th, 2008 ballot to renew the Hunterdon County Open Space Recreation, Farmland and Historic Preservation Trust Fund.
- ~ Approved application for Clinton Guild 22nd Annual Christmas Parade to be held Friday, December 5, 2008.
- ~ Mayor Schaumburg read a letter of thanks from Supt. John Alfieri to the Public Works for their assistance with repairs to the school's sewer lines.
- ~ Recycling up 35 tons over last year.
- ~ Casino Night October 10th was huge success for the Emergency Services Foundation.
- ~ Councilman Ragozine reported the Gebhardt Field scoreboard has been installed and close to completion.
- ~ Councilwoman Valenta reported the Clinton Rescue Squad seeking donations of clean or new stuffed animals to aid in comforting children during their rescue services—donations can be left at the Squad building. Also the Clinton Rescue Squad offers classes for both human and pet CPR—contact the Squad for more info.
- ~ Councilwoman Insel stated the Smart Growth Committee is awaiting response to their grant applications.
- ~ Councilman Shea reported the Completion of Knolls project should be close to October 31st as planned.
- ~ Clinton Guild's "British Invasion Music Fest" on October 5th very successful and well-organized.
- ~ The Mayor, Chief Matheis and Administrator Cutter met with D.O.T. officials to discuss lingering Exit 15 concerns, particularly for drivers going eastbound from the Knolls area and making a left through that intersection. The D.O.T. is working with their engineers to address the left turn and light timing problems.
