How Do You Sleep At Night?

How do you sleep at night? This is a question that you may not think about too often if at all. I would strongly recommend that you sleep with your bedroom door closed AND assure that your smoke and carbon monoxide detectors are functional. The following link provides valuable (and unknown to the lay person) information about how a closed door might be the only thing that saves your life in a fire. The test study demonstration will clearly

show how quickly the smoke and hot gases move throughout the home. Please note that the Clinton Fire Prevention Bureau has <u>FREE</u> battery operated smoke detectors that can be provid-

Hello friends.

Following is information you might find helpful regarding your eligibility for State assistance with your prescription drugs.

State-funded prescription programs for eligible NJ residents

PAAD and Senior Gold are two state-funded prescription programs which help eligible New Jersey residents with the cost of prescription medications. Both of these programs cover only drugs approved by the Food & Drug Administration. Drugs purchased outside New Jersey are not covered – nor are any pharmaceutical products whose manufacturer has not signed a rebate agreement with the State of New Jersey.

PAAD eligibility: NJ resident; income less than \$26,575/single; less than \$32,582/married; you are 65 years of age or older, or 18 years of age and receiving Social Security Disability benefits; enrolled in Medicare Part D (if eligible). PAAD copay is \$5 for each covered generic drug and \$7 for each covered brand name drug. If you are eligible for PAAD, you may also be eligible to receive other benefits.

Senior Gold eligibility: do not qualify for PAAD; NJ resident; income less than \$36,575/single; less than \$42,585 married; 65 years of age or older, or 18 years of age and receiving Social Security Disability benefits; enrolled in Medicare Part D (if eligible).

As winter is approaching, we want to remind all residents to remove all vehicles from the public roadways during a snow event. This will allow Public Works employees to safely and effectively plow all of the snow from the roads. For those residents with portable basketball net placed along the street. I would like to ask all residents to consider relocating the nets during a snow event as they can pose a hazard to municipal vehicles. Due to the physical size of the equipment needed to perform these services, it can be difficult to operate the vehicles while trying to maneuver around the basketball nets. The relocation of the nets will allow municipal employees to safely remove the streets of snow while ensuring that vehicles/ equipment, as well as your basketball net, do not get damaged. We thank you in advance for your assistance.

Residents are invited to take advantage of free scrap metal and electronic recycling offered by the Town.

Recycling dumpsters are located at the Town's Waste Water Treatment Plant (2 Ramsey Road), and are open Monday through Friday from 7AM – 3PM and Saturday & Sunday

The garbage collection services that are provided by the Town are for residential customers only, not commercial entities. Commercial entities are required to arrange for private collection.

NOTE: The trash cans located throughout the Town are for trash generated by pedestrians enjoying the Town, not for commercial or residential use.

WINTER ON-STREET OVERNIGHT PARKING

From November 15th to April 1st parking is prohibited on all streets in the Town be-

tween the hours of 2am and 6am parking when "snow has fallen and the accumulation is such that it covers the public road, street or highway". Vehicles parked in violation of this ordinance are subject to be towed and ticketed to facilitate snow removal operations. If you are in doubt about the weather forecast, we suggest that you play it safe and move your vehicles off-street. If you have special parking needs or your vehicle is disabled during this period please contact the police department immediately so that we are aware and can try to accommodate your needs BEFORE you get a summons or get towed.

WINTER OFF-STREET PUBLIC PARKING WHEN SNOW IS FORE-CAST

Overnight off-street public parking is available in the Water Street Lot, the Lower Center Street Lot, the Municipal Building Lot and in authorized spaces in the Firehouse Parking Lot. Please remember however that the Water Street, Municipal Building and Firehouse Parking Lots are 24 hour lots and your vehicle must be moved after each 24 hour period to facilitate snow removal. If you have any questions please ask a police officer prior to making any assumptions regarding parking in these lots.

SNOW REMOVAL FROM SIDE-WALKS

So that school children and adult pedestrians can find safe passage on our sidewalks, Ordinance 115-1 requires that the owner or tenant of property abutting or adjacent to a sidewalk must remove all snow and ice from that sidewalk or public right-of-way within 12 hours of daylight from the time that the snow or frozen precipitation ceased to fall or accumulate.

Lessons learned from years past about snow/ice removal in Clinton include:

- 1. Its much <u>EASIER</u> to remove the snow/ice <u>IMMEDIATELY</u> after it ceases to fall than it is after it <u>melts</u> and re-freezes.
- 2. Don't count on the snow or ice melting and disappearing by itself within 12 hours of daylight after it ceased to fall (see lesson #1 above).
- 3. It is illegal to deposit snow or ice from your sidewalk or driveway onto the street after the street has been plowed. We highly recommend that you shovel the snow away from the street and not into it. You will be reported by the Public Works Department and you will receive a summons if you are caught doing this.
- 4. There are many seniors in Town who find it difficult if not impossible to shovel their sidewalks and driveways, so help a neighbor who may need it. This is also a great opportunity for teenage entrepreneurs to make some extra spending money. If you would like to be contacted to help someone in need of shoveling assistance please contact the Clerk's Office at the municipal building.

CHRISTMAS PARADE

On Friday December 4th at 7pm Clinton will once again host our famous Christmas Parade. Please PLAN AHEAD to make this night fun, memorable and safe for everyone.

- 1. The Halstead Street Bridge will still be closed to vehicular traffic, however pedestrian access will remain across the bridge. Your guests will be able to park on Halstead Street, at the Community Center and the County Library which are excellent places to park and walk into Town. Shuttle buses will also run regularly from the Community Church on Route 513 near Wal-Mart into Town.
- 2. There will be no parking on Main Street, East Main Street, Center Street and Leigh Street north of

Route 173 from 5pm parade day until its conclusion and all streets are reopened. Any vehicle parked on these streets after 5pm is subject to be towed at the owner's expense.

- 3. To avoid inevitable traffic congestion and delays please let your guests know that it is best to arrive in Town as early as possible. I strongly suggest unless it is absolutely necessary for them to drive into Town, that after 5:30pm they park as far from downtown as possible and take a leisurely stroll in.
- 4. Access to Center Street will be restricted and controlled by police from both ends beginning at 5pm. Every effort will be made to accommodate residents and your guests however after 5:30pm all access to Center Street must be from the east (McDonald's end).
- 5. Individual vehicles will not be permitted to make parade participant drop off's on Center Street after 6pm. Parade participants should be dropped off on perimeter streets such as Halstead, Georges Place, Leigh Street or Route 173 and then walk to their starting position or floats on Center Street.
- 6. For safety reasons, based upon the volume of pedestrian traffic in the downtown area Main Street, East Main Street, Lower Center Street and Leigh Street are subject to closure at anytime after 5:30pm.
- 7. Every year some residents and visitors try to reserve "their" seats on public sidewalks along the parade route, sometimes as early as the night before. Please remember that our streets and sidewalks are public property and space on public sidewalks and right-of-ways is on a first come basis only. <u>Tickets are not sold to the parade and there are no "reserved seats" unless it's on your own private property</u>.
- 8. Please remember that this is a family parade with literally thousands of children and young adults in attendance. **Consumption of**

Shade Tree Commission by Ches Snider



As we head into winter months, keep in mind that it is a great time to prune. Since the tree is not active, the removal of limbs will be

less stressful to the plant. It is also easier to see the structure of the tree without its leaves to better find problem areas like rubbing branches, weak crotches, cracked or broken limbs and competing leader branches. The tree will have more time to seal the wounds before the growing season starts and there will be less sap running from the wounds.

Also, insect and disease organisms are not active at this time, so it reduces the risk of infection or pest infestation, which is why birches and American elms should only be pruned in the winter. The worst time to prune trees

is late spring and early summer when their leaves are expanding and the tree is putting its energy toward growth.

For some helpful tips:

- Try to avoid removing large limbs over 6 inches in diameter because it will be difficult for the tree to close the wound before decay sets in.
- Young trees up to 8 to 12 inches in diameter need to be pruned properly for structure while they are still young to avoid the need to remove large limbs in the future
- "Topping" trees destroys them they will never grow back to their natural shape and every branch

that grows out of that wound area will be an accident waiting to happen. If a tree is too large for its location, consider having it removed and replanted with a smaller species rather than topping it.

Regarding Town trees, or those commonly located between the street and sidewalk, residents are allowed to undertake light pruning and the removal of dead wood anytime. Please do not undertake a job that looks too big — inform the town and we'll have it professionally pruned.

CAT & DOG LICENSING

ATTENTION ALL RESIDENTS: All cats and dogs are required to be licensed in the Town of Clinton, even in-door pets. Animal licensing fees for 2016 are Dogs spayed/neutered \$10.20 non-spayed/non neutered \$13.20; for Cats spayed/neutered \$7.00 non-spayed/non neutered \$10.00. We are still below the average costs for pets. Also, late fees will be \$4.00 per month. Every year we have many delinquent pets and send letters, make phone calls, and as a last resort, Police issue summons. A summons may cost \$80.00 plus the cost of licensing your pets. Hopefully this will encourage all pet owners to quickly respond to their renewals that are mailed in December and due by January 31st.

Environmental Commission by Jeff Schaumburg

Happy Holidays! While the Environmental Commission has been quiet with respect to active applications requiring formal review, The Town of Clinton Green Team has stayed busy through this Fall. As the year winds down, our focus has been planning for the upcoming year. We have several specific events and we also seek to support overall master planning that sustainably promotes the high quality of life we enjoy here in Clinton!

The mission of the Green Team is to promote and enact sustainable environmental practices and projects in our town. We seek to get a network of potential volunteers interested in serving in any capacity, from full time support to one time events that peak your interest. Interested parties can contact the Green Team at Clinton Green Team@outlook.com.

Since our Summer newsletter, the Monarch butterfly garden project has progressed from concept through re-

search and design, and we've learned a few things along the way. Monarch butterflies migratory and reproduction cycles have been threatened by loss of habitat along their migratory zone. The Green Team obtained Milkweed seeds to plant and initially contemplated two potential park sites that were ruled out for various reasons. Thanks to the assistance of a local garden expert, we identified an area of Pond Ridge where the garden will be best sited. Seeds are being cold stored for the winter and spring planting plans are underway. Stay tuned for dates if you wish to volunteer when planting day arrives.

The Green Team is also busy assessing the Sustainable New Jersey certification renewal process to evaluate continued participation in the program. The program recognizes municipalities for taking certain actions to promote sustainability in many forms in their community. In 2013 we applied on behalf of the Town and obtained Bronze Certification. The recognition

was primarily based on documenting many programs already implemented in the Town, such as hosting a farmers market and performing an energy audit and upgrades on the municipal buildings in 2010. The three-year certification expires next year and our team is assessing feasibility and efforts needed if renewal is pursued.

2016 promises to be a busy year for all. In addition to the Monarch butterfly garden planting, the Green Team will be supporting removal of invasive species including Water Chestnut and Autumn Olive at two sites in Clinton (efforts being coordinated by The Hunterdon Land Trust with local land managers' support) in the spring. Also keep an eye out for the annual river clean ups in April and July. Other plans to follow.

RESIDENT ADVISORY

NO PARKING WHEN ROADS ARE SNOW COVERED on any street in the Town of Clinton between the hours of 2 AM and 6 AM from November 15th to April 1st, except on Main Street and East Main Street where the hours are 11 PM to 6 AM.

Snow & Ice are to be removed from sidewalks, parking areas and rights of way used by the public, by the owner / occupant of premises within 12 hours of daylight after the snow falls or ice forms.



Aug 11, 2015

- ~ Carol Beder, representing the Clinton Guild, came to promote the Come Together Music every Friday evening on Main Street.
- ~ The Lease Agreement with the Fire Department was renewed with some changes. Changes are with the street sweeping arrangements, striping of the parking lot and the payment of the water and sewer bills.
- ~ Introduction of an Ordinance to Accept Easements for Block 29 Lots 3.03 and 3.04.
- ~ Council regretfully accepts the resignation of Angela Hawes, Adm. Assistant for the Clerk's Office due to her family relocating. She will be missed.
- ~Councilman Smith stated the Road Committee recommend withdrawing the ordinance from the books regarding doing work on private roads. There are five private roads in the Town.
- ~ A complimentary letter from Kim Rogan was sent to the Recreation program thanking Don Berkman for the tennis program.
- ~ A Smart Growth committee will host a public meeting September 21 to discuss the Town's Survey.

Aug 25, 2015

- ~ Marjorie Nathanson, Executive Director of the Hunterdon Art Museum came to update Council on the latest happenings in Town.
- ~ Councilwoman Sosidka stated Police Chief Matheis alerted the Council that the Freeholders are proposing to close the Hunterdon County Jail and is contracting with Somerset County. The vote will be taking place tomorrow night, Wednesday, August 29, 2015. The Council was not against the Freeholder's plan but wanted the proposal.
- ~ Councilman Pendergast reported the new fire truck is scheduled for

Friday, August 28, 2015.

~ Councilman Rylak announced a special meeting of the Smart Growth will be held at the Clinton Fire House, Monday, September 21, 2015 to discuss the result of the Town Survey.

Sept 8, 2015

- ~ Harvey Finkel, Clinton Book Shop, and organizer of the Clinton's Farmer's Market, presented an outline of the upcoming Apple `n Pumpkin Harvest Festival scheduled for October 11, 2015.
- ~ Mayor Kovach presented a proclamation to Don Berkman for his time and effort as organizer of the Clinton Tennis Program. Don has just completed his 16th year.
- ~ Mayor Kovach informed Council and the public that A & P has filed for bankruptcy and the local store will be closing the week of November 12-15, 2015. Mayor Kovach said there has been interest for a Trader Joe's to come into the space. Council discussed options for the site. Mayor Kovach has been in contact with A&P real estate office and is awaiting a return phone call.



We continue our purpose driven work and push ourselves to grow as educators. We have additional English Language Arts professional development scheduled and continued articulation with the North Hunterdon Voorhees Regional School District. The Clinton Glen Gardner Board of Education held a retreat in the Spring of 2015 with the purpose of developing goals to help guide and inform many of the important annual tasks we must complete. Our Clinton Public School goals for the 2015-2016 school year are:

Continue to implementing the math program and improving articulation with the high school. Review the language arts program with a focus on curriculum and professional development. Revise the facilities plan to reimagine and optimize the learning spaces in and around the building. Develop a plan to provide service learning opportunities to all CPS students

The fall has been a busy time at CPS with the activities inside our building mirroring the colorful transformations outside! Our language arts, social studies, and science teachers attended a workshop entitled Teacher's as Writer's on October 13th facilitated by the Rutgers University National Writing Project designed to help our teachers experience writing as a learner. As a follow up in November, the National Writing project facilitated *Elementary Writers' Workshop: The Nuts and Bolts of Writing.* So far, we are seeing the seeds of our writing initiative blossom as students increase their capacity for detail and sustained writing. Studies confirm significant gains in writing performance among students of teachers who have participated in NWP programs. In fact, NWP is the only federally funded program that focuses on the teaching of writing. We are looking forward to our next workshop in January, which will focus on mentor texts and mini-lessons.

Reading and writing with independence and confidence will remain master arts in the information age. Experts in education state that "The explosion of media and technology...has made it all the more important that students master the core skills of gathering and evaluating evidence." At CPS, we are taking this information to heart as we invest time in professional development for teachers and informational sessions for our parents such as the Wilson Reading and Dyslexia Workshop hosted this month.

Our after school Lego Club is well underway, last week students exercised their imagination by sharing their "Lego stories" after free building time. Student engagement in language arts can be challenging, but through Lego Stories students have an opportunity to kick start creativity and engage in speaking and listening skills in a low risk environment.

Our 100 Book Challenge is off to an excellent start, so please ask your K-4 student about how they plan to help meet our goal so that we can take advantage of all the wonderful end of year activities!

As the temperatures turn chilly, consider taking advantage of the extra indoor time to turn off the television and technology and engage in story telling or a read aloud with your child! We are looking forward to a productive winter as we continue to reap the benefits of the instructional seeds we have been planting and carefully cultivating in all our classes.
