Department of Fire Prevention by Jack Daniels





What is Fire Prevention?
Does anyone really have
a clear idea or definition
for it? I'll bet if you ask

10 people there are 10 different ideas and opinions. For the officials and firefighters that work with it everyday, fire prevention is very clear. Let's prevent the fire before it happens. This seems to sound easier than it is though. Most of us have seen what happens when a fire occurs in a building and how it can destroy and devastate a business and lives. So I think it appropriate to discuss the concept (because that is what it really is, a concept) of **Fire Prevention**.

First, there are many different things to consider. What are we trying to protect from a fire? Is it lives, property, money, someone's livelihood? The answer is yes to all of these. Fire Prevention RESULTS in all of the above. But first we all must realize that it is the thought before the fire that is what really matters. Put some real thought into how to prevent a fire. Then plan what to do in case a fire occurs. Not only in your home but wherever you are. Whether you are at work, at the store or at the park, think of what you would do if a fire occurred now. This is the single most important thing I can speak about. Unfortunately, all buildings will experience some sort of fire in the life of the building. So you need to plan for that situation. You will increase your odds of survival and of recovering from the effects of a fire by planning ahead. There is so much information on the Internet about this issue and other safety issues. You can search the web with key words like "Fire Prevention" or Fire Safety". Here are just a few sites that I know of. (Please Note: The Town of Clinton Fire Prevention Department is providing these links as a source of information and does not support any advertisements or products that may be found within these links.)

The bottom line is that we all need to remember to THINK fire safety in order to make a difference in the statistics that continue to show that more and more people are dying in preventable fires. Please help me to pass on the word and the concept on to everyone, especially your children!

Arson Awareness Week - May 1 through May 7, 2005.

National Fire Prevention Week - October 9 through October 15, 2005.

REMINDER: A Certificate of Smoke Detector/Carbon Monoxide Alarm Compliance is required for the change of tenancy or ownership in all homes and rentals. The State Division of Fire Safety has established the fees associated with this smoke detector/carbon monoxide certificate. This fee is based on the amount of time the application is made before the closing. Please make every effort to make the application to the Town of Clinton Department of Fire Prevention as soon as you

know that you are planning on selling or renting a residential type occupancy. This form and other forms may be downloaded from the T o w n 's w e b s i t e http://www.clintonnj.gov/.

Business Owners:

The purpose of the State of New Jersey Uniform Fire Code (UFC) is to verify and maintain a minimum level of fire safety. This requires an annual inspection of your business to verify fire safety compliance. If any fire safety violations are discovered, subsequent re-inspections are conducted to make sure the violation is corrected. Please remember that any violations of the UFC are required to be corrected within the time listed on the violation notice. If the time frame cannot be met, then a request for an extension of time is required to be filed and approved. This form and others may be downloaded from the Town's website http://www.clintonnj.gov/.

I continue to see the following fire code no no's during routine fire inspections:

- 1. The use of extension cords. Check your businesses to verify that any extension cords are the correct type (not the residential zip cord type), not plugged into other extension cords, are not over loaded, and are not used instead of permanent wiring.
- 2. Exit and emergency light fixtures not working properly. These units are required to function at all times. Please remember to replace blown bulbs in the exit signs and test the battery function of these devices at least monthly.
- 3. Missing reports for fire protection equipment/systems. If you have a fire protection device or system in your space or building, it is required to be tested at certain intervals. Please make sure that the testing firm uses the correct report form and that they are certified to conduct the

specific test. Recently, the State instituted a business permit for fire protection companies and their staff. So be sure to ask for the credentials to be certain the company is allowed to conduct testing in NJ.

Lastly, there have been some recent recalls on various consumer Please products.

If you have any of these items listed on the above website, I urge you to visit the appropriate product web site or call the company to have the recall corrected.

Bear country:

Believe it or not Clinton is located in black bear country. It is not unusual for bear to wander into town and under normal circum-

stances pose no threat to your safety or that of your pets. It is important to leave these animals alone. Do not approach them or feed them under any circumstances. Take steps to make your garbage and bird feeder bear proof. Our police department has officers who have been specially trained by the state division of fish and game to classify and handle wandering or nuisance bears. Should you see a black bear in town, stay

clear and advise the police department at 908-735-8611 so that we can monitor the animals activities. If you have any questions regarding black bears or any other wild animal that you may encounter in town, do not hesitate to contact the police department.



Volunteers Needed

The Clinton First Aid & Rescue Squad

(CFA&RS) provides Basic Life Support (BLS) and Rescue services (vehicle extrication, water rescue, and technical rescue) to the Town of Clinton, and portions of Clinton Twp., Lebanon Borough, Franklin Twp., and Union Twp. The squad covers approximately 48 square miles, and answers about 1400 calls per year. They utilize a combination

of paid (6am-6pm, M-F) and volunteer (remaining hours) Emergency Medical Technicians, with approximately 80 volunteer members at this time. The squad operates 4 ambulances, a rescue truck, a marine support vehicle, 3 boats, a command vehicle, a technical rescue services trailer and a first responder car.

A wide variety of people can be utilized for various volunteer roles. Whether it is as an emergency medical technician, rescue technician, or a non-riding member, we need YOU! The Clinton First Aid & Rescue

Council Highlights by Colleen O'Reilly

January 25, 2005

- ~ Notification was received from the NJ Department of Environmental Protection confirming the approval of the Municipal Stormwater Grant to the Town.
- ~ Mr. Cutter sent letters of commendation to the staff for the excellent job that they did in the last snow storm.
- ~ Clinton Town Rabies clinic was

held on January 15 and 272 pets were given shots.

- ~ The Newsletter Committee would like to thank Kathy Sullivan for joining the committee.
- ~ Councilman Christenson mentioned a letter that was received from a town resident addressing concerns about truck traffic increasing and the noise it creates. The Environmental Commission will

attempt to do a sound study and ask the NJ DOT to also do testing and consider noise abatement.

February 8, 2005

- ~A CERT (Certified Emergency Response Team) exercise was held on February 15 at the Patrick McGaheran School. Five municipalities, including Clinton, participated in the drill.
- ~ A mural project is being planned

for under the Route 78 overpass on Leigh Street. Local residents, Heide Funke and Karen Romagna are the project organizers and explained the public art project. It will consist of historic Clinton sites and local children will also participate in the project.

- ~ Summer recreation program will be held from June 27 to July 22.
- ~ Councilwoman Schaumburg announced that Craig Rogers has been appointed the new chairman of the Historical Commission.

February 22, 2005

- ~ Mayor Holt will be reading to the children at Clinton Public School on March 2 in honor of Read Across America, a NJ Education Association Project, which promotes reading for success.
- ~ Councilwoman Schaumburg reported that one of the Historic Commission's goals for this year is to determine the historic status of the Pony Truss Bridge. It is protected as a historic site in the State Register and the State Historic Preservation Office.

March 8, 2005

- ~ Mayor Holt made a correction to minutes from February 22 asking that the wording on the 2005 Budget introduction be amended to read, "The tax levy for the average home in Clinton will remain flat."
- ~ DARE graduation will be held at Clinton Public School on March 10.
- ~ Councilman DeCleene reported that the Olsen Lane project will be completed when the weather improves.
- ~ The Shade Tree Commission is holding their Annual Arbor Day Celebration on April 29th. A tree will be planted in front of the Grandin Library.
- ~ Councilwoman Janice Kovach is

running for the Assembly seat vacated by Connie Myers.

March 22, 2005

- ~ The NJ DOT responded to Mr. Cutter's follow up letter regarding the turn signals on Leigh Street.
- ~ A brief discussion was held about the status of the Town of Clinton' position to assist the property owners in the reinforcement of the Clinton Mills Dam/dike. The council members asked the property owners to put together a proposal by the dam/dike owners to present to the Town.

April 12, 2005

- ~ Councilwoman Schaumburg raised the issue of the noise problem with Engine Braking. Mr. Christenson reported that the Environmental Commission has been active in the area of highway noise and is drafting a letter to the State to see if Clinton is eligible for some type of remediation
- ~ The NJ Department of Environmental Protection has notified the Town that Clinton will receive the 2005 Clean Communities entitlement.
- ~ Clinton has been named Tree City U.S.A. for 22 consecutive years.
- ~ Mr. Cutter reported that in accordance with Stormwater Management resolutions the sweeping of roads will take place once a month.
- ~ The South Branch Water Shed Clean up to be held April 16.
- ~ The Highlands Commission will be making presentations to 7 counties over the next three months.
- ~ The Clinton Rescue Squad is holding a Spring Volunteer Program. An Open House & Building Dedication will be held on May 7.

April 26, 2005

- ~ The Annual Fishing Derby at DeMott Pond will be held on April 30.
- ~ The Clinton Sunrise Rotary will hold the Hunterdon Rubber Duckie Race on July 10 at the Clinton Main Street Bridge. Proceeds go to the American Cancer Society.
