Spring is in the air and like many of you who

are cleaning your property and planting your gardens, the Town is also well underway with several important projects that will beautify and maintain our community for years to come.

We recently received approval from NJDOT to combine our grant awards into one project that will pay for the road resurfacing of Lower Center Street, Main Street and East Main Street. While we are repairing these downtown roads, we will be replacing the existing water main and service lines with new pipe and connections. This will insure that our vital infrastructure for the downtown area remains serviceable for generations to come. Please pardon any interruptions while we complete these improvements.

The water main improvements on Leigh Street from the Municipal Building to Country Club Road will begin shortly after school ends in June. This project will involve the replacement of aging water lines and service connections along Leigh Street. There will be some road closures and general construction inconveniences involved so please be careful when traveling through this area during the summer.

Good news on the financial front in that we have passed the municipal budget for 2011 with no tax increase to our residents. Through prudent fiscal management, sharing services with our neighbors, and continuing to do more with less, we were able to craft a budget that maintained the level of services our residents currently enjoy. This year's spending plan is below the 2% mandated spending cap for municipalities. In these difficult economic times we are pleased that we are not increasing the burden on local taxpayers this year.

We continue to discuss shared services with our neighbors and Councilman Shea is representing the Town on the Freeholders task force to study consolidation and collaboration within Hunterdon County. The concept of shared services is nothing new to Clinton, as we have utilized the practice to our mutual benefit for years and will continue to do so. We will also be wary of collaboration that is not in our best interests and steer clear of those practices that may become a burden to our residents in the future. I am firm believer that shared services are a productive tool for small

municipalities to provide cost effective services to its residents. I oppose mandatory consolidation or forced sharing that may harm our financial position or change the character of our community.

Continuing our green activities we added free drop off for our residents to recycle consumer electronics and scrap metal. A dumpster for each is located on Ramsey Road next to the sewer treatment plant and can be accessed Monday through Friday during the day. In January the law changed which required that all consumer electronics such as computers, TV's, laptops, radios, etc. could no longer be left curbside for garbage and must now be recycled. It is now much easier and more convenient to properly dispose of these items by having a drop off within the-Town at no cost to our residents. The scrap metal will be recycled and all profits gained from the resale of these items will be shared with the Town. ## Code Enforcement by Jack Daniels

During my frequent travels around and through the Town, I have the opportunity to witness many things. I would like to call your attention to some of the matters that I have a responsibility for verifying compliance. This would include the posting of signs around Town, extremely tall grass and debris upon properties and tanks/dumpsters along our floodways.

**Signs:** The best advice I can give is to contact my office regarding this issue. Many signs are permitted within reason however, signs posted on anyone else's property are typically not permitted without proper approvals. This includes garage sale, moving sale, yard sale, etc. There is a process to permit these "offsite" signs to be posted but this involves permission from the property owner and a sign permit from the Zoning Officer. "Onsite" signs such as contractor signs are much easier to post however sometimes this too requires the sign permit from the Zoning Officer. Please avoid unnecessary notices being issued by simply obtaining the proper permit. You can view the specifics of the sign regulations by clicking the following link:

http://www.ecode360.com/?custId=CL0 749. Within this link, get to chapter 88, Article VII. Then open section 88-64 which is the specific subsection on signs. Should you need to determine a definition please look in section 88-4. Lastly, if you post a sign, please remove it upon the completion of your event.

Grass and Debris: There are always concerns and complaints when someone's grass gets to be too high. What is considered too high? Within the Town Code, there is a chapter that deals with this matter. It is chapter 45 and this chapter states that grass greater than 3" is a violation. Over the years I have had to send out violations regarding this matter many times. It is usually the "empty" lots and abandon properties that are frequent violators. In the recent economy many foreclosed properties have the grass left uncut from weeks. There are far too many such locations within our Town. The concern is that the tall grass lends to breeding ground and habitat for ticks and other less friendly critters. I request your assistance this year with this matter in hopes that everyone will help to maintain the beauty of Clinton and maintain your property accordingly. Maybe we all can lend a land to each other and help others less fortunate.

Tanks/Dumpsters: The rainy season is upon us again. Each year, we experience flood issues when the Beaver Brook and South Branch of the Raritan River swell. Remember that it is not

only during a rainstorm that there is an issue but afterwards when the river crests. The Town has a code that requires all fuel storage tanks and any dumpster of 6 yards or less to be registered and anchored in place. All fuel tanks should already be anchored in place according to certain building codes. The dumpsters will require having an anchoring system in place that in the event of a possible flood, the dumpster can be secured to prevent it from floating away and blocking the waterways. Registration for these tanks and dumpsters is free but a form and description of the anchoring must be completed. If you have received letters regarding this in the past you must follow through immediately. Please contact my office and speak with Allison Witt regarding this matter.

# Public Works / Bus. Administrator by James T. Naples



This summer will see increased activity as we begin work on several capital improvement projects that will improve our roads, sewers and water system. The Mayor and Council have been proactive in obtaining either grants or low interest loans to facilitate these much needed repairs at the lowest possible cost for the taxpayers.

The water main replacement project on Leigh Street will begin shortly after school closes this summer. The project will include the replacement of approximately 4,000 feet of water mains and new service connections for the area of Leigh St from the intersection of Rt. 173 to Country Club Dr. The will be intermittent road closures and detours during the construction and we ask for your patience as we make these much needed repairs.

The construction of a new 2.5 million

gallon water storage tank will begin next month. This project will add additional reserve capacity to the system and improve our ability to service the system and our customers. The tank will be located next to the original storage tank and construction will take approximately seven months to complete.

The downtown road reconstruction and resurfacing project will begin late this summer. This project, which will be funded through NJDOT municipal grants, will include the resurfacing of Lower Center, Main and East Main Streets, repair of curbs and sidewalks. In addition to the road work the Town will be replacing the water mains on these streets and repairing any deteriorated storm drains. This work will be coordinated so that the disruption to the downtown business is as minimal as possible.

Work on improving the sewer treat-

ment plant will begin this summer as we are replacing the filter system that has outlived its useful life. The replacement filters will require less maintenance and reduce energy usage in the facility.

The Town has recently added a free drop-off for residents to recycle electronic equipment and scrap metal. The drop-off for these items is located at the sewer treatment plant on Ramsey Rd. Residents are welcome to recycle any of these items free of charge during the week from 8:00am to 3:30pm.

Please see the Town website for more information on what items can be recycled. Recycling is an important method to reuse valuable materials and commodities and divert trash from ending up in a landfill. Please make sure to continue to recycle your household items every Friday and to utilize the free drop-off for electronic goods and scrap metal.

## Road Department by Dan Shea

As we move into the summer we look back at the preparation that occurred in the spring. We have combined State grants to consolidate our road project for Lower Center, Main Street, and East Main Streets. After checking the water pipes and storm drains we have determined a series of replacements are necessary. This will correspond with the overall project and is expected to take place in August/September.

The Pony Truss bridge was repaired by the County Highway Dept. in May. This is an investment in time and antiquity that we appreciate. Lastly five more landlords have agreed to continue with our pavers project. We hope more will come on board to join in this downtown renovation.

## Summer Fun and Safety Reminders

Town Noise Ordinance -

Chapter 101 of the Code of the Town of Clinton addresses "unreasonable and/or unnecessary noise" which travels across real property lines and it also specifically addresses that noise which is created by "sound reproduction devices". Sound reproduction devices include but are not limited to musical instruments, radios, T.V.'s, tape recorders, phonographs, loudspeakers, P.A. systems or any other sound-amplifying devices. Let me start by saying that there are many activities that by there very nature will immediately violate this ordinance, therefore the ordinance contains provisions for exceptions (public safety, emergency work, construction activities, activities on public grounds under authority of Town Officials) or provide that the Town Council may grant a permit for a specific activity to be an exception to the ordinance for a specific period of time (concerts, merchant events, etc.). The nuts and bolts of this ordinance is "unreasonable noise" which is not an exception contained in the ordinance or authorized by Town Council. Unreasonable noise is defined as "any excessive or unusually loud sound or sounds which annoy, disturbs, injures or endangers the comfort, repose, health, peace or safety of a reasonable person of normal sensitivities or which causes or has the potential to cause injury to animal life or damage to property or business". Unreasonable noise can be many things to many people however the Police Department considers the following standards when determining whether there is a violation of the ordinance: volume, intensity, is the nature of the noise usual or unusual, is the origin of the noise usual or unusual, the volume and nature of any background noise, proximity to residential sleeping areas, nature and zoning of the area, time of the day or night, duration of the noise, is the sound source temporary, is the noise continuous or impulsive and whether the noise

would disturb the peace and/or be considered a common-law nuisance. Now I know your wondering what does all that mean right? What it means is that what is "reasonable" at noon may not be reasonable at 4pm, and what is reasonable at 4pm may not be reasonable at 8pm, and what may have been reasonable at 8pm may not be reasonable at 10pm or later. The bottom line is that "unreasonable noise" traveling across property lines is a violation of the ordinance and the common sense rule of thumb that should be used is that as it gets later in the day the volume of any noise should continually be lowered until at some point the noise cannot be heard by your neighbors.

Fireworks - The Fireworks laws in New Jersey are VERY restrictive. In some States fireworks are permitted to be sold to the public however in New Jersey only paper or plastic caps for use in toy cap guns or legal. EVERY OTHER type of fireworks is ILLEGAL and will subject a person who possess or sells such a device to severe penalties upon conviction. Sparklers, novelty items such as cigarette loads, trick matches, trick noise makers, smoke grenades, toy propellants, snap & pops, poppetts and champagne poppers as well as firecrackers, Roman Candles, rockets, etc. are ALL ILLEGAL in this State. Please do not be fooled by a salesman who tries to tell you that they are authorized or permitted to be sold by mail order houses or over the internet and please do not purchase fireworks and transport them into New Jersey from Pennsylvania or others States. Aside from being illegal fireworks are EXTREMELY unpredictable and dangerous. Each year many people young and old find themselves in emergency rooms around the State with severe injuries caused by the illegal use of fireworks. Fireworks are also a serious fire hazard. Please leave fireworks to the experts at officially sanctioned public and licensed displays and be reminded that the police department

and our Fire Code Official have a ZERO TOLERANCE policy for violations of the State's Fireworks Laws.

Severe Weather / Flooding - Clinton is prone to flooding in several commercial and residential areas, and like all other places susceptible to high wind damage and storm related power outages. Although the Police, Fire, EMS and Office of Emergency Management Departments of the Town are available to respond and assist in emergencies, YOU the property owner/tenant are responsible to be aware of severe weather forecasts and to take those steps unique to YOUR properties to protect them in cases of severe weather and flooding. Please take the time NOW to create a plan for you, your family and your home or business to follow in the event of emergency. Resources are available to assist you at the following websites: www.state.nj.us/njoem, www.fema.gov and www.redcross.org. You are also encouraged to sign up for

Suspicious Activity – We have all seen something that "just did not seem right". Too often people do not report suspicious activity for fear that they will have to "get involved" or suffer some form of retaliation. Many times suspicious activities are reported the morning after and sometimes many days after the fact when there is little if anything that police can do about it. If you see or are aware of anything suspicious in nature do not hesitate to contact the non-emergency number for the Police Department at 908-735-8611 as soon as possible. You will be connected to a live communications dispatcher who will accept your information AN-NONYMOUSELY (if you desire) and relay that information to a police officer who will immediately investigate the incident.

Alcoholic Beverages – If you are hosting a summer picnic or party, please be reminded that the consumption of alcoholic beverages in public continued see page 5

# Clinton First Aid & Rescue Squad by Chad Newsome



The concept of Shared Services, a term garnering great attention on the national, statewide, county and local stages,

has in fact been in use by the Clinton First Aid & Rescue Squad (CFARS) for many years. It is important to note that what sharing services should really strive for is an overall improvement in the level of service desired by citizens of a particular jurisdiction while maintaining high cost efficiency. History has shown that sharing services works best when all parties agree on the mission and have a cooperative spirit entering the relationship.

In 2003, CFARS started the 27 Rescue Partnership in conjunction with the Califon First Aid Squad, High Bridge Emergency Squad and Hampton Emergency Squad. This joint venture was tasked with the goal of meeting and bolstering daytime response capabilities without straining the financial resources of any one department or corresponding municipality. The 27 Rescue ambulance is in service Monday through Friday and covers the Borough of High Bridge, the Borough of Glen Gardner, the Borough of Califon and parts of the

following areas; the Township of Clinton, the Township of Union, Bethlehem Township, the Township of Lebanon and Tewksbury Township. The 27 Rescue Partnership is, at its very core, a successful and multi-jurisdictional benefit for the agencies involved and, most importantly, for the citizens and visitors to the towns noted above.

In April of last year, CFARS partnered with The Borough of Lebanon to bolster the delivery of emergency medical service by stationing one of the CFARS ambulances at the Lebanon Fire Company station. This unit is located in Lebanon Monday through Friday during daytime hours. This move gives residents and visitors alike increased service coverage. Unlike the 27 Rescue Partnership, this service is provided by CFARS as part of its primary response capabilities.

CFARS is pleased to be part of the Hunterdon County Technical Rescue Task Force (HCTRTF). The HCTRTF is a partnership between the Clinton, Flemington-Raritan, and Whitehouse Rescue Squads, along with personnel from the Hunterdon County Office of Emer-

gency Management. The HCTRTF is trained and equipped, through the participating agencies, to handle unusual rescue situations, including high angle rope rescue, confined space rescue, trench cave-in rescue and structural collapse rescue incidents. This partnership is yet another example of how Shared Services is fully embraced and practiced by the Clinton First Aid & Rescue Squad.

The Clinton First Aid & Rescue Squad provides Basic Life Support (BLS) and Rescue services (vehicle extrication, water rescue, collapse, trench, rope and confined-space rescue) to the Town of Clinton, a majority of Clinton Twp., all of Lebanon Borough, and portions of the Township of Franklin and the Township of Union. With a coverage area of approximately 52 square miles and a call volume that exceeds 2,000 calls per year, the squad utilizes a combination of volunteer and supplemental paid personnel to insure in-house staffing. Unique to Hunterdon County, Clinton has an ambulance crew in quarters, seven days a week. The squad operates 5 ambulances, a rescue truck, a special services vehicle, 3 boats, a command vehicle and a technical rescue services trailer.

the Drunk Driving blood alcohol level threshold in New Jersey for those 21 and over is .08% blood alcohol content, however the limit for those under 21 is SIGNIFICANTLY LESS at .01% BAC. So for all practical purposes this is a ZERO TOLERANCE for the consumption of alcoholic beverages if you are under 21 and operating a

### February 22, 2011

- ~Public Hearing and adoption of Development Fee Ordinance where fees are collected from developers for maintenance and expenditures pursuant to COAH regulations and used for the sole purpose of providing low and moderate-income housing.
- ~Public Hearing and adoption of Municipal Maintenance Ordinance authorizing municipal maintenance of Georges Place Extension.

### March 8, 2011

- ~A Resolution was approved for the endorsement of the submission of a Municipal Recycling Tonnage Grant Application.
- ~Councilman Shea discussed plans for Main, East Main, Lower Center Street resurfacing project and sewer line televising.
- ~Kathy Olsen, CFO, reported three years of the budget have been posted on the website, in accordance with State requirements.

## March 22, 2011

~Discussion on proposal for Farmer's Market on summer Sundays in Town. The proposal has the support of the Mayor and Council, but discus-

- ~A letter of resignation was received from Don Goehe, stepping down from the Environmental Commission for which he proudly served for 30 years!

- ~An Eagle Scout project was presented by Matt Singer to propose a Rain Garden near DeMott Pond.
- $\sim 2011$  Municipal Budget was adopted.
- ~Resolution approved for the purchase/lease a police vehicle.

## **Buildings & Grounds Update by Rich Duffy**

The Buildings and Grounds Committee along with Art Dysart have been working hard on the ball fields in Town. The fields are being mowed and weeded and new clay has been added to the infield.

Renovations are scheduled to begin early this summer on the grand stands at Gebhardt Field. This should not affect the use of the field during construction. The Buildings and Grounds Committee is also in the process of doing energy upgrades on all the town buildings. Approximately 75% of all the upgrades will be paid by grant funds as a result of the Town participating in the energy audit.
