Onto Main Street with the merchants and businesses there also advertising the

The activities started around 11am and moved continuously throughout the day, May 30, from the Red Mill down to the Firehouse and back again - there was not a moment in time when you couldn't find something happening. If anyone would like to view the Congressional Statement by Congressman Lance it will be on display at the municipal building and the flag that was flown over the capitol building will soon be flying at the municipal building.

## Code Enforcement by Jack Daniels

During my frequent travels around and through the town, I have the opportunity to witness many things. I would like to call your attention to some of the matters that I have a responsibility for verifying compliance. This would include the posting of signs around town, extremely tall grass and debris upon properties and tanks/dumpsters along our floodways.

Free Smoke Detector Campaign: That's right, I said free. I have obtained battery operated smoke detectors as part of an ongoing campaign by the Division of Fire Safety and Kidde to reduce life loss due to fires. Residential home fires account for about 76% of all fatal fires. Having properly placed AND working smoke detectors can make the difference between life and death. I currently have 18 battery operated smoke detectors available for residents of Clinton that are in need of these devices. I will come to your home and determine

what is needed to provide the minimum level of protection (one detector per floor level including a basement). All you need to do is contact me either via email or phone; no questions asked. I typically can assist with the installation of these detectors as well. Please take the time to contact me at 908-468-1696 or <a href="mailto:jdaniels@clintonnj.gov">jdaniels@clintonnj.gov</a>. Doing so could just save your life. If you know of a neighbor in need, please speak with them and contact me for them.

Grass and Debris: There are always concerns and complaints when someone's grass gets to be too high. What is considered too high? Within the Town Code, there is a chapter that deals with this matter. It is chapter 45 and this chapter states that grass greater than 3" is a violation. Over the years I have had to send out violations regarding this matter many times. It is usually the "empty" lots and abandon properties that are frequent violators. In the recent

economy many foreclosed properties have the grass left uncut for weeks. There are far too many such locations within our Town. The concern is that the tall grass lends to breeding ground and habitat for ticks and other less friendly critters. I request your assistance this year with this matter in hopes that everyone will help to maintain the beauty of Clinton and maintain your property accordingly. Maybe we all can lend a hand to each other and help others less fortunate.

Upcoming Projects:

### <u>Halstead Street Water Main</u> Replacement

Beginning on/about June 22, 2015, the Town will be repaying Halstead Street from the Water Street parking lot to the Town line. As we move forward with the project, updates will be sent out notifying residents of any delays/detours so you can plan accordingly.

### Reminders:

- 1. For residents with shrubs/plants that overhang into the sidewalks, we ask that you please trim them accordingly. The last thing we want is for a pedestrian to be forced into the street due to an overgrown shrub.
- 2. Residents are invited to take advantage of free scrap metal and electronic recycling offered by the Town. Recycling dumpsters are located at the Town's Waste Water Treatment Plant (2 Ramsey Road), and are open

Monday through Friday from 7AM – 3PM and Saturday & Sunday 6AM—8AM.

3. The garbage collection services that are provided by the Town are for residential customers only, not commercial entities. Commercial entities are required to arrange for private collection.

NOTE: The trash cans located throughout the Town are for trash generated by pedestrians enjoying the Town, not for commercial or residential use.

Affordable Housing - If you know anyone who may be eligible to qualify for affordable housing, please visit the Clerk's Office to fill out an application. These units offer a valuable opportunity for income qualified participants to become homeowners in Clinton. We encourage anyone looking for affordable housing to get "pre-qualified" through the Town so when units become available, you are ahead in the process.

### ADDITIONAL CLARIFICATION FOR BRUSH AND LEAF COLLECTION

For the past two years we have changed our brush and leaf collection, and have realized there is still some confusion regarding the collections so we wanted to clarify some things for you. The brush collection runs from May to end of October with your appropriate zone pick up, after October you can take your brush pile to the Town's Composting Center located at 2 Ramsey Road (Wastewater Treatment Plant, Monday –Friday 7am-3pm, and Saturday – Sunday 6am -8 am). During collection all small brush/debris is to be placed in buckets or garbage cans, all large brush/debris (large limbs and branches no longer than 6 inches in diameter) will be placed at curbside facing the flow of traffic. Please do not place brush on top or underneath your leaf pile, for our leaf machine is not equipped to handle brush. BRUSH AND LEAVES ARE NOT TO BE PLACED IN THE BROWN GRASS CLIPPING BAGS. THOSE BAGS ARE ONLY FOR GRASS CLIPPINGS WHICH THE TRASH HAULER WILL PICK UP.

Our leaves will be collected from mid-October through December with multiple trips through all the neighborhoods. If your leaves are not out when the DPW goes by, they will be picked up next time. All piles must be 10 feet or further away from any storm drain inlet in order to prevent the basins from getting clogged. The leaf collection is subject to inclement weather and other municipal emergencies. A special springtime leaf collection will be the last week of March and first week in April, so please mark your calendar accordingly.

**Summer Fun and Safety** 

Town Noise Ordinance – Chapter 101 of the Code of the Town of Clinton ad-

dresses "unreasonable and/or unnecessary noise" which travels across real property lines and it also specifically addresses that noise which is created by "sound reproduction devices". Sound reproduction devices include but are not limited to musical instruments, radios, T.V.'s, tape recorders, phonographs, loudspeakers, P.A. systems or any other soundamplifying devices. Let me start by saying that there are many activities that by there very nature will immediately violate this ordinance, therefore the ordinance contains provisions for exceptions (public safety, emergency work, construction activities, activities on public grounds under authority of Town Officials) or provide that the Town Council may grant a permit for a specific activity to be an exception to the ordinance for a specific period of time (concerts, merchant events, etc.). The nuts and bolts of this ordinance is "unreasonable noise" which is not an exception contained in the ordinance or authorized by Town Council. Unreasonable noise is defined as "any excessive or unusually loud sound or sounds which annoy, disturbs, injures or endangers the comfort, repose, health, peace or safety of a reasonable person of normal sensitivities or which causes or has the potential to cause injury to animal life or damage to property or business". Unreasonable noise can be many things to many people however the Police Department considers the following standards when determining whether there is a violation of the ordinance: volume, intensity, is the nature of the noise usual or unusual, is the origin of the noise usual or unusual, the volume and nature of any background noise, proximity to residential sleeping areas, nature and zoning of the area, time of the day or night, duration of the noise, is the sound source temporary, is the noise continuous or impulsive and whether the noise would disturb the peace and/or be considered a common-law nuisance. Now I know your wondering what does all that mean right? What it means is that what is "reasonable" at noon may not be reasonable at 4pm, and what is reasonable at 4pm may not be reasonable at 8pm, and what may have been reasonable at 8pm may not be reasonable at 10pm or later. The bottom line is that "unnecessary or unreasonable noise" traveling across property lines is a violation of the ordinance and the common sense rule of thumb that should be used is that as it gets later in the day the volume of any noise should continually be lowered until at some point the noise cannot be heard by your neighbors.

Fireworks - The Fireworks laws in New Jersey are EXTREMELY restrictive, perhaps the most restrictive in the Country. In some States fireworks are permitted to be sold to the public however in New Jersey only paper or plastic caps for use in toy cap guns or legal. EVERY OTHER type of fireworks is ILLE-GAL and will subject a person who possess or sells such a device to severe penalties upon conviction. Sparklers, novelty items such as cigarette loads, trick matches, trick noise makers, smoke grenades, toy propellants, snap & pops, poppetts and champagne poppers as well as firecrackers, Roman Candles, rockets, etc. are ALL ILLEGAL in this State. Please do not be fooled by a salesman who tries to tell you that they are authorized or permitted to be sold by mail order houses or over the internet and please do not purchase fireworks and transport them into New Jersey from Pennsylvania or others States. Aside from being illegal fireworks are EX-TREMELY unpredictable and dangerous. Each year many people young and old find themselves in emergency rooms around the State with severe injuries caused by the illegal use of fireworks. Fireworks are also a serious fire hazard. Please leave fireworks to the experts at officially sanctioned public and licensed displays and be reminded that the police department and our Fire Code Official have a ZERO TOLERANCE policy for violations of the State's Fireworks Laws.

Severe Weather / Flooding - Clinton is prone to flooding in several commercial and residential areas, and susceptible to high wind damage and storm related power outages. The Police, Fire, EMS and Office of Emergency Management Departments of the Town are available to respond and assist you in emergencies, however YOU the property owner/tenant are responsible to be aware of severe weather forecasts and to take those steps unique to YOUR properties to protect them in cases of severe weather and flooding. Please take the time NOW to create a plan for you, your family and your home or business to follow in the event of emergency. Resources are available to assist you at the following websites: www.state.ni.us/nioem. www.fema.gov and www.redcross.org. You are also encouraged to sign up for local alerts on the Police Department website www.clintonnjpolice.com as well as the official Town of Clinton website, Facebook and Twitter.

Suspicious Activity - We have all seen something that "just did not seem right". Many times suspicious activities are reported the morning after and sometimes many days after the fact when there is little if anything that police or other Town departments can do about it. If you see or are aware of anything suspicious in nature do not hesitate to contact the non-emergency number for the Police Department at **908-735-8611** as soon as possible. You will be connected to a live communications dispatcher who will accept your information, and you may remain anonymous if you wish. The Police Department is "one stop shopping" for residents and visitors to Clinton so please do not hesitate to call on us 24/7/365.

Alcoholic Beverages – Hosting a summer picnic or a party?, please be reminded that the consumption of alcoholic beverages in public (public property, streets, sidewalks, parks & playgrounds) is prohibited by ordinance. Please maintain an awareness of WHO is consuming your alcoholic beverages and HOW MUCH they are consuming at YOUR event. As the host you may be held responsible for

the actions of those that you have served in some instances. Please also remember that the Drunk Driving blood alcohol level threshold in New Jersey for those 21 and over is .08% blood alcohol content, however the limit for those under 21 is SIGNIFI-CANTLY LESS at .01% BAC. So for all practical purposes this is a ZERO TOLERANCE for the consumption of alcoholic beverages

if you are under 21 and operating a motor vehicle regardless of where or from whom you were served.

## **Shade Tree Commission by Ches Snider**



Greetings fellow tree huggers – I want to thank everyone who participated in this year's Arbor Day celebration. It was extra special

as we were able to surprise longtime Town of Clinton employee Wayne Smith with a Korean Dogwood.

If you're not familiar with Wayne, he is the one we rely upon to ensure that visitors and citizens alike enjoy a beautiful, bucolic setting in Clinton year round.

Speaking of Dogwoods! Flowering dog-

woods range in color from white, to pink or red and generally bloom for about two to four weeks in early spring. They also add summer and fall color, with rich green foliage color in summer and reddish purple leaves during fall. This is oftentimes followed by brilliant red berries in winter. Proper dogwood care will bring these New Jersey friendly trees to their height of beauty.

Flowering dogwoods can be grown in sun or shade; however, trees planted in partial shade generally perform better. Those planted in full sun can be stressful, making them more susceptible to <u>dogwood borers</u> and heat stress. For care of flowering dogwood trees, dogwoods that are planted in full sun must also rely on frequent watering, especially during hot conditions.

## **Environmental Commission by Jeff Schaumburg**

Spring has sprung and summer is upon us. The Town of Clinton Environmental Commission has been busy this season. The Environmental Commission's primary role includes reviewing development applications and providing comments regarding Environmental aspects of the projects and/or general Town policies.

In addition to our plan review and advisory roles, we have formed the Town of Clinton Green Team to support sustainable activities and service in our community. The mission of the Green Team is to promote and enact sustainable environmental practices and projects in our town. We seek to get a network of potential volunteers interested in serving in any capacity, from full time support to one time events that peak your interest. Interested parties can contact the Green Team at Clinton Green Team@outlook.com.

On April 18, 2015, The Environ-

mental Commission and Green Team supported the Raritan Headwaters Association annual river clean up. We pulled substantial piles of general litter and debris from the river and its banks, helping to keep our downtown beautiful and protecting this important watershed resource. We have planned an additional "In-river clean up", using canoes and kayaks to reach areas in the water and steeper upstream banks for Sunday July 26, 2015 at **9AM**. In past years, we successfully removed mounds of debris including large tires and various other garbage from the river. If interested in volunteering, please contact us through the Green Team email above, and spread the word.

The Green Team is also seeking volunteers to help plant and maintain milkweed pods for a butterfly garden at DeMott's Pond. Monarch butterflies annually migrate from Canada to Mexico and Florida, but their population has been threatened by loss of habitat along their migratory zone. We

have obtained milkweed seeds and are preparing to plant them in the existing rain garden at DeMott's Pond (and conduct spring garden maintenance) to help keep Clinton's piece of their migration route intact.

The Green Team Natural Remedies Workshop, led by several of our volunteers, Veronique Lambert; Jean Pierson; Deena Roberts; and Patty Smeltzer, was held on February 28, 2015. The workshop provided demonstrations and recipes for environmentally sustainable homemade laundry detergent, face scrub, silver cleaner and more.

By the time you read this, the Green Team members also will have participated in the Town's 150th Anniversary Celebration. We intend to provide a litter patrol to help keep up with emptying garbage cans, providing recycling containers, and picking up litter that may be generated during the event. We hope to see you all there.

### February 24, 2015

- ~ Historic Commission will be working in conjunction with the Red Mill Museum Village to put on an exhibit for the 150 years of Clinton. A cabinet will be constructed to display items being donated in the 47 Leigh Street building.
- ~ Sewer Committee discussed budget requests, filter for the Wastewater Treatment Plant building, centrifugal blowers, heater, and a sludge press.

### March 10, 2015

- ~ Lynn Arnold and Andy West of the Sunrise Rotary presented checks to the Clinton Police Department and the Clinton First Aid & Rescue Squad for their help with the Rubber Ducky Race and Sprintin' Clinton 5K Race in 2014. Police Chief Brett Matheis and Rescue Squad Deputy Chief, Matt Stiff accepted donation checks of \$500 each.
- ~ The "Irishtown" sign will be dedicated in front of the first Mulligan house at 28/30/32 Halstead Street.
- ~ Councilman Shea presented Council with his letter of resignation. Effective St. Patrick's Day, Councilman Shea will step down after serving nine years on council.

### April 14, 2015

- ~ Mayor Kovach thanked the Friendly Sons of St. Patrick's for their generous donation of new American flags on Main Street.
- ~Jonathan D. Wall, PsyD, of Center Street, wrote Mayor and Council to commend Jean Marie Pierson of Clinton's Green Team for her presentation to the Hunterdon South Highlands Sierra Club Group on April 1, 2015. A wonderful presentation!
- ~ Mayor Kovach submitted Pete Bross for the 200 Valor & Merit Award. Chief Matheis mentioned that Sgt. Jay Hunter will also be receiving an award that evening. Congratulations gentlemen!

~ St. Baldricks fund raiser that the Fire Department participated in last year will be repeated this year on September 27, 2015. The fire department and the police department will take part in the event if anyone would like to sponsor them.

### April 28, 2015

- ~ Mayor Kovach announced a proclamation was written in support for National Day of Remembrance for Women given on April 24, 2015. This proclamation is to support July 14 as a National Day of Memory for Women and Girls killed in the name of honor.
- ~ Mayor Kovach announced a proclamation is to be given to Harvey Finkel on May 3, 2015 for his efforts on originating and organizing each year the Farmer's Market in the Town of Clinton. The Town of Clinton is proud to have the Farmer's Market return to open in its fifth season on Sunday, May 3, 2015. It has been a great success over these years.
- ~ Ms. Marjorie Nathanson, Executive Director, and Ann Villa, Development Director, for the Hunterdon Art Museum wanted to come to council to discuss the new offerings of the museum. The first expedition is a Contemporary Tapestry Expedition with 39 artists from 9 countries. In the summer there are 4 shows opening starting May 17. There are 300 classes and workshops for adults and children from two and a half and up as well as classes for people with disabilities. The Museum works with a program called Family Promise which deals with homeless families.
- Ms. Nathanson mentioned there are 2 sculptures on the terrace by two world famous artist. The first sculpture is called New Direction by Tom Otterness and a second sculpture, Tree by Toshiko Takaezu. Toshiko Takaezu resided in Hunterdon County for 25 years and lived in Clinton for part of that time. She

was associated with the Museum for part of the time as well. Ms. Nathanson said they are in the process of putting in a smart code where anyone with a smart phone can scan the bar code and listen to information about the sculptures.

Students have finished with PARCC testing for the year and the board wants to thank all the teachers and staff for a successful first administration.



## Clinton Sixth Graders are Making a Difference for Those With Autism

Autism is a pervasive developmental disorder characterized by severe deficits in social interaction and communication, by an extremely limited range of activities and interests, and often by the presence of repetitive, stereotyped behaviors. In New Jersey, 1 in 49 children are diagnosed with Autism. It is more common than cancer, AIDS, and diabetes put together.

April has been designated as Autism Awareness Month for nearly a quarter of a century. This year, the goal of Autism Awareness Month is to go beyond simply promoting autism awareness to encouraging friends and collaborators to become partners in movement toward acceptance and appreciation.

One of many examples of great initiatives at Clinton Public School is Ms. Lunger and her sixth grade language arts class. Talya Findikli, Emily Czerw, Isabelle Layding, and Damiano Palladino (*pictured* below) are determined to make a difference and touch the lives of those with autism. They started a fundraiser they call "Motions for Emotions" and are raising money for autistic charities.

Their inspiration began by reading an article from Storyworks magazine titled, "Kevin and Daisy." This article was about an autistic child who was coping with autism and used equine therapy to help. After reading this article, the students initiated additional research, put together presentations, and took action to begin their fundraiser. In April, this group of amazing students presented their initiatives to the Special Education Parent

Advisory Committee.

To raise money this group of dedicated students, started a fundraiser by designing and selling tee shirts and collected money during school lunches. Collectively, they decided all of the profits will be donated to a nonprofit, equine therapy organization, called Mane Streams in Oldwick. Mane Stream (<a href="manestreamnj.org">manestreamnj.org</a>) offers adaptive horsemanship for individuals with disabilities and equine assisted therapy. Donations are still being accepted. Donations can also be made directly at the Mane Streams web site.

At Clinton Public School, students and staff continue to send messages and demonstrate acts of acceptance and understanding of those with

autism. These actions make such a difference in the lives of those with learning differences.
