### Sometimes the Minimum Is Not Enough

Recently, the Town of Clinton lost one of its Historical Buildings; the Music Hall which dated back to 1890. Present day it housed several different businesses and the structure was considered a "business" use. Since this structure predates the Uniform Construction Code for the most part, the Uniform Fire Code had jurisdiction on the various types of fire protection components for this structure. With this business use some fire protection components are required while others are not. What was not required was an automatic or manual fire alarm system.

I call this out for several reasons;

- 1. To indicate there was no "requirement" to have these types of fire protection systems and,
- 2. To discuss that the codes only contain minimum requirements.

While the codes discuss what has been determined to be minimum requirements, there is nothing that prevents an owner or tenant of a specific space from going above and beyond what the code requires since the code is a minimum. That does not mean that you should just blindly leap forward without doing your research. That's where I can assist. Research regarding fire

protection will include many variables to determine the cost effectiveness of the desired installation or "upgrade". First, find out what type of fire protection component or system would best fit the protection desired. An automatic fire alarm system is always a good investment. If properly installed and maintained, it is designed to provide early warning of a possible situation that warrants a fire department response. There are some things that should be known about an automatic alarm system though. There will be a monthly fee associated with the monitoring of the system. Monitoring the alarm system is essential in order to have the quickest response time of the emergency responders. There is also the annual alarm inspection and report that is needed per the Uniform Fire Code. Note that this is only applicable to commercial type occupancies. On the flip side, check with your insurance company to determine what type of fire alarm would provide you with the most insurance premium reduction. Insurance companies wish to reduce the risk of a loss and will therefore give reductions in rates for certain "protection" systems.

By being knowledgeable and educated on this matter, you may find that the cost of installing the fire alarm will pay for itself in the long run through insurance premium rate reductions. You will also have "peace of mind" in that should some event occur, a quick response of the emergency responders is far better than one where someone must first determine there is a situation and then react to it. The automatic fire alarm is that "person" that is waiting there to react to certain types of events within the structure. Without the alarm system within your building, you are simply gambling with the odds. The odds are that every building will have a fire at some point during its existence. Do you want to continue to gamble with that chance?

Free Smoke Detectors: I still have battery operated smoke detectors that are part of an ongoing campaign by the Division of Fire Safety and Kidde to reduce life loss due to fires. The Clinton Fire Department has offered to assist with the installation of these devices in your home. All you need to do is contact either Chief Walter Dorf or myself via email or phone; no questions asked. For residents with shrubs/plants that overhang into the sidewalks, we ask that you please trim them accordingly. The last thing we want is for a pedestrian to be forced into the street due to an overgrown shrub.

Residents are invited to take advantage of free scrap metal recycling offered by the Town. Recycling dumpsters are located at the Town's Waste Water Treatment Plant (2 Ramsey Road), and are open Monday through Friday from 7AM – 3PM and Saturday & Sunday 6AM—8AM.

The garbage collection services that are provided by the Town are for residential customers only, not commercial entities. Commercial entities are required to arrange for private collection.

NOTE: The trash cans located throughout the Town are for trash generated by pedestrians enjoying the Town, not for commercial or residential use.


The initial theme will be to make the Town of Clinton a butterfly-viewing

plants wherever possible. In fact, all residents and businesses are encouraged to plant "chocolate cake" butterfly plants! "Chocolate Cake" is a designation given by Jane Ruffin of the NJ Audubon Society to top nectar producing flowers that are irresistible to butterflies. Google butterfly friendly plants, see http:// www.njaudubon.org/Portals/10/ Education/PDF/ Recommended Nectar Plants.pdf or choose a few butterfly friendly plants from this list: Aster, Ageratum, Anise Hyssop, Aster New York, Boneset, Butterfly Weed, Cardinal Flower, Chelone Turtlehead, Daylily Fire of Fuji Reblooming, Echinacea Coneflower, Grass Prairie Munchkin, Fennel, Goldenrod (seaside), Joe Pye Weed, Lantana, Lobelia, Mexican Sunflower, Milkweed Common, Milkweed Tropical, Mint, Mistflower, Monarda Bee Balm, Parsley, Phlox, Speedwell, Sage, Sedum, Zinnias.

Did you know that the NJ State Butterfly is the Black Swallowtail? It is found in all 21 counties – rural to urban – and lives its entire life cycle in New Jersey. You can plant common garden herbs like parsley, dill and fennel and it's very likely you'll attract adult black swallowtails to lay eggs. Town Noise Ordinance – Summertime brings with it a lot of outdoor activity throughout our Town and

with outdoor activity also comes noise. Chapter 101 of the Code of the Town of Clinton addresses "unreasonable and/or unnecessary noise" which travels across real property lines and it also specifically addresses that noise which is created by "sound reproduction devices". Sound reproduction devices include but are not limited to musical instruments, radios, T.V.'s, tape recorders, phonographs, loudspeakers, P.A. systems or any other sound-amplifying devices. Let me start by saying that there are many activities that by their very nature will immediately violate this ordinance, so this ordinance provides for exceptions (public safety, emergency work, construction activities, activities on public grounds under authority of or sanctioned by Town Officials) and provides that the Town Council may grant a permit for a specific activity to be an exception to the ordinance for a specific period of time (concerts, merchant events, etc.). The nuts and bolts of this ordinance is "unreasonable noise" which is not an exception contained in the ordinance or authorized by Town Council. Unreasonable noise is defined as "any excessive or unusually loud sound or sounds which annoy, disturbs, injures or endangers the comfort, repose, health, peace or safety of a reasonable person of normal sensitivities or which causes or has the potential to cause injury to animal life or damage to property or business". Unreasonable noise can mean many things to many people however the Police Department considers the following standards when determining whether there is a violation of the ordinance: volume, intensity, is the nature of the noise usual or unusual, is the origin of the noise usual or unusual, the volume and nature of any background noise, proximity to residential sleeping areas, nature and zoning of the area, time of the day or night, duration of the noise, is the sound source temporary, is the noise continuous or impulsive and whether the noise would disturb the peace and/or be considered a common-law nuisance. Now I know you're wondering what does all that mean right? What it means is that what is "reasonable" at noon may not be reasonable at 4pm, and what is reasonable at 4pm may not be reasonable at 8pm, and what may have been reasonable at 8pm may not be reasonable at 10pm or later. The bottom line is that "unnecessary or unreasonable noise" traveling across property lines is a violation of the ordinance and the common sense rule of thumb that should be used is that as it gets later in the day the volume of any noise should continually be lowered until at some point the noise cannot be heard by your neighbors.

#### **Fireworks**

The Fireworks laws in New Jersev are EXTREMELY restrictive, perhaps the most restrictive in the Country. In some States fireworks are permitted to be sold to the public however in New Jersey only paper or plastic caps for use in toy cap guns are legal. EVERY OTHER type of fireworks is ILLEGAL and will subject a person who possess or sells such a device to severe penalties upon conviction. Sparklers, novelty items such as cigarette loads, trick matches, trick noise makers, smoke grenades, toy propellants, snap & pops, poppetts and champagne poppers as well as firecrackers, Roman Candles, rockets, etc. are ALL ILLE-GAL in this State. Please do not be fooled by a salesman who tries to tell you that they are authorized or permitted to be sold by mail order houses or over the internet and please do not purchase fireworks and transport them into New Jersey from Pennsylvania or other States. Aside from being illegal fireworks are EX-TREMELY unpredictable and

dangerous. Each year many people

young and old find themselves in emergency rooms around the State with severe injuries caused by the illegal use of fireworks. Fireworks are also a serious fire hazard. Please leave fireworks to the experts at officially sanctioned public and licensed displays and be reminded that the police department and our Fire Code Officials have a

ZERO TOLERANCE policy for violations of the State's Fireworks Laws.

#### Severe Weather / Flooding

Clinton is prone to flooding in several commercial and residential areas, and susceptible to high wind damage and storm related power outages. The Police, Fire, EMS and Office of Emergency Management Departments of the Town are available to respond and assist you in emergencies, however YOU the property owner/tenant are responsible to be aware of severe weather forecasts and to take those steps unique to YOUR properties to protect them in cases of severe weather and flooding. Please take the time NOW to create a plan for you, your family and your home or business to follow in the event of emergency. Resources are available to assist you at the following websites:

connected to a live communications dispatcher who will accept your information, and you may remain anonymous if you wish. The Police Department is "one stop shopping" for residents and visitors to Clinton so please do not hesitate to call on us 24/7/365.

#### **Alcoholic Beverages**

Hosting a summer picnic or a party?, please be reminded that the consumption of alcoholic beverages in public (public property, streets, side-

walks, parks & playgrounds) is prohibited by ordinance. Please maintain an awareness of WHO is consuming your alcoholic beverages and HOW MUCH they are consuming

at YOUR event. As the host you may be held responsible for the actions of those that you have served *in some instances*. *Please also* remember that the Drunk Driving blood alcohol level threshold in New Jersey for those 21 and over is .08% blood alcohol content, however the limit for those under 21 is SIGNIFICANTLY LESS at .01% BAC.

So for all practical purposes this is a ZERO TOLERANCE for the consumption of alcoholic beverages if you are under 21 and operating a motor vehicle regardless of where or from whom you were served.

#### February 16, 2016 Budget Meeting

 $\sim$  Council discussed the current funds budget for 2016.

#### February 23, 2016

- ~ Mayor Kovach presented a proclamation to the Clinton Public School 's Lady Bulldogs for an undefeated season.
- $\sim$  A special event application was received for Rubber Ducky Race to be held July 17, 2016.
- ~ A resolution was adopted to authorizing the purchase of a tractor.
- ~ Councilwoman Dineen reported the Clinton Guild talked about a proposed dinner on the bridge event.
- ~ Councilwoman Sosidka reported the Girl Scout Troop 80828 is working towards a Silver Award: Teen Club. They will be organizing many events.

#### March 8, 2016

- ~ Mayor Kovach requested a motion to authorize the hiring of two police officers, Anthony Higgins and Alberto Bonilla, Jr.
- ~ Councilman Smith reported the Town is applying for a Pedestrian Safe Grant Opportunity to purchase new signs that stand in the crosswalks for pedestrian crossing.
