As Mayor and as a resident, I thought I understood the value of our emergency re-

sponders. On January 26th, when an electrical fire started in our second floor bathroom, I learned first hand about the incredible work our volunteers and police officers do to protect us and our belongings, twenty-four hours a day and seven days a week.

First, I want to thank the five Fire Departments that responded quickly, saving our home and much of our belongings. Clinton Fire Department, Quakertown, Annandale, Lebanon Township and High Bridge Fire Departments worked together to quickly extinguish the fire. It's hard to describe the fear I felt watching these volunteers climb a ladder to our burning roof while others entered our smoke-filled home. I was grateful to learn that the two firefighters who sustained injuries are well. I was amazed when I learned that a group of firefighters laid tarps over our

belongings to prevent water and smoke damage. This is truly above and beyond service. Many paid fire companies would not take the same care.

I am also truly grateful to the Clinton First Aid and Rescue Squad for taking care of my children and me during a very frightening time. The volunteers of our Squad showed utmost professionalism and compassion under very difficult circumstances.

Thank you to the Clinton Police Department, the first to respond to the scene. Our officers kept my family and neighbors safe while coordinating the emergency efforts of all of the responders. I am forever grateful to them for their professionalism and compassion in helping my family through a terrifying experience. As always, our officers

went above and beyond in service.

While this has been an awful experience, the Schaumburg family has seen the best in people in the last three weeks. We are once again reminded that we live in a wonderful community, filled with people who care about their neighbors. After long and aggravating days dealing with the aftermath of the fire, we talk about how lucky we are in so many ways. We're of course, grateful for our safety, but also for the countless people who've reached out to help us through this ordeal.

### **Code Enforcement by Jack Daniels**

Spring is here now and the cold winter that we had is a memory. This winter was one of the coldest in a long time and was evidenced by the freezing of the South Branch of the Raritan River.

#### FIRE PREVENTION - Fire

Prevention is an issue that must continuously be thought about by every citizen. You can help continue our safety trend by conducting a fire prevention inspection within your home or business. The smallest item corrected could avert a disaster from occurring. Items such as the proper use of extension cords and multiple plug adapters, inspection of your heating and cooling equipment, verification that your storage areas are safe, checking for clearance of combustibles around any type of electrical or heating equipment, inspections of chimneys and fireplaces, proper storage of combustible or flammable materials, making certain that fire protection systems are up to date and inspected, conducting fire escape drills, checking that your smoke and carbon monoxide alarms are working and most importantly, always thinking of the steps to take if a fire were to occur.

One constant issue I see is the improper use of extension cords & multiple plug adapters. These pose an increased fire threat because most folks do not understand the implication by using these devices. Both have limitations based on the manufacturer's testing and listing information. If you do not follow these directions, you WILL have a fire. It's just a matter of time. Think about the possible result by adding a 6-plug multiple plug adapter to an electrical outlet. This device takes a duplex outlet and now creates 4 extra plugs. This creates the potential to overload the wiring within the wall for this outlet. There is only so much electrical current that a wire can carry. If you create too large of an electrical load by using these adapters, you have caused an electrical power draw that is typically too great for the wire to carry. Over a period of time this "stresses" the wire and "weakens" the ability of the wire to carry electricity.

At some point the wire simply gives up and fails. This failure results in an electrical short caused by an overload and the potential to start a fire at the point of failure. If this failure is within a wall, it will grow unnoticed until the smoke or flames become visible, typically long after the wire failure occurred. The same process holds true when an extension cord is used or when multiple extension cords are plugged into each other. **EXTENSION CORDS AND** MULTIPLE PLUG ADAPTERS ARE NOT PERMITTED IN ANY BUSINESS. Great caution should be used if any of these devices are used in a home. Please try not to use these in your home if at all possible. Statistically, 80% of all fires occur in our homes (where you think you are the safest).

This is just one example of how the improper use of something could result in a fire. My plan for future newsletters is to have an example and explanation of the potential for a fire to occur as a result of some sort of equipment or process. I hope to have this be interactive and would enjoy comments from the residents and business owners of Clinton. **HOUSING REGULATIONS - The** rental (overcrowding) ordinance has been in effect just over 3 years now. I took on the enforcement responsibility of this ordinance in January 2008. Overcrowding has a direct influence on the entire infrastructure of the Town. Overcrowding will increase the demands of the rental unit, the rental building, and the Town as a whole. Increased demands are placed on the water supply, sewer system, electrical grid, consumable fuel products, local school, local traffic, and a potential for increased services from the Town employees and emergency services. Additionally, it is documented that the health and morale of the occupants are at risk when overcrowding exists. Overcrowding can occur because tenants do not

know what the requirements are for the proper number of persons within a unit or room. With that said, the minimum amount of space that is necessary to provide adequate living arrangements is contained within the ordinance. Each room used for sleeping purposes must have at least 70 square feet of floor space for the  $1^{\rm st}$ person using the room. Each added person using the same room requires an additional space of 50 square feet. For example, 2 persons sleeping in one room would require 120 sq ft of floor space, 3 would require 170 sq ft, 4 - 220 sq ft, etc. Do not confuse this with a 3-bedroom rental where 1 person uses each bedroom. In this example, each bedroom would require a minimum of 70 sq ft for 1 person per bedroom. While a rental unit may have adequate space for all of the inhabitants, the sleeping arrangements may not be code compliant. Landlords & tenants are responsible to verify that the rental unit is code compliant.

ZONING REGULATIONS (TEMPORARY SIGNS) - With spring and summer approaching, soon there will be temporary signs scattered about. ALERT!! The sign ordinance only allows these temporary signs under specific **conditions.** These conditions are outlined in the sign ordinance under section N.(2), N.(3), and N.(4). Garage Sale signs qualify as temporary signs and require a sign permit. In addition only events occurring within Clinton are permitted to have temporary signs installed. There is no fee for the application to install a temporary sign. Specifically, N.(2) is for on-site temporary signs, N.(3) is for standing temporary signs while N.(4) deals with the off-site temporary signs. The maximum duration of these temporary signs is 30 days. Most importantly, you MUST complete the temporary sign application otherwise the sign is considered illegal and will be removed without notice and a violation notice may be issued. Pruning Tip: When Pruning do not top or tip, always cut the branches at the branch collar or near the joint, but be careful not to cut the collar or joint too closely. You need to allow the tree to seal over the wound without having a lot of exposed wood tissue. Prune branches that: grow towards the ground, are dead, broken or diseased, rub together or overlap, and are sprouts growing from the base.

#### PEDESTRIAN SAFETY

With warmer weather comes increased pedestrian traffic throughout Clinton. It is

extremely important that pedestrians and motorists are aware of their separate but equal responsibilities at a crosswalk. Pedestrians must stop at the curb, look both ways and proceed only when safe to do so. Motorists must yield the right of way to a pedestrian who has entered the crosswalk. After dark, pedestrians should wear light or reflective clothing and motorists should pay extra attention at intersections and crosswalks for the unexpected. If either a pedestrian or motorist neglects their responsibilities the results can be tragic and expensive for both. Unfortunately, every year hundreds of pedestrians are injured and many are killed, that's why the police department takes pedestrian safety very seriously and we actively enforce pedestrian laws at our crosswalks.

#### **HOUSE NUMBERS**

Emergency responders frequently have difficulty responding to emergency calls at locations throughout Town because they are not properly marked with a street address that can readily be identified from the street or sidewalk. When an emergency happens seconds are critical to responding police, fire or rescue personnel. Please take the time to check your property to make sure that your house, apartment or building number is clearly marked and visible from the street so that those critical seconds can be spent on your emergency and not trying to find it!

# OVERNIGHT PARKING RESTRICTIONS

Winter overnight parking restrictions end March 31<sup>st</sup>. Note: At the time of this writing the Mayor and Council were considering a recommendation from the Road Committee to modify this Ordinance so please check with the Clerk or Police Department if you have any questions regarding it.

# CHILD SAFETY SEAT INSPECTIONS

Residents are encouraged to take advantage of our Child Safety Seat Inspection Program.

These inspections take approximately one hour and there is no cost. Inspections are also available at the Hunterdon Medical Center by appointment.

# CELL PHONES AND TEXT MESSAGING

The use of a wireless HANDHELD telephone or electronic communication device and/or text messaging with such a device while driving is a PRIMARY traffic offense in New Jersey. In other words you are subject to be stopped and issued a summons for talking on a handheld cellular phone or text messaging while operating a vehicle. We urge you to concentrate on the road and the operation of your vehicle and not a text that someone just sent you.

#### SKATEBOARDS, SKATES, ROL-LARBLADES and SCOOTERS

In addition to literally hundreds of complaints about their improper operation, we receive many inquiries every year regarding State law and our local ordinances governing skateboards, skates, scooters and other locomotion devices that are gas or electrically powered. Skateboards, skates and non-motorized scooters are considered "human powered" locomotion devices. They are prohibited from being operated on any street, highway or other area of Town designed for motor vehicles by ordinance. Additionally they are prohibited from being operated on the

sidewalks of Main Street, Lower Center Street, East Main Street and the section of Leigh Street from Route 173 to Center Street. Although they are sold in stores and on the internet, gas or electrically powered skateboards, scooters or any other "motorized" locomotion device are considered motor vehicles under current law and the operation of such powered devices is prohibited on any public street or sidewalk in New Jersey. Operation of these motorized devices on public streets can subject the operator to being charged under State motor vehicle law with operating an unregistered and uninsured vehicle in addition to any other traffic violation they may be committing, REGARDLESS OF AGE. If you have ANY questions regarding ANY motor vehicle law or Town ordinance regulating any of these devices PLEASE ASK an officer FIRST. Also, please remember that if you are under 18 years of age you MUST wear an approved helmet, even on a bicycle.

#### FINGERPRINTING

Fingerprinting has become required for a variety of public and private purposes. If you live in Clinton or the employer requiring you to be fingerprinted is in Clinton you can schedule an appointment to be fingerprinted by calling 908-735-2665 and leaving a message for Sergeant Cory Kubinak or Patrolman Jim Kramer.

On behalf of the entire membership of the Clinton First Aid & Rescue Squad, we welcome our new officers and wish them well as they guide the squad through its 41st year of providing Basic Life Support (BLS) and Rescue services (vehicle extrication, water rescue, and technical rescue) to the Town of Clinton, a majority of Clinton Twp., half of Lebanon Borough, and parts of Franklin Twp. and Union Twp.

The squad covers approximately 48 square miles and utilizes a combination of volunteer and supplemental paid personnel to insure in-house staffing. Unique in Hunterdon County, Clinton First Aid & Rescue

Squad has an ambulance crew in quarters, seven days a week. The squad operates 5 ambulances, a rescue truck, a marine support vehicle, 2 boats, a command vehicle and a technical rescue services trailer.

The Clinton First Aid & Rescue Squad has a Public Information Officer, Chad Newsome, who can be reached by both e-mail, cnewsome@clintonems.org, or by phone at 732-616-8661. In case of large scale incidents, the PIO will, if not on-scene, get you timely information pertaining to said event. Be assured that the Clinton First Aid & Rescue Squad will try to accommodate all requests for information as long as they conform to accepted practices pertaining to patient confidentiality.

### **Historic Commission by John Leddy**

#### MAINTAINING OUR HISTORICAL HERITAGE

The beautiful Town of Clinton and her surrounding historic homes are among the most popular sites in the State of New Jersey. This is due primarily to two centuries worth of homeowners, all of which shared the same value; the importance of maintaining the historic, architectural integrity of their home.

The Town of Clinton includes a variety of historic homes, primarily "Victorian" homes. Contrary to popular belief, the term "Victorian" describes a period in time (approximately 1840-1900) rather than a particular architectural style. Within this time period, we see a variety of "Victorian" styles, such as: Folk, Stick, Queen Anne, Second Empire, and Italianate. Our municipal building is referred to as "Victorian -

Italianate" architecture.

We are privileged to live in such a Town. Moreover, we are indebted to it's residents who through the years, realized and respected its' historic significance. It is our duty to maintain that historic integrity so that future generations can share in the beauty of our Town.

The Town of Clinton's Historic Preservation Commission offers assistance to those in our town who would like to maintain the historic, architectural integrity of their homestead. Furthermore, we would like to emphasize the importance of maintaining our Town's architecture – not only from a historical viewpoint but from an investment standpoint as well.

#### VINYL SIDING VS. REFURBISH-ING YOUR CLAPBOARD

If you are the owner of a historic home

and are considering covering your clapboard with siding, we encourage you to research the topic. You will find that most architects, real estate agents and investors will encourage you to ALWAYS maintain the historical integrity of the home. Modern siding does away with architectural details such as trim-work, dentils, etc. These priceless details can always be covered up but never replaced. Furthermore, studies have shown that your investment in a historic home has greater value in original materials as opposed to "renovating" with exterior siding. This applies to the exterior more than the interior of a home.

The Historic Preservation Commission encourages you to inquire about the history of your home and we appreciate your efforts in maintaining our priceless, historical, architectural integrity.

### Council Highlights by Susan Komorowski

#### October 28, 2008

- ~ Resolution passed declaring a curfew of 9pm to 6am October 13th through November 10th.
- ~ Parking Lease Agreement between the Town and the Clinton Fire Dept permitting 35 parking spaces available 24 hours a day
- ~ Mr. Cutter reports contacting the Electric Company to address recent long-term power outages in the Knolls, and to trim trees which add to the electrical problems.
- ~Board of Recreation and Buildings and Grounds Committees have solicited proposals to renovate the Gebhardt Field grandstand. The score board installation is complete.
- ~Phase II, water lines, completed ahead of schedule in the Clinton Knolls. paving to begin November.
- ~ Fur Majesty and the Running Shop businesses are negotiating with the Town for subdivisions to install pavers leading from the Lower Center St parking lot to Main St. This walkway will be a model for the Main Street street-scape initiative. and will improve handicap access. Project scheduled for Spring.
- ~The Clinton Town Recycling Program will be presented, as a model, to the County in December. That meeting will decide how to best use an awarded \$100,000 recycling grant to the County.
- ~ Pat Goehe and Dan Shea attended the Forestry Mgmt Training. The Town's Mgmt Plan for the trees was submitted, and is awaiting the State's approval for a grant.
- ~ Councilman Shea presented the Clinton Town banners for display, and thanked Ceil Covino, the Town Clerk, for her efforts on this project.

#### November 25, 2008

- ~ Attorney Cushing administered the Oath of Office to Councilman Duffy, who is filling the unexpired term of the late John C. Harrison. Mr. Duffy's term expires Dec. 31, 2010. ~ Congratulations to Maria Valenta, Rich Duffy, and Marty Pendergast on their recent election victories!
- ~ Resolution adopted to notify the Highlands Council that the Town intends to conform to the Highlands

Regional Master Plan.

- ~ Adoption of Resolution to request the Hunterdon County Board of Freeholders to reserve the Town's share of Open Space Funds in the amount of \$20,412.65.
- ~ Mr. Cutter praised Public Works crew on long efforts to repair three water main breaks on the weekend of Nov 22-23. Department members Howie Deemer, Art Dysart, Pete Bross, Bob Hoffman, and Jerry Vogel were commended for their efforts.
- ~ Mayor Schaumburg commended Mr. Cutter as a panelist in Atlantic City. Mr. Cutter was an expert on "Going Green". Mr. Cutter also earned an award for his Stormwater Mgmt Plan-the 2007 Clean Water NJ Award.
- ~ Councilman Shea requested the Council's consideration in amending the winter parking ordinance for Center Street and other sections of Town where residents have only street parking. Mayor agreed. Chief Matheis will attend the next Roads meeting to further discuss the current Ordinance and a proposed Ordinance for 2009.

#### December 9, 2008

- ~ Mr. Cutter reports recycling numbers continue to rise, gasoline usage down from previous month.
- ~ Mayor Schaumburg reports Police Dept renovations coming along well, and new Town banners are up and look great!
- ~ Clinton Guild discussed utilizing a consultant to help market the Town the Mayor encouraged the Guild to bring their proposals to the Council for their consideration.

#### December 23

- ~ John Leddy appointed to the Historic Commission.
- ~ Town of Clinton received notification of award of the Safe Routes to School grant for \$225,000. Thanks to Laurie Insel for her efforts in applying using Town Open Space Funds to for this grant. This grant assists with the engineering portion of work from the Clinton House to New Street on Old Hwy 22. Affected property owners will be notified and invited to meetings regarding the project.


