Open fires or "open burning" is prohibited within the State of NJ with few exceptions. These exceptions involve campfires at approved camping grounds, certain cooking type fires that are properly set up and far enough away from combustibles where a fire safety permit has been obtained, and other open fires where the proper fire safety and/or forest fire permit has been obtained first. The Uniform Fire Code prohibits open burning without the proper permit

and is therefore an offense of the several State laws. The fire safety permit process takes a short time to process therefore applying well in advance is strongly recommended. Public Works / Bus. Administrator by James T. Naples



Over the summer the Town was busy with several capital improvement projects which will serve the residents of Clinton for many years to come. These include improvements to the water and sewer systems as well as upgrades to the municipal facilities.

The work has begun on the replacement of water main pipe on Leigh Street. The contractor is replacing over 4,000 feet of pipe which will reduce leaks and disruption to service in the area. The work on this project is expected to be completed by the end of October. In addition work has begun on the new 2.5 million gallon water storage tank. The addition of this tank will increase the capacity of our system and out ability to provide service to our water customers during peak usage.

The sewer treatment plant will soon

see improvements with the replacement of the existing filters and a new roof. Both of theses currently are more than 15 years old and have seen their effectiveness decline markedly. The replacement of the filters and roof will reduce costly maintenance and repair and increase the overall efficiency of the plant operations.

The municipal building and community center received some much needed repair that was recently completed. The community center roof was replaced and equipment was repaired in the playground and tennis court. In addition the revised plans for the grandstand were completed and work should begin on the renovation of this historic icon in the fall. The railings and concrete steps to the municipal building were repaired and the public works staff added a paver patio near the back entrance using surplus pavers.

In addition to the above improvements the Town buildings all were recently retrofitted with energy efficient lights and HVAC equipment. This equipment upgrade was funded through the NJ Smart Start program and an energy efficiency block grant. The grant funds covered approximately 85% of the total cost of the upgrades. The Town will see its energy demand reduced at all of its facilities in future years.

The Town has several affordable housing units available for purchase. If you know anyone who may be eligible to qualify for affordable housing please visit the Clerk's Office to fill out an application. These units offer a valuable opportunity for income qualified participants to become home owners in Clinton. Units are currently available for both low and moderate income levels.

Road Department by Dan Shea

Our roads projects for this season are in the final planning stages. However since the water company has decided to replace their lines in this location during the winter months we have moved back our Main, East Main and Lower Center road replacement schedule until spring of

2012. This should leave the business district with a less hectic environment as we lay out the new roads in the warmer months.

Repairs at the Town Hall included the steps and railings to the entrances.


Painting is scheduled in the near future to touch up the outside trim.

Police Department by Chief R. Brett Matheis



As the new school year begins we ask that parents

please review some important safety practices with their children to help make this a SAFE year for everyone traveling to and from CPS.

The official walking routes to Clinton Public School are as follows:

From the west take the sidewalk along West Main Street past the Clinton House onto Main Street, turn right on Leigh Street south and continue across Route 173 with the Crossing Guard, continue south to the Crossing Guard at the CPS Bike Path and then up the hill to CPS. (DO NOT WALK UP SCHOOL STREET unless accompanied by an adult) From Halstead/Center Street cross with the Crossing Guard stationed at Leigh Street at Center Street, continue south on Leigh Street and then continue as outlined above. From Alton Place or the South cross with either the Crossing Guard at Alton Place or at the CPS Bike Path. Children are not to walk along Route 173 between the South Branch River and Leigh Street unless they are accompanied by an adult.

The very nature of Leigh Street, School Street and the CPS parking lot itself is not conducive to the efficient flow of the traffic volume generated in the morning and afternoon by parents delivering or picking up children directly at CPS. However, if you still choose to drive your children to CPS please plan to leave EARLY. Morning rush hour Interstate 78 traffic is extremely unpredictable and it DI-RECTLY IMPACTS ALL TRAFFIC here in Town and will inevitably delay your arrival at CPS. To ease conges-

tion in the CPS parking lot we strongly urge parents to allow their children to walk to school or to utilize Riverside Drive for drop off's and pick-ups. Parents that do choose to deliver children directly to CPS must immediately make their drop off and proceed away from the curb as to not block other vehicles or buses. No vehicle will be permitted to park or stand in front of CPS in the Bus Lane or Fire Lane.

Aside from parents, our School Crossing Guards are the first line of protection for our children walking to and from CPS. Parents, please reinforce with your child the importance of obeying all instructions from our Crossing Guards. Motorists, please be courteous and patient with our Crossing Guards while they are at their posts safeguarding our children. Our Guards are empowered to report motorists who they observe breaking traffic laws to the Police Department for prosecution, and to report improper behavior on the part of students to CPS Staff. The job of a Crossing Guard is hot in the summer, cold in the winter, wet when it rains and frustrating when motorists or children are difficult and ignore their instructions, so the next time you see one of them please smile, wave and above all appreciate them for the very important job that they do!

If a parent or a student observes ANY activity or behavior on their way to or from CPS that they feel is suspicious or "out of the ordinary" they should report it IMMEDIAT-LEY to a Crossing Guard, a Police Officer or CPS Staff. Unfortunately suspicious activity is all too often not reported until "the next day" when there is little if anything that can be

investigated or done about it. And one final reminder, although there are Police Officers on-duty and patrolling Clinton 24/7, Police Headquarters is not staffed fulltime therefore unless otherwise instructed, to immediately contact a Police Officer you must call our Communications Center at 908-735-8611 where you will reach one of our civilian dispatchers.

ORDINANCE REMINDERS

Smoking Prohibited by Minors in Any Public Place: Chapter 128 prohibits smoking in any public place by anyone under the age of 18.

Smoking Prohibited in all Parks, Playgrounds and Park Facilities: Chapter 105 prohibits smoking in all Town parks, playgrounds and other park facilities.

Established Hours of Operation for Town Parks and Playgrounds: Chapter 105 establishes hours of operation for all Town Parks and Open Space. Hunts Mills Park 6am to 10pm. De-Mott Pond 6am to 10pm. Community Center and facilities 6am to 10pm or upon conclusion of sanctioned activities inside the Center. Basketball courts, tennis courts and baseball fields are open for play beginning at 7am until 10pm.

Clinton First Aid & Rescue Squad by Chad Newsome



NEW OPERATIONS CHIEF

The Clinton First Aid & Rescue Squad, Inc. is

proud to announce the appointment of Howard "Bucky" Buchanan to the position of Operations Chief, effective September 2011. Mr. Buchanan has been involved in the Emergency Services sector since 1981 when he became a member of the local American Red Cross' Youth Disaster Action Team at their Millburn-Short Hills Chapter. He helped establish the Safe Rides program within the Chapter, where he served as a Dispatcher, and later a driver. He also attained the rank of Eagle Scout with Troop 2 in Maplewood, NJ and worked as an Outward Bound Expedition Guide for the Boston-Essex Council (MA) at a New Hampshire camp for 3 summers.

He started in EMS as a member of the Maplewood First Aid Squad, where he was a cadet member and worked his way up to Lieutenant on the Maplewood Squad. He joined the Springfield First Aid Squad in 1985 while working at New Jersey AAA, and shortly afterwards became certified as an EMT. He also held several Line Officer positions in Springfield, before moving from Essex County out to Branchburg Township in 1989. Since that time, he has been a member of the Branchburg Rescue Squad, where he is a Life Member and currently holds the rank of Chief of Department. In 2001, Bucky joined the Whitehouse Rescue Squad's Rescue Services Division as a Supportive Member. He helped to establish their Rehab Services Unit, and quickly became more involved in the RSU, and changed classification to a RSU Associate, where he held the rank of Master Rescue Technician. In September 2001, Bucky joined other RSU & EMS units from WHRS in serving at both Ground Zero NYC, as well as other points around Manhattan during the aftermath of the 9-11 attacks. In 2003, Bucky was promoted to the position of Captain of the Rescue Services Unit, which he held through 2005.

Bucky was a founding member & secretary of the Hunterdon County Emergency Medical Services Squad Chiefs Association. He also is a past-Chairman of the Board for the American Red Cross Hunterdon County Chapter, an organization that he held the position of Disaster Health Services Specialist and Mass Care Technician on their National Disaster Response Team.

In May 2002, Bucky was appointed to the position of EMS Coordinator for the Hunterdon County Office of Emergency Management, where he helped plan, coordinator and monitor the response to large-scale incidents within the County and when requested by other agencies for assistance. He also was a founding member of the Hunterdon County Technical Rescue Task Force. He has also been an Incident Command System, Technical Rescue and EMS Instructor with the Hunterdon County **Emergency Services Training Center** since 2003. A founding member of the NJ EMS County Coordinators. Bucky has worked with this group since it was founded in 2004, and continues today, sitting on committees including a State Mobile Emergency Room Working Group for the State's UASI Region. In November 2006, Bucky was accepted onto the newly formed State of New Jersey **EMS Task Force**

In his spare time, Bucky works as the Lead Instructor & President of RVESCUE, LLC, an Emergency Management & Technical Rescue consulting and Education Company based in Central New Jersey. Previously, he had been a Senior Project Coordinator with the National Transit Institute, assigned to manage their FEMA/TSA "Connecting Communities" program across the US.

Prior to joining NTI, Bucky was employed by Bank of America, where was a Vice President with the Associate Premier Bank covering Delaware to NYC Region. He also is a founding member of FleetWorks NJ, an employee-driven volunteer group, where he is a past-president and a sitting advisory board member of the surviving organization, Team Bank Of America New Jersey. He has also been awarded the Presidential Volunteer Service Award from the President of the United States and Ken Lewis, Chairman and CEO of Bank of America.

Since 2010, Bucky has been a Disaster Assistance Employee with FEMA Region II, based out of New York City. He has been assigned to several disasters, working in the Planning Section in New York, New Jersey, and the US Virgin Islands. In May 2011, he received the "Bronze Trainer Award" recognition from FEMA's Center for Domestic Preparedness, for his quality and quantity if Incident Management Training programs, as authorized by the State of New Jersey.

His certifications include: EMT-B, Vehicle Rescue Technician, Rope Rescue Technician, Confined Space Technician, Swiftwater Rescue Technician, Rescue Boat Operator, Trench Rescue Operator, along with multiple other incident command, Awareness, FEMA ICS & HSEEP Instructor and technique classes.

Council Highlights by Angela Hawes

May 10, 2011

- ~Resolution authorizing an agreement with DONJON for recycling of scrap metal.
- ~Hunterdon County Chamber of Commerce hosted National Tourism Week from May 2-15, 2011, during their visit to the Town of Clinton; everyone was very impressed with variety of shops and eateries.
- ~Two trees were planted on Arbor Day April 29 on East Main Street, and were named Will and Kate in honor of the Duke and Duchess of Cambridge and their wedding on that day.
- ~Electronic Message Boards have been placed in key locations throughout the Town displaying important messages.

May 24, 2011

- ~The Town lost a dedicated volunteer and good friend, Don Goehe. Don and Pat Goehe have been a great team. Don was the Chairman of the Environmental Commission for 30 years! Don will be missed and never forgotten.
- ~Annual water restrictions will be altered to permit power washing. Less water is used power washing than with a hand held device.
- ~Resolution to Award Contract to Reivax Contracting Corporation for the Leigh Street Water Main Replacement.
- ~Roads Committee discussed the televising of storm drains and water mains and detected several problem areas on the 30 year old mains located on Lower Center Street.

 Main Street and East Main Street drains were found to be in good condition.

June 14, 2011

- ~Accepted, with regret, the resignation of Mayor Christine Schaumburg.
- ~Resolution adopted for Council to appoint Councilman Robert B. Smith as Mayor Pro Tem.
- ~Harvey Finkel and Rob Dougherty

- of the Clinton Book Shop, and organizers of Hunterdon First, proposed hosting a weekly Farmer's Market in Town. Conceptual plan accepted via Motion.
- ~Refunds issued to Town merchants who were billed \$75 Road Opening Permit fees upon the sidewalk pavers installation.
- ~Lien assessed by Town of Clinton Public Works for maintenance of the following properties due to failure of owners to comply with repeated notice of violations regarding public welfare and safety: 19 & 31 West Main Street 2 & 8 Hillside Drive, all in the Town of Clinton.
- ~Council approved waiving food permit fees for non-profit organizations that are designated 501C-3 when the Hunterdon County Health Dept waives such fees, easing paperwork and multiple request procedures.
- ~Anthony Kearns, HC Prosecutor, is proposing ordinance prohibiting underage consumption of alcohol on private property. Ordinance may be intended for larger homes in more rural areas, in response to a complaint of noise. Officers in the Town already have a wide range of discretion such as verbal or written summonses, so motion made to table this discussion for future consideration.
- ~Shared sewer services with Clinton Township is going well.
- ~Dumpsters for Scrap metal and Electronics are located at the Treatment Plant.
- ~Community Center to have the roof replaced.
- ~Municipal Building to get new railings and repairs to steps and ramp.
- ~Improvements to Gebhardt Grandstand to begin over next few weeks.
- ~Rescue Squad responded to 146 calls in May, with Town response time in under 4 minutes!!!
- ~Construction of 2.5 MG Storage Tank to begin soon, per Water Committee.

June 28, 2011

- ~Richard F. Miller wished to express his thanks to many people who have welcomed him into his new appointment as Mayor of the Town of Clinton.
- ~Jerry Vogel of the Town of Clinton Waste Water Treatment Plant is to be commended for fast thinking when passing a West Main Street Fire. He grabbed a fire extinguisher from his truck and put out the fire out.
- ~Tennis Court has a new net.
- ~Clinton First Aid & Rescue Squad will be sending out their 2011 Fund Drive Letter.
- ~Chamber of Commerce to display a banner from September 26 thru October 10, 2011 for the Chamber of Commerce Business and Home Expo on October 11, 2011 in Flemington.

July 12, 2011

- ~Farmer's Market will be opening on Sunday July 17, 2011 from 10-2, and every Sunday till October at the Clinton Fire Department parking lot.
- ~Resolution Calling for a Ban on Fracking, which is hydraulic fracturing (fracking) for natural gas involves the use of chemicals and hazardous materials during construction, drilling, hydraulic fracturing, gas production and delivery, well maintenance, and workover operations is prohibited within the Town of Clinton.
- ~So far 2011 figures on garbage since changing the solid waste and recycling pick up days. Figures show solid waste is down 20% and recycling figures are up 10%.
- ~Electronic dumpsters located at the Treatment Plant have brought 3,376 lbs of electronic waste.
- ~Roads/ Water —a recent alignment meeting of the two committees to discuss how to proceed with the Main Street, East Main and Lower Center Street project. A public information meeting for the merchants and residents will be arranged and will also include members of water, sewer, and roads committee as well as the Town Engineer.
