Shade Tree Commission will be meeting October 15. Shade Tree is also working with the Piazza family, owners of the Clean Plate. A huge Sycamore tree on their property along the South Branch has been measured by the Town Arborist, Lou Spanner. By measuring the tree's circumference, it is estimated that the tree is over 200 years old and will be nominated for State Champion Tree. They will receive a plaque and get State recognition! It is great timing for this bit of history in conjunction with the Red Mill's new water wheel and the history of that iconic structure!

Historic Commission will be meeting next week.

Rescue Squad will be holding a coin toss on Saturday, October 17 at the High Bridge station past Gronsky's on West Main Street from 9 - 1pm

Councilman Traphagen, having a history with scouting, has been coaching an Eagle Scout with a project at the Water Street Park. The Boy Scout, Garrett, constructed two new benches in the rear of the park, refinished a bench already there and worked on some planters. A big shout out to Garrett for the improvements made, stop by and check them out!

Councilman Humphrey

Clinton Fire Department – Deputy Chief Scott Wintermute reported 21 calls for the month of September and gave the breakdown as to five fire calls; nine alarm activations; two carbon monoxide; five smell of smoke and two other calls for service; a total of 205 for the year to date. In September, the fire department received the new turn out gear for five firefighters at a cost of \$15,000. The old gear was cleaned and will be repurposed. The engine has been out of service for several month and should be returned towards the end of the week or next week, no cost estimate has been provided yet. Chief Hedden and Deputy Chief Wintermute have met several times with the Fire Marshall to review the plans for the A&P redevelopment project to make sure fire safety is addressed. Chief Hedden and Deputy Wintermute also met with the Road Committee to discuss the layout in front of the Clinton House, and have come up with reasonable solutions to get apparatus to the building without incurring large costs. Environmental Commission, along with the Shade Tree Commission, expressed concerns of the Lantern Fly invasion and many residents have expressed an increase in the amount of questions. Mr. Phelan identified an entire page on the website. The Commission have also identified a huge quantity of cigarette butts in the Downtown area and discussed prevention management on the discarding of them with the Roads Committee, possibly cigarette stands throughout the area.

Communications Committee – the Halloween Page has been prepared by Council Humphrey and Intrabartola and should be going live Thursday, October 16. Newsletter articles are due before October 29, please reach out to your committees and get the articles in.

Senior Committee – hoping to work with Councilman Traphagen to ramp up the committee again taking COVID precautions into consideration.

The Red Mill Wheel ceremony was terrific !!
