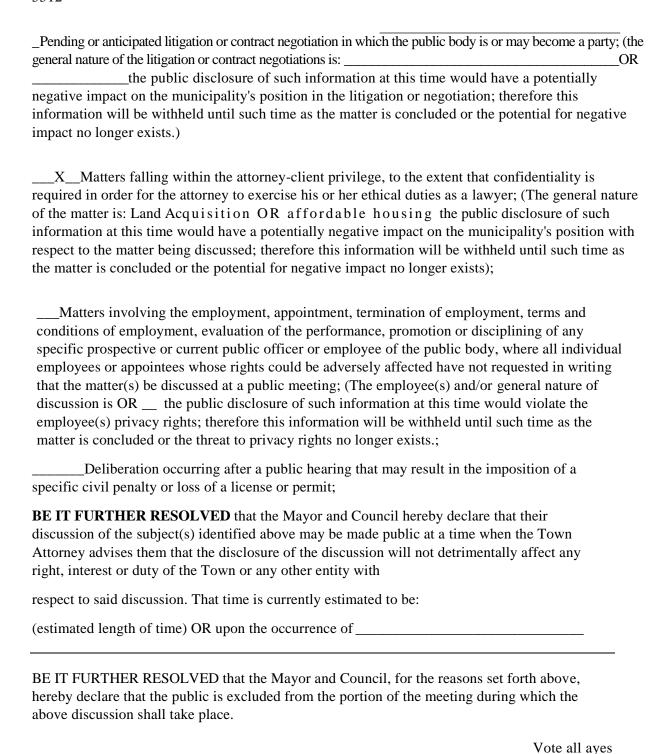

PUBLIC COMMENTS

Laura Burr, 26 Union Road, presented to Council her concerns of safety on Union Road. Ms. Burr broke it down into three matters.

- 1. 25 mph speed limit and 6 ton weight limit often ignored with trucks coming off the highway when the interstate has traffic and the cars exceeding 50 mph.
- 2. Sidewalks do not connect from Union Road to Rupell's Road and other disconnects in the Knolls such as Spruce Road does not connect to Union, forcing children and parents to walk in the street.
- 3. The need of a crossing guard at the intersection of Exit 15 where the traffic light is, the gas station and the car wash is extremely warranted and needed.

Councilwoman Johnson agreed with Ms. Burr on all points. Ms. Karsh said the points have been addressed and regarding the speed, asked if the sign "THIS IS YOUR SPEED" the electronic sign that the police have, could be relocated on Union Road for a time. The Chief said he could set it to record the higher speed comes in and the speed and documents the time of day that people abuse the speed limits.

Ms. Burr addressed the cut through the Knolls down to the Clinton House and asked if that could be properly paved. Ms. Karsh explained it is not possible because there is no viable way down because of the elevation making it ADA compliant. The Town is working with Go Hunterdon for pedestrian friendly solutions and with the school. Chief Kubinak will address the need for a crossing guard. Follow up with the school will be made in August.

MAYOR'S COMMENTS

- 1. Garrett Reed Gonzalez-Rivas, is interested in earning his eagle scout status, by pursuing a Clinton Park Enhancement by building benches at the Water Street lot. Buildings and Grounds is looking at the idea.
- 2. Hunterdon County Prevention Resources produced a documentary for discussion on July 15 with a Q & A period, please share the information on social media.
- 3. Hunterdon Medical Center is not holding their annual Gala but are working on a telethon with 11 other organizations and a "town challenge" to participate in raising money through donations.
- 4. Eric Eisenhart is also talking about a competitive challenge where folks would be visiting sites in Hunterdon County and running short and/or long distances. Mayor Kovach is 6 miles away from 172 miles in the "Garden State Parkway challenge".
- 5. The Governor set forth an Executive Order today requiring that masks must be worn outside if social distancing is not an option.

INDEMNITY AND TRUST AGREEMENT

THIS AGREEMENT made this 8TH day of July 2020 in the County of Morris, State of New Jersey, by and between the Statewide Insurance Fund (hereinafter "FUND"), and <u>CLINTON TOWN</u> in the County of <u>Hunterdon</u> a duly constituted local unit of government (hereinafter "LOCAL UNIT");

WHEREAS, two or more local units have collectively formed a joint insurance fund as such an entity is authorized and described in N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the LOCAL UNIT has agreed to become a member of the FUND in accordance with and to the extent provided for in the Bylaws of the FUND and in consideration of such obligations and benefits to be shared by the membership of the FUND; and

WHEREAS, the LOCAL UNIT has complied with relevant law with regard to the acquisition of insurance;

NOW, THEREFORE, it is agreed as follows:

- The LOCAL UNIT, upon entering the FUND, agrees to be bound by and to accept and comply
 with each and every provision of the FUND's Bylaws, Risk Management Program, as it applies
 to the LOCAL UNIT and the applicable statutes and administrative regulations pertaining to joint
 insurance funds.
- The LOCAL UNIT agrees to participate in the FUND with respect to the coverage listed in the LOCAL UNIT's "Resolution to Join" in accordance with the FUND's Bylaws and Risk Management Program.
- 3. The LOCAL UNIT agrees to become a member of the FUND until January 1, 2024, at 12:01 a. m. eastern standard time. The commencement date shall be the effective date as established by the FUND's Bylaws and policies.
- 4. The LOCAL UNIT certifies that it has not been canceled for non-payment of insurance premiums for a period of at least two (2) years prior to the date hereof, or, if self-insured, that it has never defaulted on any claims.
- 5. In consideration of membership in the FUND, the LOCAL UNIT agrees that it shall jointly and severally assume and discharge the liability of each and every member of the FUND in accordance with statute and regulation, and by execution hereof the full faith and credit of the LOCAL UNIT is pledged to the punctual payment of any sums which shall become due to the FUND in accordance with the Bylaws thereof, this Agreement or any applicable statute or regulation.
- 6. If the FUND, in the enforcement of any part of this Agreement, shall incur necessary expense or become obligated to pay attorney's fees and/or court costs, the LOCAL UNIT agrees to reimburse the FUND for all such reasonable expenses, fees and costs on demand.
- 7. The LOCAL UNIT and the FUND agree that the FUND shall hold in trust all monies paid by the LOCAL UNIT to the FUND and those monies will be used in accordance with all applicable statues, the FUND's Bylaws and the Risk Management Program.
- 8. If required by the Commissioner of Insurance or applicable statutes or regulations, the FUND shall establish separate trust fund accounts in accordance with N.J.S.A. 40A:10-36, et seq. and any other statutes or regulations that may be applicable. Said trust accounts shall be used solely for the payment of claims made against members of the FUND, excess insurance premiums and/or the administration of the FUND, or for such other purposes as now or hereunder permitted by statute or regulation.

- 9. Each LOCAL UNIT which shall become a member of the FUND shall be obligated to execute an agreement similar in form to this Agreement.
- 10. To the extent required by law, the LOCAL UNIT shall provide notice of this Agreement to the Office of the State Comptroller.

AN ORDINANCE OF THE TOWN OF CLINTON, COUNTY OF HUNTERDON, STATE OF NEW JERSEY APPROVING AND AMENDED REDEVELOPMENT PLAN FOR

BLOCK 8, LOTS 23.02, 23.05, 24, 27, 29.02, AND 33

WHEREAS, pursuant to Resolution #60-18 adopted on February 27, 2018 (as amended by Resolution #126-19 adopted on September 24, 2019) the Mayor and Council of the Town of Clinton (the "Council") authorized the Town of Clinton Land Use Board (the "Land Use Board") to undertake a preliminary investigation to determine whether an area known as the former A&P Super Market and identified as Block 21, Lots 6, 25, 27, 28, 29, 30, 30.01, 31, 32, 33, and 34 on the Town of Clinton Tax Maps (the "Redevelopment Area") met the statutory criteria to be designated as an "Area in Need of Redevelopment" pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-3 et seq. (the "LRHL"); and

WHEREAS, the Land Use Board held a public hearing on October 15, 2019 regarding the preliminary investigation and the Redevelopment Area was found to meet the standard for an area in need of redevelopment; and

WHEREAS, the Land Use Board subsequently adopted Resolution # 2019-0011 that same date recommending that the Town Council designate the Redevelopment Area as an "Area in Need of Redevelopment" pursuant to the LRHL; and

WHEREAS, the Town Council adopted Resolution #141-19 on October 22, 2019 designating the Redevelopment Area as an "Area in Need of Redevelopment" in accordance with the Land Use Board's recommendation and instructed the Land Use Board to prepare a redevelopment plan; and

WHEREAS, in consultation with the Town Planner, Jim Kyle, P.P. of Kyle & McManus Associates, the Land Use Board prepared a redevelopment plan dated January 10, 2020 (the "Redevelopment Plan");

WHEREAS, on March 11, 2020, the Town Council adopted Ordinance #20-01 adopting the Redevelopment Plan; and

WHEREAS, in consultation with the Town Planner, Jim Kyle, P.P. of Kyle & McManus Associates, the Land Use Board prepared an Amended Redevelopment Plan dated June 25, 2020 (which is attached hereto as **Exhibit B,** the "Amended Redevelopment Plan") which increases the residential unit count to provide an additional affordable unit and changes the general layout of the proposed project;

WHEREAS, pursuant to N.J.S.A. 40A:12A-7(f), because the Land Use Board prepared the Amended Redevelopment Plan, the Town Council does not have to refer the Amended Redevelopment Plan to the Land Use Board for review and comment; and

WHEREAS, after conducting a public hearing on the Amended Redevelopment Plan, the Town Council finds that it is in the best interests of the Town to adopt the Amended Redevelopment Plan.

NOW THEREFORE BE IT ORDAINED, by the Council of the Town of Clinton, County of Hunterdon, and State of New Jersey, as follows:

Section 1. Pursuant to the authority granted to the Town Council by N.J.S.A. 40A:12A-7, the Amended Redevelopment Plan for the Former A&P Supermarket, dated June 25, 2020, prepared by Kyle & McManus Associates and attached hereto is hereby adopted.

Section 2. Pursuant to the provisions of N.J.S.A. 40A:12-7(c), the Amended Redevelopment Plan for the Former A&P Supermarket hereby supersedes applicable provisions of the Town of Clinton Land Use Ordinances. In so doing the Amended Redevelopment Plan for the Former A&P Supermarket shall constitute an explicit amendment to the Town Zoning Map to identify the Redevelopment Area as the boundaries of the area regulated by the Amended Redevelopment Plan for the Former A&P Supermarket. The official Town Zoning map shall be amended to henceforth coincide with the Amended Redevelopment Plan for the Former A&P Supermarket.

<u>Section 3.</u> If any portion of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole, or any other part thereof. Any invalidation shall be confined in its operation to the section, paragraph, sentence, clause, phrase, term, or provision or part there of directly involved in the controversy in which such judgment shall have been rendered.

Section 4. All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency only.

Section 5. This ordinance shall take effect after final approval and publication according to law.

A notice of this Ordinance will be published in the Courier News edition of January 11, 2020. A public hearing will be held August 12, 2020.

Ms. Karsh, member of the restart committee, suggested a weeknight as not to take away from guild events and outside dining on the weekends. Ms. Johnson agreed that would be a good idea. Ms. Dineen, suggested the Water Authority property. All ideas will be discussed

with the committee. Ms. Intrabartola of the committee will now handle scheduling of the fields and the community center.

Ms. Johnson would like to promote the revitalization of the playground efforts and their search of volunteers in every area. Social media will begin putting out information for everyone to share.

Councilman Humphrey

Mr. Humphrey addressed Council to discuss the procedure taking place of events happening without full approval of the Mayor and Council. Mr. Humphrey wishes to formalize a process of events taking place. Mayor Kovach explained that the two graduation parades of cars took place at the discretion of the Police Chief who is also the Office of Emergency Management coordinator because of the emergency conditions, OEM makes the final decision. Mr. Humphrey stated that he would like to see "communication alerts" and shared thoughts and feelings of council when proposals are made to have an event in Town. A penalty and fines should be imposed to organizations or groups for holding events without prior council approval. Mr. Humphrey referenced the Fourth of July parade as an example of lack of communication.
