1. Mayor Kovach said she received an e-mail from Wesley Hockin, a member of the Clinton Fire Department and Clinton First Aid and Rescue Squad. Mr. Hockin stated they are creating a team similar to last year for the Relay for Life to be called "Clinton Fire/EMS. They are dedicating this year's race to Eugene De Cleene, a long-time Clinton resident, who passed away last year. Mr. Hockin is asking Mayor

and Council if they can go around to the merchants on Main Street for a \$5.00 donation and then they will put a purple ribbon around the tree outside their business.

RESOLUTION #46-19 - OPPOSITION TO NEW BEEKEEPING REGULATIONS

A motion was made by Ms. Dineen, seconded by Ms. Karsh to adopt Resolution #46-19 as submitted:

RESOLUTION #46-19

WHEREAS, the New Jersey Department of Agriculture has published new beekeeping regulations in the New Jersey Register on December 3, 2018; and,

WHEREAS, these new regulations include a section that states, it shall be unlawful for a beekeeper to keep any hive or hives in such a manner or of such disposition to pose a threat to: 1. Public health and safety; or 2. Bee Heath, as determined, by the State Apiarist or his or her designee; and,

WHEREAS, these new regulations also include a section on Location of Hives, which requires that when a colony is located less than 20 feet from any property line, a beekeeper shall establish a flyway barrier at least six feet in height consisting of a solid wall, fence, dense vegetation, or combination thereof that is parallel to the property line and maintain it to extend 10 feet beyond the colony in each direction; and,

WHEREAS, these new regulations also include a section on Waiver Process that is unduly burdensome and should simply utilize New Jersey Municipal Land Use Law 40:55D-12; and,

WHEREAS, the Town of Clinton believes that bees, and Clinton residents who are beekeepers, are beneficial to Clinton and that those residents in Clinton who are currently beekeepers as hobbyists should be able to continue to have bee hives.

NOW THEREFORE BE IT RESOLVED by the Town of Clinton, County of Hunterdon, State of New Jersey that the Mayor and Town Council wishes to go on record with the New Jersey Department of Agriculture that the Town of Clinton is opposed to the new beekeeping regulations which would have a detrimental impact on beekeeping in Clinton as well as throughout New Jersey and urges the New Jersey State League of Municipalities to work with the New Jersey Beekeepers Association towards creating legislation with straightforward regulations based on fact, science and best management practices which will protect both beekeepers and non-beekeepers within the State of New Jersey.

BE IT FURTHER RESOLVED, that copies of this resolution be sent to the New Jersey Department of Agriculture; New Jersey State: League of Municipalities, the New Jersey Beekeepers Association; and all Hunterdon County Municipalities urging them to oppose the adoption of the new beekeeping regulations as proposed by the New Jersey Department of Agriculture.

- 2. Mayor Kovach received a citizen involvement application from Bryan Lubsen, 66 Lakeview Avenue, to join the Land Use Board. Mayor Kovach asked for a motion to appoint Bryan Lubsen to the Land Use Board as an Alternate I member.

REPORTS FROM COUNCIL & TOWN OFFICIALS

Councilwoman Johnson

- 1. Councilwoman Johnson reported the Town's Annual Bonfire was a big success. This year was the largest turnout and the weather was perfect. The Board of Recreation will be meeting next week.
- 2. Councilwoman Johnson reported the school board meeting was cancelled last month due to weather. The school was closed.

Councilman Humphrey

1. Councilman Humphrey received an application from Lee Di Donato to join the Clinton Fire Department. He was previously a member of the Whitehouse Fire Company and has recently moved to our area.

A motion was made by Mr. Smith, seconded by Ms. Dineen to accept Lee Di Donato has a new member to the Clinton Fire Department.

- 2. Councilman Humphrey reported the Clinton Fire Department had 27 calls for January 2019. In 2018 the Clinton Fire Department had over 2400 hours of training and drills, over 2100 hours of fire department duty activities and active standby, and 218 level 1 calls which involve fire and carbon monoxide alarms and motor vehicle incidents.
- 3. Councilman Humphrey advised mayor and council that the fire department wants to submit changes to the ordinance regarding mitigation rates. He would like to discuss this at the next council meeting. These are fees that are billed to the insurance companies such as extrications, creating landing zones for level one and level two responses and amounts for fires and chemical responses.
- 4. The fire department recently purchased a special washer and dryer which washes the chemicals out from the clothing to help reduce the chance of getting cancer. Statistics say that firemen have a much higher chance of cancer and this should help reduce that possibility substantially. They were able to get this washer and dryer by a grant. Other fire departments in our area were able to purchase them as well.

Councilman Smith

- 1. Councilman Smith reported the Clinton Rescue Squads had 313 calls last month which is 10 over January of last year. The educational training hours will be submitted at the next meeting.
- 2. Councilman Smith said the water and sewer committees met with the superintendents of both departments that are retiring and their staff. The staff was asked to give transitional recommendations once the exiting superintendents retire. These recommendations will be giving to Mayor and Council once the committees have reviewed them.
- 3. Roads Committee met. The opening of the West Main Street sidewalk project will be March 7 to the 21st and then proceeding forthwith. Councilman Smith would like to introduce the sidewalk ordinance at the second meeting in February. It concerns the ownership and who is responsible for the sidewalks. He asked all to review for the next meeting. Richard Cushing, Town Attorney, has put a lot of time into this ordinance.
- 4. Councilman Smith informed Mayor and Council he is going to have Richard Cushing look into something that a previous mayor, Allie McGaheran, agreed to in 1997 whereby the sidewalks that are owned by the State will be maintained by the Town. No municipalities should maintain property owned by the State. Councilman Smith is not aware how this came about and will be looking into it to have it changed. The state recently pointed this out to the Town.

Councilwoman Karsh

- 1. Councilwoman Karsh reported the Clinton Guild had their reorganizational meeting and they are setting up their upcoming year. She will have more information next meeting.
- 2. Economic Development Committee meets tomorrow. For the last month the committee has been working with the website / newsletter committee to talk about ways to modernize the website to make it friendlier to the consumers. Councilwoman Karsh introduced John Creech, the website sub-committee leader for the Economic Development Committee who has been working hard on this project.
- 3. Councilwoman Karsh said the Economic Development Committee, is also working on the Mayor's Wellness Campaign and looking to partner with the other committees and commissions. The Committee will be reaching out to other outside municipal committees also to help with some of the programming for this project. This campaign will take place over the entire year.

Councilwoman Dineen

- 1. Councilwoman Dineen reported that Buildings and Grounds committee met last week to discuss the energy auction that was passed earlier tonight.
- 2. The Buildings and Grounds committee decided to renew the annual maintenance contract for the clock on Main Street in the amount of \$500. The cost went up a bit but there are no other vendors in the area to choose from.
- 3. Discussion took place concerning the facility use form at the Buildings and Grounds meeting. More information will be forth coming.

4.. Land Use Board met last Tuesday. They heard and approved a waiver for a site plan at 12 East Main Street. A Tae Kwon Do business went into the space where the book shop previous was and would like to put in a café coming in from the Old Route 22 side.

Councilwoman Intrabartola

- 1. Councilwoman Intrabartola reported the Board of Health held their annual Animal Rabies Clinic on January 26, 2019. There were 261 dogs and 43 cats that were vaccinated.
- 2. The Board of Health had their annual meeting following the rabies clinic. Beth Sosidka, a former council member, joined the Board of Health committee. Discussion was made to eleviate some of the burden for Cecilia Covino, Town Clerk, who has been handling the responsibility of replacing the doggy baggies in the stations around town. Some members have offered to take on that responsibility. There are three stations around town, one by Hunts Mill Park, another by the Pony Truss Bridge and the last at the community center. The one by the community center is on the fence of the ball field and is the least one used. The Board of Health members believe it may be because it is the only one without a garbage receptacles right next to it. However there are garbage receptacles by the park which is not far from the ball field. Councilwoman Intrabartola was recommending a garbage can be put by it or a possibility of moving the doggy station to another spot by the park. Mayor Kovach said there are three garbage receptacles around the park.

Deliberation occurring after a public hearing that may result in the imposition of a specific civil penalty or loss of a license or permit;
