#### **PUBLIC COMMENTS**

Mr. Prater also took this opportunity to explain the proposed enhancements JCP&L are working on for increased reliability and resiliency of the electric distribution system against severe weather and to reduce the number of customers affected by outages. Mr. Prater stated JCP&L is asking BPU for more latitude in trimming trees for more clearance, as trees are a major issue in outages.

Mr. Prater continued to inform Council and the public that JCP&L's Reliability Plus includes approximately \$400 million in targeted investments above and beyond its regular annual investments to enhance JCP&L's service reliability and resiliency which will estimate the initial increase on a monthly bill for an average user of 26 cents per month for the first six months up to \$1.89 by the end of the fouryear period. A public hearing will be held October 15 in Morristown for anyone interested in attending. Mr. Prater requested that the Town of Clinton, along with other municipalities, adopt a resolution in support of JCP&L's efforts.
