PRESENTATION TO COUNCIL BY WATER ENGINEERS

Water Engineer, Andrew S. Holt, P.E. and Client Manager and Project Coordinator, Eleni Giannikopoulos of Suburban Consulting Engineers, Inc. came before Council tonight and presented a clear and concise 2017 Water Rate Analysis Report. There are numerous capital and operational needs of the Clinton Water Company and the need for a rate increase to raise revenue to deal with the issues is inevitable. Mr. Holt and Mrs. Giannikopoulos explained the rather complex efforts that were undertaken to develop the proposed rate increase to fund Asset Management Plan (AMP). AMP is an accepted industry standard which consists of developing a plan to address long term water system reliability and sustainability and to stay in compliance with DEP regulations. A five-year plan of capital improvement projects was also laid out. Low interest funding is available.

Towns that are serviced by the Town of Clinton Water Company will be notified directly of a rate increase and a press release will be posted in the local newspapers.

A rate increase ordinance will be introduced at the meeting of February 14, 2017 with a public hearing on February 28, 2017. New rates will go into effect April, 2017.

Chief Matheis, aka Dog Warden,

said he thinks it's a great idea! Ms. Bittenmaster will attend a council meeting with information as to cost and her feelings about doggie waste stations.

3. Board of Recreation – has a new dynamic with new members that have joined the Commission! An incredible amount of enthusiasm and thank you to Sean Rogan for recruiting new members! Rosemary Pendergast remains the Chairwoman, Sean Rogan is the new Vice-Chairman and Nancy Smith remains Secretary. The Commission has many new ideas and wish to buy new equipment at the Community Center playground and a new sound system for the Center to show movies and have events. On the website, calendars will be updated regularly for the Community Center and ball fields. They are requesting additional funds in their budget. The Town Picnic is scheduled for June 10, the Senior Luncheon May 7 and this weekend, the Bonfire, January 28, 2017.
