PUBLIC COMMENT

Mr. Joe Piscopo from Lebanon Township introduced himself to Mayor and Council concerning his possibility to run for Governor of New Jersey in the 2017 gubernatorial election. He is going around the State seeing what people are concerned about. He was told property taxes are the main concern. He is an entertainer and is a host on radio station AM 970 which is a radio station focusing on conservative politics. Mr. Piscopo stated he has been interested for some time to run for an elected position to help the State of New Jersey. He spoke to Mayor and Council about his ideas if he ran for a position. He feels bringing revenue to the State is a major factor. Some issues he mentioned were trying to promote generic drug production in New Jersey with partnership with China: increasing manufacturing for distressed communities; eliminating state income tax for police, fire fighters, and teachers; using public-private partnerships to rebuild the state's infrastructure. These were some of his ideas and a few he has been working on already.

Mr. Piscopo said he was a former life-long Democrat but was going to run as an Independent. He mainly is addressing Mayor and Council to see what bothers them and what they need to help reduce taxes or anything else. He understands the ratio is mostly to the schools. People cannot live here with the property taxes the way they are. Many people are moving out after their children are finished going through the school system. Mr. Piscopo said he did talk previously with Mayor Kovach. Each person understands the taxes are mainly with the administration of the schools.

Mayor Kovach did say she sent out the two budget letters to the residents. Taxes are a huge thing. CMPTRA (Consolidated Municipal Property Tax Relief Aid) aid is less than \$8,000 which is less than ½ of a tax point for the Town of Clinton. We have an awesome school district but what do we do to reduce costs. As a resident and a Mayor she struggles to figure it out.

Councilwoman Sosidka stated that we are one of the highest unfunded pension States in the country and asked what he would do about that.

Mr. Piscopo said he had an idea but was controversial and voted down. First he said give police, fire fighters and teachers should not pay any state tax and then start negotiations from there. You should give the union something. He stated he is a very Pro-Union guy. Second, it is not mainly his idea but his colleagues say we need that North Jersey casino. Part of that revenue will go to funding the pension. Mr. Piscopo said most important factor is to create revenue.

Mr. Piscopo said bring filming into New Jersey would create revenue. Mayor Kovach said New Jersey is the worst for filming credits. She has sent New Jersey's legislature information from other state's legislature and nothing is done. Mr. Piscopo said it was terrible how the State raised the gas tax by \$.23. He said at least Governor Christie stopped the estate tax and gave roads \$400,000,000.

Mr. Piscopo thanked the Mayor and Council for listening to him and allowing him to explain his views on helping New Jersey become a sustainable state. He said New Jersey needs a conservation independent in Trenton. He thinks it can be done. Mr. Piscopo says if he does not decide to run he would like to at least present the initiatives. Mr. Piscopo is very proud of New Jersey and thinks each party has great ideas.

Mayor Kovach and Council thanked Mr. Piscopo for attending.

MAYOR'S COMMENTS

- 1. Mayor Kovach announced the Town of Clinton was named number one for the 2017 Best Community for Families in the State of New Jersey and Best in Hunterdon County according to the New Jersey Family Magazine. The Town is also in the running for top community in the northeast. This is a terrific recognition for the Town.
- 2. Mayor Kovach received an invitation from the Red Mill Museum inviting herself and Council to the opening reception for their Exhibition "Over Here, The New Jersey Home Front", a WWI Centennial Exhibition which the Town donated to. It will be held on April 6, 2017 at 6:00pm if anyone is interested in attending.
- 3. Mayor Kovach informed Council that Ella Haver who was a strong force behind the Jennie M. Haver Memorial Scholarship Fund has passed away at the age of 104. It is very sad but she lived a wonderful life.
