PUBLIC COMMENT

1. Four members of the Clinton Fire and Rescue Parade committee commemorating the 125th Anniversary of the Town of Clinton Fire Department and the 50th Anniversary of the Town of Clinton Rescue Squad which included Frank Setnicky, Rescue Squad Chief, Walter Dorf, Fire Chief, Mike Clancy, Fire Department, and Bill Wintermute, Fire Department. They came to officially invite the Mayor and Council to participate riding in the parade. Mayor and Council welcomed the invitation.

Mayor Kovach said the Town of Clinton will have two proclamations sent over to put in the History/Ad book.

Mr. Carberry said the Chili Cook-off was out of this world again that took place at the Rescue Squad this past weekend, April 22, 2017.

2. Mr. Harvey Finkle from the Clinton Book Store updated the Mayor and Council that the Farmer's Market will begin again for another season on May 7, 2017. This will run through October 2017. There will be a ribbon cutting ceremony at 9:00am on opening day. Also October 1, 2017 is the date for the Harvest Festival.

MAYOR'S COMMENTS

1. Mayor Kovach said she received a letter form the NJ State Police National Guard Camporee for anyone who would like to participate. The event is from May 19th, 2017 to May 21st, 2017 at the National Guard Training Center in Sea Girt New Jersey. If anyone is interested in participating you must respond by May 1, 2017.

PRESENTATION – Gilbert Andwati , Co-Founder of Hope For The Hurt Campaign

Mr. Gilbert Andwati introduced himself to Mayor and Council to speak to and explain what his campaign is about. He is a 22 year old from Kenya, Africa and when he came over to this country he had bullying issues in school and wanted to start something to help others. Mr. Andwiti said he is the president and co-founder of Hope for The Hurt Campaign.

The Hope for The Hurt is a youth advocacy campaign working its way up into a non-profit organization, the campaign began as an Instagram page, where people could vent about their sad and depressing moments. The more people vented about the painful moments in their lives the more they saw a community of support. The campaign addresses five critical issues which can lead to one another, or directly to suicide. Those issues are substance abuse, depression, anxiety, self-harm, and cases of bullying. Less than 10 years ago, suicide was the third leading cause of death for young teens and adolescents. Today, the second leading cause of death among ages 10-24 is suicide. Our goal is to grow a presence of awareness and grow a generation of leaders who want to help others. By raising awareness on these critical issues, Mr. Andwati explained the organization hopes to spread its presence and build bonds and partnerships.

Mr. Andwati said his main aim was to get a declaration signed from Mayor and Council for this cause. In a few weeks he will be going back to the United Nations to give his report of his progress.

Mayor Kovach and Council all felt this is a great cause and told Mr. Andwati he is doing a terrific job. They were very impressed for taking on such a big task at the age of 22. Mayor Kovach said she will have a proclamation written up from the Town.

PRESENTATION – Andrew Camp, MPA, Hunterdon County OEM: Point of Distribution (POD)

Mr. Jack Daniels, Housing/Code Enforcement Officer and Fire Official and member of the Emergency Management committee introduced Andrew Camp from the Hunterdon County Department of Public Safety Division of Emergency Management and Karen DeMarco from the Hunterdon County Division of Public Health to give the update to what the County's Office of Emergency Management is doing to prepare for any catastrophic situation.

Mr. Camp and Ms. DeMarco addressed Mayor and Council with a power point presentation about the importance of having Point of Distributions for the public to get the medications and supplies out during

those situations. The idea is to have the medication out in 36 hours. One Point of Distribution is at the County Offices on Route 12 and they are looking into using Spruce Run Recreation as another. What is needed to be a point of distribution is an easy entrance and exit that can handle many cars and pedestrians like an assembly line. Councilman Smith recommended to look into the Hunterdon County North Branch library in Town. They have the porch on both sides to go in and out. Mr. Camp responded saying that location may be small but can look into it.

Ms. DeMarco said what they would like from Mayor and Council is a Memorandum of Understanding (MOU's) which means the Town will agree to supply some items needed to have this work if the situation arises. Ms. DeMarco will get the list of items over to the Town and if there is anything the Town can say they will be responsible for that would be great. That list will be the Town of Clinton's MOU's. Ms. Demarco and Mr. Camp thanked Mayor and Council for listening and anything the Town can do to prepare for an emergency situation would be great. They said hopefully we will never need it but at least we will be prepared.

Mayor Kovach and Council thanked them for the presentation and will do all they can to participate with the Office of Emergency Management to prepare for any emergency.

PRESENTATION – Marc Saluk, Hunterdon County Economic Development Director

Mr. Marc Saluk, Economic Development Director from the Hunterdon County Department of Planning Economic Development and Land Use addressed Mayor and Council about the updates on the current initiatives for Hunterdon County. One of the main concerns his department is looking into is the fact Hunterdon County population is aging and declining rapidly for a while. It is the oldest county in the State. Mr. Saluk said he is looking into creating opportunities for the young people to show them their advantages to staying in Hunterdon County. Mr. Saluk said he has only been in this positon for one year therefore all programs are in the beginning phase. Since just beginning, there could be a lot of partnership with the Clinton area to develop initiatives.

Mr. Saluk said he wants to build reasonable and appropriate programs for Hunterdon County. Some ways are small foot print projects such as IT and research and development, etc. Through these projects try to show opportunities to the students in schools by taking them into some of the big companies in our area like the Exxon Research and Development and other industries. Show the students there are many job opportunities right in their own backyard. Take the students into the business and see what they actually do. Hopefully start some overlap which may lead to internships, semester long projects between business and schools and other things. This will make the students aware what is here.

Mr. Saluk explained one area is the entrepreneurial initiations to keep all the innovators in Hunterdon County and partner with them for long term growth. This means to try to develop programs that engage the community. One such project is this weekend called Hackathon where coders, programmers and software designers come together for 24 to 48 hours to make their ideas a realty. There are awards and prizes given out. Mr. Saluk said this event has brought many people together who did not realize how many others are interested in the same field and the resources that are out there in their own community. This is just the start of building programs and connections in other business areas in the community. Mr. Saluk said he is in the process of creating the Economic Development web site. This will have information about all the communities such as what they are trying to bring into their community. Mr. Saluk thanked Mayor Kovach and Council for listening to him and would love their input in the future.

Chief Brett Matheis

One is for professional fire departments and one is for volunteer departments. According to their records neither department in the County meets the state's standards. They say it is not a problem. They are looking into where departments will not be able to have volunteers and moving more towards paid staff. The Fire Chief Association is looking to have paid staff in some sites throughout the County. The problem with volunteers is the extensive training they need to go through. The point of this is to look into ways to handle the diminishing supply of volunteers for the future. Councilman Pendergast said it was a very interesting meeting and more information will be coming.

2. The Waste Water Treatment Plant's filter building will be starting structural and electrical updating. The engineer will be going through the entire building to get it up to shape. The permit was accepted and passed the inspection. The Sewer staff works very hard to keep everything up to par.
