PUBLIC COMMENT

Mr. Mark Desire, Mayor of High Bridge, addressed Mayor and Council concerning the resolution which was passed to cancel the sewer contract between High Bridge and the Town of Clinton five years from the date of resolution. Mr. Desire was not aware of this since it was not on the agenda. He said he did not feel there was enough sunshine notice. He stated he would have attended that council meeting if he would have known. Mr. Desire said the Town of Clinton refused to have their attorney look at the records on how the billing is determined. The people affected by this are the High Bridge residents, the two High Bridge schools, Voorhees High School, NJ Water Authority, Spruce Run Recreation area and Voorhees State Park. All part of the High Bridge capacity. High Bridge does not have the space to build their own sewer treatment plant and the Department of Environmental Protection may not approve it anyway. With the spirit of cooperation we should all work together. It takes both sides. He brought two members of their council with him tonight. They were Chris Zappa and Karen Scarcia. All members very much would like to work this out He asked Mayor and Council to discuss other options in this matter to come to a resolution.

Mayor Kovach commented that the Town does not disagree. Mayor Kovach explained to Mr. Desire the Town did not want to pass the resolution however there have been many meetings with High Bridge members to discuss the issues going on with how the Town of Clinton was billing High Bridge for the service of using the Town's sewer treatment plant. The Town's books have always been open for High Bridge to review. The Town auditor came in and did a full audit of the files. High Bridge has received a copy of the audit each year. Mayor Kovach has had conversations with Clinton Township Sewerage

Authority and we are now in a better understanding with them. Our Attorney reached out to High Bridge attorney to resolve this. She explained that High Bridge's business administrator and their attorney gave the impression there was no conversation to be had. Message was nothing was going to be discussed. One meeting was scheduled and was only cancelled the night before the meeting was to take place. The Town has been trying to work with the representatives of High Bridge for over three years on this subject. The Town has done all they could at this point which lead up to passing the resolution to cancel their contract.

Mr. Desire was not aware of that cancellation. Mr. Desire has said he has not received any of those audits.

Mr. Richard Cushing, Town Attorney, thanked and welcomed Mr. Desire for coming. Mr. Cushing said it would be in every ones best interest to resolve the dispute. If interested the Town would be very interested. Both sides would pay many legal fees if not. He went on to explain to Mr. Desire that was not the correct facts of the events leading up to the cancellation of the sewer contract. Mr. Cushing went on to explain the details that occurred for the period of about three years. During that time High Bridge decided to bring suit to the Town of Clinton. Arbitration was also started. This action caused the Town to endure extra costs which could have been avoided. What the Town was saying is if you do not want to work with the Town then you can go on your own way. Mr. Cushing told Mr. Desire he was very glad he was here and that he is willing to try to get this problem resolved. Mayor and Council would like to do the same. Mr. Cushing said let's get a commitment to get together to start the process. Mr. Desire agreed.

Mayor Kovach added the arbitration cost the Town \$7000.00 which could have been avoided if High Bridge would have worked with the Town to come to some type of agreement. Mayor Kovach also said she was very happy to see Mr. Desire here and looks forward to working with him and his staff to try to work to an agreement.

Councilman Smith stated these problems were created by a prior administration. Three years since Mr. Smith has been on the administration the Town has worked diligently to get this resolved.

Mr. Chris Zappa introduced himself to Mayor and Council. He said he is new to the council at High Bridge. This is his second year. He ran for office to help with issues such as this and to serve the people. This problem existed before he came on council but wants to get it resolved before his term is up. Mr. Zappa said he would very much also like to work this out. Mr. Zappa stated he will be involved in the meetings and help come to an agreement.

Mayor Kovach, Council, and Mr. Cushing thanked Mr. Desire, Mr. Zappa, and Ms. Scarcia for attending tonight's meeting and look forward to meeting with them to resolve this.

REPORTS FROM COUNCIL & TOWN OFFICIALS

Councilman Smith

- 1. Councilman Smith reported that as of January 1 there has been four water main breaks so far. With the dropping of temperatures we should expect more.
- 2. Councilman Smith stated he received in the mail a flyer from a company offering insurance for water line service. The flyer says it will cover the water service line from the house to the curb for normal wear and tear however will not cover things such as a rock or tree roots rupturing the line or anything else. Normal wear and tear takes years and years to occur which his recommendation was it is not worth receiving. Councilman Smith recommend putting a notice in the next newsletter to warn the public of this.
- 3. Councilman Smith reported the Town of Clinton Rescue Squad's responses were up by 15% in 2015 from the prior year. The calls were up by 395. The Rescue Squad has mailed out a flyer to recruit volunteers. The Rescue Squad is in need of more volunteers most of all the senior people. There are a lot of young people but they would benefit from the guidance of the older people.
- 4. Councilman Smith reported the Roads Committee met and decided as of this time to hold off on the issue of Georges Place extension. The Committee is looking into another approach.
- 5. Councilman Smith reported the Roads Committee discussed the Raritan River Stream Classification and the Wargo Property (A & P).

6. Councilman Smith stated that the Lower Center Street and the Municipal parking lots will be repaved sometime in the near future. The municipal parking lot is no problem. That can be done in sections and will not be a total rebuilt paving job. However, the Lower Center Street parking lot will have to be closed during the entire repaving job. The time frame for completion since it will be a complete overall will be about one week. Therefore the residents effected must have at least one month notice before the work is to be started.

Councilman Pendergast

- 1. Councilman Pendergast reported the Clinton Fire Department was wondering about the status of the Knox Box Ordinance.
- 2. Councilman Pendergast reported for Buildings and Grounds that the maintenance on the Municipal Building is 98% complete. The top step for the entrance of the building facing Leigh Street which is not used does not meet safety requirements. It will be fixed to meet code. Councilman Pendergast said the contractor has done a fantastic job. Mayor and Council all agree. The municipal building looks beautiful.
- 3. Councilman Pendergast reported the Roads Committee discussed the brush schedule for 2016 and decided to leave it the same for the public. However the Road's Department will make two swings through the neighborhood instead of one for those residents who put their brush out after they see the truck the first round.

1. Ms. Burgess announced Cecilia Covino, Clerk, is a grandma again. Ms. Covino's daughter delivered a baby girl Monday night, January 11. Both mother and baby are doing fine.
