Mayor Janice Kovach called the meeting to order at 7:30 p.m.

PUBLIC COMMENT

- 1. Town of Clinton First Aid and Rescue Chief, Frank Setnicky, addressed the Mayor and Council to clarify a press release that was sent out stating that the Clinton Rescue Squad and the High Bridge Rescue Squad are going to merge in the near future. The press release made it seem like this was a done deal but it is not. Mr. Setnicky said there has been talk about it and it looks like it will happen in the future. The Clinton squad has 60 to 70 volunteers and High Bridge does not have that many. He feels we can pool our resources which will allow us to cut back on some resources like ambulances. High Bridge will benefit from the training that the Clinton squad has. Both squads will benefit. The Clinton squad covers five municipalities in the area. The area has grown substantially, as of today Mr. Setnicky stated there are about 3000 calls compared to when he started in 1984 where there were only about 600 calls. There is no time frame for this consolidation. As of now there is not much to report on this matter. It was talked about many years ago and High Bridge approached Clinton recently to discuss the consolidation of the two squads. Mr. Setnicky said it will be close to a year before anything happens.
- 2. Mayor Kovach introduced officially, Brenda Karcher, the new employee at the Waste Water Treatment Plant. Mayor and Council welcomed her and thanked her for coming in and meeting everyone.
- 3. Mr. Ken Fisher, 71 Leigh Street, brought up the issue of the Interstate Route 78 noise and water pollution. He said this past Easter Sunday he had the opportunity to speak to a Department of Transportation (DOT) sub- contractor who gave him more information. This sub-contractor mentioned that his thoughts on the possible problem is the water bulk heads. This is where Route 78 transitions onto an overpass. He believes these bulk heads may have been reduced in size due to settling, time, or maybe the tapering did not get done correctly. The sub-contractor said there would be two options: 1. put down fiberglass coating and seal it with black top over it and will meld to the concrete; 2. use high performance

material to reduce the sound. Mr. Fisher said the contractor would like to come out and take a look at this overpass. The main point is the pounding of the traffic on Interstate Route 78. The contractor told Mr. Fisher that once the job is complete and finalized with DOT the sub-contractor is given a punch list. When that is complete the sub-contractor is done. Mr. Fisher was told after the final payment is paid the only person who can change anything would be the Mayor of the Town.

Mayor Kovach responded that was interesting because that is not correct according to DOT. Mayor Kovach has had multiple conversation with Meredith Hammond, Ahmat Jahn, Deputy Commissioner, Engineers, Director of Government Relations, and the Governor's office. She tells the governor's office and they tell DOT and then get a call that whatever needed to be done was done. Mayor Kovach said again she is not the person to get it done. Mayor Kovach told Mr. Fisher to give her his number or she will give him her number to help get something done. Mayor Kovach is willing to help in any way she can.

Mr. Fisher also mentioned about the jake brake noise from trucks on Interstate 78. The correct term now for jake brake is brake retard. Older trucks are using the brake retard instead of the brake to slow down. The new diesel trucks are so quiet you cannot hear the brake retard. Mr. Fisher asked how we regulate that. Mr. Fisher also mentioned that debris is still coming down onto Leigh Street from the overpass of Interstate 78. He is concerned that one day someone is going to get hurt.

MAYOR'S COMMENTS

- 1. Mayor Kovach reminded everyone to file their Financial Disclosure Statements. They are due April 30, 2019 and there is a \$100 a day fine for not each day not filed.
- 2. The Highlands Council recently introduced an Initial Assessment Grant Program which awards up to \$50,000 to communities to provide economic initiatives.
- 3. Officer Robbins is going to receive a Meritorious Service Award at the upcoming Hunterdon County 200 Club Valor & Merit Awards Ceremony. Congratulations to him for that and also for becoming a father back in December 2018.
- 4. Mayor Kovach and the Council received with a heavy heart a letter of resignation for Chief Brett Matheis. He will be retiring on June 30, 2019. Chief Matheis has been the chief for twenty one and a half years with the Town of Clinton. Chief Brett Matheis will be missed. A motion was made with regret by Mr. Smith, seconded by Mr. Humphrey to accept Chief Brett Matheis' letter of resignation.
- 5. Department of Environmental Protection (DEP) is re-categorizing 729 miles of river and streams to C-1 classification. This will include the South Branch Raritan River and also the Beaver Brook. This will have a potential impact on our sewer system as well as the two new developments coming into town. DEP has extended the comment period to June 3, 2019. We are working with the county to come up with some supporting documentation for them to look at before going through with this. The small communities are the ones mostly affected by this. Mayor Kovach said she will prepare a resolution for the next meeting in May to send down to DEP.
- 6. Mayor Kovach wanted to clarify rumors going around that she has been reaching out to mayors of other communities to tell them not to settle their police contracts. It originated in Flemington which is why she went to Flemington's council meeting last night to stop the rumors. Mayor Kovach said she has not and will not, it is not her place, have conversations with other mayors about how they should handle their contract negotiations. Contract negotiations are specific to each community and it is not her place or her business to say what/how to do it. Mayor Kovach addressed Sergeant Cory Kubinak to let Hunterdon

County PBA know that she has made it public in two locations that she is not saying for other towns not to settle. Sergeant Cory Kubinak responded that the Hunterdon County PBA is aware of that fact.

2. Communications Committee met Wednesday, April 10, 2019. They moved to another vender for the newsletter and are very close to approval. Hopefully by the next council meeting the committee will have a resolution for Mayor and Council. They also are getting close to determining a new web site vendor with a new design and also a new e-mail system for the Town.

Councilman Smith

1. The water committee had a meeting where information went out through the e-mail notice system to let the residents know about the West Main Street Water Main and Sidewalk Replacement project to be done in from of the Clinton House down to the Red Mill Museum. The project will take place over a period of a month. There will be a lot of traffic issues. Also another notice will be going out the end of summer about the water main replacement for the remainder of West Main Street. That project will definitely cause major traffic problems not only for the people living on West Main Street but also for the residents on the west side of town trying to come in and out. Also the Department of Transportation requires all work that is done on their roads to be done at night however the water committee would like them to change that for this project. The noise at night will be too much for the residents on West Main Street. There is about 30" of concrete the contractor will have to get through with jack hammers. The noise will be tremendous. There will be plenty of signage around town and along the entrances in and out of town when the project starts.

Mayor Kovach said that Halstead Street is an emergency route right now and asked Sergeant Kubinak how can it temporarily not be an emergency route during this project. Sergeant Kubinak responded by saying DOT needs to make that decision.

Councilwoman Karsh

- 1. The Clinton Guild is having a "Girls Night Out" on May 9, 2019.
- 2. The Max Challenge event concluded last week. Ms. Karsh was not there but Mayor Kovach was. Mayor Kovach said it had a very nice turnout and went very well.
- 3. The Clinton Guild is also putting out an e-mail blast to the businesses about the water main project that Councilman Smith spoke of.
- 4. Economic Development Committee submitted the grant request for assistance with the cost of the overhaul the Town website.
- 5. The Communication Committee is putting together an outreach program for all the businesses in Town. Anyone interested in participating let her know. Mr. Humphrey said the new newsletter vendor is asking for a letter to go out to all the business when it gets up and running for them to put ads in it. Ms. Karsh will absolutely help in that matter.

Councilwoman Dineen

- 1. Arbor Day is officially this Friday, April 26 but the Town celebrated it on April 17, 2019 due to the spring recess for Clinton Public School. It was well attended.
- 2. The Shade Tree Commission will do their annual "walk about" this Thursday at 5:00pm. They will walk around town and create a list of trees that need removal, trimming, or pruning. The Commission will determine what they can do given their budget. They will then come up with their maintenance plan for the rest of the year.
- 3. The Land Use Board's next meeting is May 7, 2019.
- 4. Building and Grounds will meet on May 6, 2019.

Councilwoman Intrabartola

1. The Historic Commission did not meet so nothing to report. The historic walk though was a huge success.

Mr. Walter Wilson, owner of 19 West Main Street, wanted to thank Mayor and Council for letting the Special Olympics use the Community Center for their basketball practice. Special Olympics had three county basketball teams. Two of the teams made it all the way to state finals. Mr. Wilson was very grateful.

Mr. Wilson also mentioned the water main replacement project which is going on in his area where he lives in Clinton Township, Heather Hill Way. All is going well. He said the main part of the replacement went great. It was easy to get in and out of his street.

Mr. Wilson commented on the Department of Environmental Protection C1 expansion that was mentioned earlier in the meeting. There is great development along rivers and streams. Without the regulations Clinton would not be here. Changing the reclassification under this C1 plan would hinder development in the future drastically. You do not disregard the environment. He agrees with the Mayor's comments from earlier that this reclassification would take away opportunities for river towns. Mayor Kovach recommends as a property owner for Mr. Wilson to send a letter to DEP as well. Mr. Wilson said he definitely will.
