ORDINANCE #16-01

CALENDAR YEAR 2016 ORDINANCE TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et.seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said final budget appropriations to 0.00% unless authorized by ordinance to increase it to 3.5% over the previous years final appropriations; and,

WHEREAS, a municipality may, by ordinance, bank the difference between its final budget appropriations and the 3.5% increase authorized by this ordinance when said difference is not appropriated as part of the final budget; and,

WHEREAS, the Town Council of the Town of Clinton, County of Hunterdon, hereby determines that this difference in the amount of \$106,774.89 that is not appropriated as part of the final budget shall be retained as an exception to the final appropriations in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

A copy of this ordinance will be published in the March 16, 2016 edition of the Hunterdon Review. A public hearing is scheduled for April 12, 2016.

REPORTS FROM COUNCIL

Police Chief Matheis

Chief Matheis reported that the Police Department is ready for Saturday, March 12th Run O' the Mill 5 K beginning at 8 a.m. and Sunday, March 13, St. Patrick's Day Parade! Street closures will take place, residents have been notified.

Councilman Smith

1. Roads – Mr. Smith distributed a DRAFT ordinance regarding the Georges Place Extension which has been re-written to protect the Town for insurance and costs. Upon Council's review,

- the ordinance will be introduced at the March 22 council meeting. Mr. Carberry commented that Council will be given the choice to rescind or amend the current ordinance or to adopt this new ordinance.
- 2. Van Cleef Engineering Firm is getting prices from contractors for the parking lot repaving. It may be possible for a contractor working on another municipal project that Mr. Clerico represents to "pony up" on this project. The Town is also applying for a Pedestrian Safe Grant Opportunity to purchase new signs that stand in the crosswalks for pedestrian crossing.
- 3. Buildings and Grounds is overseeing the final steps of the Municipal Building renovations and has compiled a punch list for the contractor to complete such as the front steps and a leak in the roof. Also seeking bids to move the electrical panel out of the basement where flooding occurs which would have to be completed on weekends when the office is closed. The first bid came in at \$35,000, other bids are being sought.
- 4. Spring Clean Up will begin April 4, leaves only; May begins chipping once again. Electronics Clean Up at the County facility on Route 12 will be held Saturday, April 9, 2016 from 9 noon. Mr. Rylak asked about disposing of old air conditioners, freon must be removed and a sticker proving it and then it can be out with the regular trash. Mr. Rylak also commented on the options for the proposed Georges Place Extension ordinance, one option to rescind, one option to amend and a third option to let the current ordinance remain.

Councilman Pendergast

- 1. Clinton Fire Department has posted no parking at the fire house this coming Saturday or Sunday because of the scheduled events, the 5K and the Parade.
 - Eagle Scout project to be undertaken by Jeremy Decker who will be restoring the shed in the back alley of the fire department lot.
 - Clinton Fire Department has requested assistance from Union Township to fund a service truck, estimated cost \$50,000 to \$75,000. Union Township does give a small stipend to Clinton for responding to calls but Clinton is now looking for a larger stipend. Awaiting response.

Councilman Rylak

1. Smart Growth Committee – Mr. Rylak proudly modeled the new Conservancy shirts now available! The Smart Growth Committee has formed this conservancy and will begin by taking small steps to improve the "look" of Clinton. They will be sprucing up the five" Welcome to Clinton" signs and doing some plantings. Mr. Gulshan Chhabbra of the Holiday Inn is interested in funding some new shrubbery. Mr. and Mrs. Madden of Clinton are joining the group. Mr. Rylak also reported that Roger Mellick of the Land Use Board is a member of the New York Conservancy and will be a valuable participant to Clinton 's endeavor. Mr. Rylak then gave a brief history on the origin of the Central Park Conservancy. Ms. Sosidka asked if the Town could solicit funds and the response was no we cannot.
