PRESENTATION – HUNTERDON COUNTY VETERAN SERVICES

Sabrina Baarda, Veterans Services Coordinator, attended this evening to educate Council and the public of the services offered. Ms. Baarda helps veterans and their families navigate through the VA system, helps caregivers coordinate services for veterans, sees to it that the cemetery plots have an American flag, works closely with George Wagner and the Hunterdon County Freeholders and the medal ceremonies for deserving veterans. Outreach programs with representatives from the Lyons Hospital are also very helpful. These are just a few of the works of Ms. Baarda and her department. Mr. Smith asked about veteran ID cards through the County Clerk's office and Ms. Baarda assured him they are available to vets. These ID cards can help vets get discounts at some big box stores and other locations. It is recommended when the vet gets a card that they register with the County Clerk in case the card is ever lost it can be reproduced easily. Information is posted on the Chamber of Commerce website and Mayor Kovach asked that a hyperlink be put on the Town's website directing folks in need.

ORDINANCE AMENDING CHAPTER 73 ENTITLED "FEES" OF THE GENERAL ORDINANCES OF THE TOWN OF CLINTON, COUNTY OF HUNTERDON, AND THE STATE OF NEW JERSEY BY CREATING A NEW SECTION ENTITLED "PUBLIC MAINTENANCE OF PRIVATE ROADS"

WHEREAS, the Road Committee of the Town of Clinton has recommended to the Mayor and Council that Chapter 73 of the Code of the Town of Clinton be amended to include fees governing applications for private road maintenance and/or repairs to be conducted by municipal employees; and

WHEREAS, N.J.S.A. 40:67-23.1 permits the maintenance and/or repair of qualifying, private roads when certain conditions are met and memorialized via ordinance specific to the road(s) in question; and

WHEREAS, in an effort to assist owners of private roads while not adversely affecting the municipal budget, the Mayor and Council have decided to perform certain maintenance and/or repair work on private roads so long as all of the costs associated with said work is borne by the owner(s) of the private road(s).

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Clinton, the County of Hunterdon, that Chapter 73 entitled "Fees" of the Code of the Town of Clinton ("Code") is hereby amended as follows:

Section 73-3 of the Code of the Town of Clinton entitled, "Schedule of Fees and Charges" is hereby amended as follows:

L. Public Maintenance of Private Roads

Activity

Application for Maintenance and/or Repair

Fee \$250.00

AN ORDINANCE AMENDING ORDINANCE #11-03 BY CHANGING THE CONDITIONS FOR MUNICIPAL MAINTENANCE OF GEORGES PLACE EXTENSION

WHEREAS, on February 22, 2011, the Mayor and Council of the Town of Clinton adopted Ordinance #11-03 which authorized the Town to perform maintenance and repair on Georges Place Extension, a private road under the jurisdiction of the Pine Ridge Homeowners Association, in accordance with N.J.S.A. 40:67-23.1; and

WHEREAS, this Ordinance #11-03 set the parameters and conditions of said maintenance and repair should the Town undertake these actions; and

WHEREAS, the Town of Clinton Road Committee has evaluated the cost and of maintaining and/or repairing Georges Place Extension and the potential costs of maintaining other private roads within the Town; and

WHEREAS, the funds available for municipal operations have been significantly curbed while the actual costs for municipal operations have significantly increased, thereby providing a reduction of funds available for discretionary municipal operations; and

WHEREAS, it is the desire of both the Pine Ridge Homeowners Association and the Town of Clinton to further clarify the roles and responsibilities of each party should road maintenance and repairs actions need to occur; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Town of Clinton, County of Hunterdon and State of New Jersey hereby amend Ordinance #11-03 as follows:

- 1. Only when approval is granted by the Town of Clinton Road Committee, the Department of Public Works is authorized to maintain and/or repair Georges Place Extension by spreading asphalt on the road as needed to prevent erosion. Said repairs and maintenance will be provided only when the following requirements are met:
 - a. An application requesting maintenance and/or repair to the road must be submitted by the Pine Ridge Homeowners Association to the Town of Clinton Road Committee along with the applicable application fee as dictated in Chapter 73 of the Town of Clinton Municipal Ordinances, for their review and approval. The form of application will be created by the Town of Clinton and provided to the Pine Ride Homeowners Association for their use. No requests for repair and/or maintenance services will be considered/or provided on Georges Place Extension without express written consent from the Pine Ride Homeowners Association. Only after approval is granted by the Road Committee can work proceed.

- i. A certificate of insurance meeting the minimum coverage limits must be provided along with the application. Additionally, the Town of Clinton <u>must</u> be named as an additional insured on said certificate.
- ii. The Pine Ridge Homeowners Association and its members must indemnify and hold harmless Town of Clinton, and provide proof of such action in writing along with the application requesting maintenance and/or repair. This indemnification obligation shall survive the expiration of the work being performed.
- b. The total hourly compensation costs for all employees assigned by the Public Works/Business Administrator to the road repair and/or maintenance request will be borne by the Pine Ridge Homeowners Association. This includes, but is not limited to current salary, health insurance, pension, and other applicable fringe benefit costs.
- c. The total hourly vehicle and/or equipment charges for all vehicles and/or equipment utilized to perform the maintenance and/or repair will be borne by the Pine Ridge Homeowners Association. Said rates will be based off of the Federal Emergency Management Agency's (FEMA) "Schedule of Equipment Rates", as amended, which can be viewed directly on FEMA's website at https://www.fema.gov/schedule-equipment-rates.
- d. The total material cost for all materials needed to perform the maintenance and/or repair will be borne by the Pine Ridge Homeowners Association. Said materials can include, but not be limited to, asphalt (cost per ton), "tac-coat", crack sealer, and the like.
- e. Upon completion of the work, the Town of Clinton will provide a detailed invoice of the costs listed above. The Pine Ridge Homeowners Association agrees to make payment to the Town within thirty (30) days after receiving said invoice.
- 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
- 3. This Ordinance shall take effect upon final passage and publication according to law.
