# **ORDINANCE REGARDING MUNICIPAL PARKING LOT NO. 7**

WHEREAS, parking spaces in the Town of Clinton are a limited resource; and

**WHEREAS**, the Mayor and Council are concerned that a further reduction of available parking by motorists leaving their cars in lots for excessive periods of time will adversely affect traffic as people search for available parking spots creating a nuisance and a traffic hazard; and

**WHEREAS**, the Mayor and Council have determined that restricting the time limit on parking in Municipal Lot No. 7 will improve traffic flow and safety.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Town of Clinton, the County of Hunterdon, that Chapter 136 entitled "Parking" and Chapter 135 entitled "Vehicles and Traffic" of the Code of the Town of Clinton ("Code") is hereby amended as follows:

**SECTION 1.** Section 136-9 of the Code of the Town of Clinton entitled "Public parking permitted" is hereby amended and supplemented as follows (Additions indicated in boldface and italics *thus*; deletions indicated with strike-through thus):

Public parking is permitted in marked and numbered spaces on the north side of the property (to the left of the Fire Department garage bay doors on the Center Street side). All vehicles must park in these designated spaces only and between the lines provided. Parking is permitted *in accordance with the provisions of § 135-26, entitled "Time Limit Parking"*. 24 hours a day.

**SECTION 2.** Section 135-26, Schedule IV of the Code of the Town of Clinton entitled "Time Limit Parking" is hereby amended and supplemented as follows (Additions indicated in boldface and italics *thus*; deletions indicated with strike-through <del>thus</del>):

**SECTION 2.** All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**<u>SECTION 4.</u>** This Ordinance shall take effect upon final passage and publication according to law.
