ANIMAL CONTROL OFFICER - NATE BARSON

Nate Barson was asked to attend this evening's meeting to address the feral cat situation in Town. Mr. Barson explained the process used in Lambertville has been very successful. It is referred to as TNR, trap, neuter and return. If the animal control officer is called to pick up a cat, it must be boarded for seven days at \$15 per day, then euthanized by a vet \$35, and cremated \$10 costing approximately \$140 per cat. The TNR method to spay, vaccinate, clip ears and possibly micro chip can cost \$50 to \$60. An animal going to the vet for spaying can cost \$300 but through the program can cost \$50. Young healthy cats are fixed and put up for adoption. If a person is found to be feeding the feral cats, they will be asked to pay for the neutering but if they cannot afford it arrangements can be made with the municipality. Chief Matheis said the Mayor and Council need to decide on a policy and there is money in the animal control account to cover some of these costs. Mr. Pendergast made a motion seconded by Mr. Carberry, to try the TNR method for a period of time.

WHEREAS, pursuant to N.J.S.A. 40A:12A-6, the governing body of the Town of Clinton ("Town") is authorized to direct the Land Use Board of the Town of Clinton ("Land Use Board") to undertake a preliminary investigation in order to determine whether a certain area within the Town would qualify as an area in need of redevelopment pursuant to the criteria set forth in N.J.S.A. 40A:12A-5; and

WHEREAS, the Legislature amended the Local Redevelopment and Housing Law on September 6, 2013 to expand and clarify various provisions of same; and

WHEREAS, as a provision of the amendment to N.J.S.A. 40A:12-6, the Legislature has directed that the resolution authorizing the planning board to undertake a preliminary investigation shall state whether the redevelopment area determination shall authorize the municipality to use all those powers provided by the Legislature for use in a redevelopment area other than the use of eminent domain ("Non-Condemnation Redevelopment Area") or whether the redevelopment area determination shall authorize the municipality to use all those powers provided by the Legislature for use in a redevelopment area, including the powers of eminent domain ("Condemnation Redevelopment Area"); and

WHEREAS, the Town of Clinton does not intend to use all the powers provided by the Legislature for use in a redevelopment area, and specifically, the Town of Clinton will not use eminent domain; and

WHEREAS, the Mayor and Council desire the Land Use Board to conduct such a preliminary investigation relative to certain properties located within the Town, more specifically identified as Block 11, Lots 15.01 and 17, Block 23, Lots 13 and 13.01, A PORTION OF Block 24, Lot 2, Block 24, Lots 1, 3, 6 and 8, A PORTION OF Block 25, Lot 8, and Block 25, Lots 15, 16, 17, 18, 19 and 20, as shown on the Official Tax Map of the Town of Clinton (the "Property").

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Town of Clinton, they being the Governing Body thereof, as follows:

- 1. The Land Use Board of the Town of Clinton is hereby directed to conduct a preliminary investigation to determine whether the aforementioned property, or any portions thereof, constitute an area in need of redevelopment according to the criteria set forth in N.J.S.A. 40A:12A-5:
- 2. The Land Use Board of the Town of Clinton is hereby directed to conduct a preliminary investigation of the aforementioned Property, in accordance with the requirements set forth in NJ.S.A. 40A: 12A-6, more specifically, to prepare a map showing the boundaries of the potential area in need of redevelopment and locations of the various parcels of property included therein, with a statement setting forth the basis for the investigation appended to the map; to specify a date for a public hearing for the purpose of hearing persons who are interested in, or would be affected by, the determination that the delineated area is an area in need of redevelopment; to give notice of said hearing pursuant to the hearing notice requirements set forth in N.J.S.A. 40A:12A-6(b)(3); to hear and receive into the record any objections to such a determination that the proposed property be designated an area in need of redevelopment; and
- 3. After completing its hearing on the matter, the Land Use Board shall recommend that the delineated area, or any part thereof, be determined, or not be determined, by the Municipal Governing Body to be an area in need of redevelopment.

CAPITAL ORDINANCE OF THE TOWN OF CLINTON SEWER UTILITY, IN THE COUNTY OF HUNTERDON, STATE OF NEW JERSEY, AUTHORIZING THE MAKING OF IMPROVEMENTS IN, BY AND FOR THE TOWN OF CLINTON SEWER UTILITY AND APPROPRIATING THEREFOR THE SUM OF \$40,000.00 FROM THE SEWER CAPITAL RESERVES FOR PURCHASE OF PUBLIC WORKS EQUIPMENT

BE IT ORDAINED, by the Mayor and Council of the Town of Clinton, in the County of Hunterdon, State of New Jersey as follows:

Section 1. The Town of Clinton in the County of Hunterdon, State of New Jersey, is hereby authorized to make the following improvements to the Sewer Utility in, by and for the Town, including all work, materials and appurtenances necessary and suitable therefore:

Section 2. The aggregate sum of \$40,000.00 is hereby appropriated from the Reserve for Purchase of Public Works Equipment within the Capital Improvement Fund of the Town of Clinton Sewer Utility to the payment of the cost of the improvements as described in Section 1 hereof.

Section 3. Said improvements are lawful capital improvements of the Sewer Utility having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget of the Town of Clinton Sewer Utility is hereby amended to conform with provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 5. This capital ordinance shall take effect after final passage and publication as required by law.
