• Outside/Gym Time: 2:40 – 3:40

• Snack Time: 3:40 – 4:00

• Library (if available): 4:00 – 5:00

After Care: 5:00pm – 6:00 pm (All Purpose Room)

Salary for adults in before/extended/after care = \$20/hour (Current salary of an After-Care provider at CPS during the regular school year is \$16/hour. Youth get \$12/hour)
Salary for youth in before/extended/after care = Minimum Wage

Before care cost: \$10/day flat rate

Regular Recreation: Approximately \$18 per day

Extended Day: \$60 per day After Care: \$10/day flat rate Total cost per day: \$98 per day Total cost per week: \$490 Discussion followed. The following items were presented

- 1. Banner to promote the Recreation Program
- 2. Advertising would need to start in January
- 3. Magic number 150 registrations, due to limited space at school
- 4. Staff ratio
- 5. Four or three weeks, dates and times
