Roadway Improvements

- Clinton Common Drive Entire length of roadway
- Plymouth drive Entire length of roadway
- Stratford drive Entire Length of roadway
- Lancaster drive Station 0+00 to Sta 1+70
- Central Ave Entire length of proposed improvement
- 20 ft wide Emergency access from end of Clinton Common drive to Central Ave.
