PUBLIC COMMENTS

George Tiboni, West Main Street, asked what is the plan for the old bank building on the corner of Leigh and Main Street? An IT Company recently purchased the building and is restoring the front to the original façade. The building will have about 30 employees. An extensive exploration of the building is taking place, old storage rooms, closets, etc. and many old bank records have been uncovered dating back to the 1800's. The deed to the Leigh Mansion has also been found. Many items of historic paperwork are being given to the Town.

MAYOR'S COMMENTS

- 1. Clinton Township Sewerage Authority's dispute with the Town of Clinton Sewer Department has been settled and many thanks to former Mayor and Councilman, Robert B. Smith, for his years of negotiating with CTSA and High Bridge. The many meetings and sessions with the Judge, Mr. Smith was a valuable asset on behalf of the Town of Clinton. Thank you, Bob!
- 2. Mark from Citispot has a new documentary in the works and it is available on YouTube. Climate Change is the topic.
- 3. Governor Murphy gave his State of the State address and Liquor License Reform is a hot topic. The League of Municipalities is pushing for this which is of great importance to small communities.
- 4. Health benefits are still looking at a 23% increase and no resolution has yet to be had.

CLINTON FIRE DEPARTMENT

Fire Chief Jeff Hedden attended this evening's meeting along with fellow officers of the Clinton Fire Department, Jason Mayer, Chris Querry, Tim Vanselous and Jack Daniels, to make a presentation to Council regarding the need for a new fire truck. The town's 2001 American LaFrance engine is the first out of the station in response to a fire but the manufacturer went out of business in 2014 and replacement parts are hard to come by. The cost of a new fire engine truck could be as high as \$1,081,691 with \$520,000 for the chassis, although a pre-pay could save the department \$20,000. The quoted price is good for six months. There is currently only one company building fire engine trucks in the U.S., the department wants to get a 2026 Pierce Enforcer with a 1,000 gallon tank. Chief said it takes 38 to 40 months to build a truck. The men explained the design they are interested in and the necessities needed. Chief Hedden is asking the Town for a promise of down payment. Mayor Kovach explained that Council will begin the budget process next month and CFO, Kathy Olsen, is looking into obtaining state funding to help with the replacement of the truck.

PLAYGROUND PROPOSAL

Nicole Ayers, Chairwoman of the Playground Committee, updated Council on the recently completed action meeting. The budget is estimated to be between \$250,000 and \$300,000. The section of the playground for children 5 to 12 years old would be fully inclusive. The section for children 2 to 5 years old is fully inclusive at Clinton Public School. After meeting with four state vendors, the committee is recommending MRC Recreation of Sea Girt to provide the equipment, and offers free installation. Councilwoman Johnson secured a State Department of Community Affairs grant last year in the amount of \$70,000 and is working on doing the same again this year. Booster Club's next meeting is January 23, to continue discussions. At this time there is \$55,100 available for the project. Shade Tree Commission is looking at the health of the trees in the park to determine if any need to be removed. Councilman

Kashwick said they will have an easier time evaluating the trees once they start to bud. The Playground committee is also working with the water company to secure an easement.

WHEREAS, on April 28, 2021, the Mayor and Council of the Town of Clinton (Town) ratified the Collective Bargaining Agreement between the Town and the Teamsters Local 469 (Teamsters) via Resolution #84-21; and

WHEREAS, on August 24, 2022, via Resolution #125-22, Contract Amendment #1 was approved by the Town and Teamsters which made certain changes to the terms and conditions of the Collective Bargaining Agreement, specifically amendments to "Schedule A" by creating a new, separate rate of pay for employees that do not possess a CDL who are assigned to the Water/Roads Department without penalizing existing employees in this department who have obtained their CDL already; and

WHEREAS, on August 6, 2022, the Town received a letter from the Teamsters requesting the aforementioned Agreement be reopened for further changes to the terms and conditions of the Agreement; and

WHEREAS, after discussions, the Town and Teamsters have agreed to make the following changes to the existing Agreement:

- 1. Amend Article 24, entitled "Rates of Pay", and the respective tables located in Schedule's A-1, A-2 & A-3 to reflect the following:
 - a. 2023 Increase of \$5,000
 - b. 2024 Increase of \$2,000
 - c. 2025 Increase \$2,000
 - d. 2026 Increase \$2,000
 - e. 2027 Increase \$2,000
- 2. Amend the duration of the Agreement to run through December 31, 2027.

WHEREAS, the Town and Teamsters have executed a Memorandum of Understanding approving the attached changes; and

WHEREAS, upon adoption of this resolution,

- 1. All references to "Schedule's A-1, A-2 & A-3" in the Collective Bargaining Agreement shall now refer to the amended version referenced herein.
- 2. All references to the duration of the Agreement in the Collective Bargaining Agreement shall now refer to the amended expiration date of December 31, 2027
- 3. All existing terms and conditions not referenced in this Resolution shall remain in full effect and cannot be altered or amended without the mutual consent of the Town of Clinton and the Teamsters Local 469.; and

NOW THEREFORE BE IT RESOLVED, that the Mayor and Council hereby authorize and ratify the amendments to the Collective Bargaining Agreement between the Town of Clinton and Teamsters Local 469 as more fully described in the preceding paragraphs in this Resolution, which are expressly incorporated herein by reference.

BE IT FURTHER RESOLVED that the Town of Clinton shall enter into and execute an amended Collective Bargaining Agreement incorporating the amendments set forth in this Resolution and authorized the Town's Business Administrator to facilitate the execution of the new Agreement.

BE IT FURTHER RESOLVED that the provisions of this Resolution are expressly conditioned on Teamsters Local 469 having approved the aforesaid amendments to the Collective Bargaining Agreement, and the provisions contained herein shall have no force or effect absent such approval by Teamsters Local 469.

- 4. At least one (1) week prior to the time fixed for further consideration of this Ordinance for final passage, a copy thereof together with the notice of the introduction thereof and the time and place when and where the Ordinance will be further considered for final passage shall be mailed to every person whose lands may be affected by this Ordinance so far as may be ascertained. Said notices shall be mailed by the Town Clerk in accordance with the provisions of N.J.S.A. 40:49-6.
- 5. This Ordinance shall take effect immediately after final passage, approval and publication as provided by law.
- 6. All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

ORDINANCE AUTHORIZING ENFORCEMENT OF TRAFFIC REGULATIONS UPON THE PRIVATE OR SEMI-PUBLIC ROADWAYS AND PARKING AREAS WITHIN BLOCK 6, LOT 1.01 (82 WEST MAIN STREET)

WHEREAS, the Land Use Board granted approval to 82 West Clinton, LLC (the "Developer") pursuant to Resolution No. 2020-13 (the "Resolution") to develop Block 6, Lot 1.01 (the "Property") as a gas station with a Dunkin' Donuts store;

WHEREAS, the Developer and the Town of Clinton (the "Town") entered into a Developer's Agreement (The "Agreement") dated October 12, 2021 pertaining to the development of the Property; and

WHEREAS, a condition of the Resolution and the Agreement requires traffic enforcement be authorized upon the private or semi-public roadways and parking areas of the Property; and

WHEREAS, by email correspondence dated January 6, 2023, the Chief of the Town of Clinton Police Department recommended the application of the Title 39 to the property.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Town of Clinton, Hunterdon County, New Jersey as follows:

- 1. Pursuant to N.J.S.A. 39:5A-1, all applicable traffic and parking regulations provided for under Subtitle 1 of Title 39 of the Revised Statutes of the State of New Jersey shall be enforced by the Town of Clinton's Police Department upon the private or semi-public roadways and parking areas within the boundaries of the property identified as Block 6, Lot 1.01 on the official tax map of the Town of Clinton.
- 2. All signs, posts or other necessary materials utilized for traffic and parking control shall be installed and maintained exclusively by the owners and/or operators of the lot identified as Block 6, Lot 1.01 on the official tax map of the Town of Clinton and conform with the current Manual on Uniform Traffic Control Devices pursuant to N.J.S.A. 39:4-198 and N.J.S.A. 39:4-183.27.
- 3. Any article, section, paragraph, subsection, clause, or other provision of the Code of the Town of Clinton inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.
- 4. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.
- 5. This ordinance shall take effect upon its passage and publication and filing with the Hunterdon County Planning Board, and as otherwise provided for by law.

ORDINANCE GRANTING EASEMENT PERMIT LOCATION OF CERTAIN STRUCTURES ON TOWN-OWNED PROPERTY (BLOCK 29, LOT 8)

WHEREAS, Peter Ochs and Laura Chambers Ochs (the "Property Owners") own certain property located at 36 Haver Farm Road, Clinton, New Jersey, which is designated on the tax maps of the Town of Clinton as Block 29, Lot 19.03 (the "Property"); and

WHEREAS, the Property is adjacent to certain property owned by the Town of Clinton, known as Hunts Mill Park, designated as Block 29, Lot 8 on the tax maps of the Town of Clinton (the "Park Property"); and

WHEREAS, the Property Owners inadvertently constructed certain structures which encroach on to Park Property, including a shed and swing set; and

WHEREAS, the Property Owners desire to construct a fence around the Property, which will require a 5-foot encroachment on to the Park Property, as depicted in the survey attached hereto as **Exhibit A**; and

WHEREAS, the Property Owner has requested permission from the Town of Clinton allow the shed and swing set to remain on a small portion of the Park Property and to construct a fence that encroaches on to the Park Property; and

WHEREAS, the Town Council desires to grant such permission, subject to the execution of an Easement Agreement in substantially the same form as attached hereto as Exhibit B.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Town of Clinton, County of Hunterdon, New Jersey, as follows:

- 1. The Mayor and Council hereby grant Peter Ochs and Laura Chambers Ochs, the owners of Block 29, Lot 19.03, a five foot wide easement running the length of the property line between Block 29, Lot 19.03 and Block 29, Lot 8 on the survey, attached as Exhibit A for the purpose of (1) maintaining the existing shed and swing set; and (2) constructing a fence, to be in compliance with all requirements set forth in the Code of the Town of Clinton. Nothing herein shall be considered as a grant of a permit to construct the afore-mentioned fence.
- 2. The Mayor and Clerk are authorized to sign the easement on behalf of the Town, in substantially the same form as attached hereto as Exhibit B.

- 3. The consideration for the easement shall be one dollar (\$1.00).
- 4. The Town Attorney is authorized to record said easement upon full execution.
- 5. This Ordinance shall take effect upon its adoption and final publication in accordance with law.

information at this time would have a potentially negative impact on the municipality's position in the litigation or negotiation; therefore this information will be withheld until such time as the matter is concluded or the potential for negative impact no longer exists.)
Matters falling within the attorney-client privilege, to the extent that
confidentiality is required in order for the attorney to exercise his or her ethical duties as a lawyer; (The general nature of the matter is: Land Acquisition OR the public

municipality's position with respect to the matter being discussed; therefore this information will be withheld until such time as the matter is concluded or the potential for negative impact no longer exists);
Matters involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance, promotion or disciplining of any specific prospective or current public officer or employee of the public body, where all individual employees or appointees whose rights could be adversely affected have not requested in writing that the matter(s) be discussed at a public meeting; (The employee(s) and/or general nature of discussion is
ORthe public disclosure of such information at this time would violate the employee(s) privacy rights; therefore this information will be withheld until such time as the matter is concluded or the threat to privacy rights no longer exists.;
Deliberation occurring after a public hearing that may result in the imposition of a specific civil penalty or loss of a license or permit;
BE IT FURTHER RESOLVED that the Mayor and Council hereby declare that their discussion of the subject(s) identified above may be made public at a time when the Town Attorney advises them that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the Town or any other entity with
respect to said discussion. That time is currently estimated to be:

BE IT FURTHER RESOLVED that the Mayor and Council, for the reasons set forth above, hereby declare that the public is excluded from the portion of the meeting during which the above discussion shall take place.
