MAYOR'S COMMENTS

Mayor Kovach expressed her gratitude to the Department of Public Works for their dedication to the Town of Clinton this past weekend. Thursday into Friday they took care of the roads with the snow that night and Friday through Sunday they dealt with three water main breaks, trying to locate the leaks on the mains and service leaks in the frigid weather. It is not often spoken, but they are very much appreciated!

Mayor Kovach asked that residents be mindful of parking on the streets during snow season. Parking on streets impedes plowing and cars will be ticketed.

Offices had hoped to re-open to the public, but due to the surge in COVID cases, offices will be kept closed through January. CLINTON COMMUNITY YOUTH ATHLETICS (CCYA)

Previously, as the Recreation Commission, in conjunction with the Clinton Community Youth Athletic League (CCYA), and led by volunteers throughout town, a basketball program was run for the children of the community.

As of February 10th, 2021 by Ord.
