Mayor Kovach read the following statement before opening it up to public comment:

I know there have been multiple social media posts regarding the Moebus property as well as affordable housing. I understand everyone's frustration, I'm disappointed that rather than reach out and ask the social media world has gone down rabbit holes that are not true. Many of you know me and have worked with me for the last 11 years, I will help anyone who asks and have always worked in the town's best interest.

I'm willing to take the hits when you disagree and some of the comments are reminiscent of the comments made about my character in June 2020. I hope that this can start the dialogue so that we speak to each other rather than hurl insults.

What I am sharing is all public information. And please bear with me – I will try to keep this concise but there is quite a bit of history.

Affordable housing has been a constitutional obligation since the early 80s. The obligations were determined per town and with the Council on Affordable Housing Round 1 and 2 had numbers of units established and housing built (Alton Place and Twin Ponds we also had several homes serving those with special needs that qualified).

The state, the legislature and the courts went back and forth with Fair Share Housing (the advocacy organization that pushes for the affordable housing in communities) in July 2015 Fair Share Housing went to court and filed against 300+ municipalities that we were not meeting our affordable housing obligation.

At that time Fair Share Housing determined that we needed approximately 200 new affordable units — which could equate to 1000 new housing units in town. Because a developer gets to build 4 market rate units for every affordable, they provide.

Around the same time the owners of the Moebus property unbeknownst to the town put up a website showing a plan on the Moebus property for 250+ garden apartments and 5 pad sites.

Mayor and council met with the property owners several times and said we would not support that project – it was too large and would change the landscape. The owners then entered the lawsuit as an intervenor telling the courts that they had the answer for the Town's affordable housing obligation.

We were in court with them for 3 years as we worked to come up with other ways to meet our obligation. We attempted to purchase the music hall property to put our housing there and the developer purchased it out from under us. Mayor and Council had multiple meetings over those years to work through opportunities and how to meet the obligations while protecting the integrity of our community.

The plan that was ultimately agreed to, reduced our overall obligation down to 66 new affordable units and yes provided the Moebus property owner with some development.

Every development that has been built in this town has come up against opposition, Alton Place, Kings Crossing, Pond Ridge, Rachel Court and most recently the Halstead Place apartments. Each time these projects came for approvals residents came out against – some more strongly than others. But here we are today counting many of the residents of those communities as our closest friends. I get that we don't like change, and we want to continue looking at the beautiful scenery around us but at the same time private property owners are granted rights as well. Short of the town purchasing all the remaining land and burdening the taxpayers with significant debt the best we can do is negotiate for the best possible scenario.

56 for sale townhomes are much different than 250 garden apartments. The 3 pad sites are on route 31 with no access to Center St and 12 acres donated for open space.

And ultimately the only jurisdiction of the council is regarding the affordable housing settlement and if there any amendments to those, they will be publicly noticed on Council agendas and will have to be subject to a noticed fairness and compliance hearing before the court both of which will provide for public opportunity to comment. Right now, there is nothing before council with regards to affordable housing.

PUBLIC COMMENTS

1. Mr. John Bohnel presented his concerns over the development of the Moebus track. He as well as many other residents he talks to would like it to stay as open space. He voiced many of his comments and concerns on Facebook which he is not sorry for. It has created quite a stir. Mr. Bohnel said he believes there are two alternative; stay with the developer or someone else purchase the property.

Mayor Kovach replied that is absolutely possible for someone to come in and buy the property. However, she stated it is still privately owned. The private owner cannot be forced to sell. Mr. Bonnell stated he still has hope to keep it green acres. Mayor Kovach responded the town's responsibility is not to strong arm anyone. The organization looking to purchase the property has an opportunity to negotiate with the purchaser. Mayor Kovach said we can all hope. Many previous council members have spent many hours on this subject in the past. There was a lot of effort and days spent on this project and we were able to get 12 acres donated to the Town. When the Land Use Board has their meeting on the Moebus track anyone can give their concerns and questions during the public comment. Allison Witt, Board Secretary, is in the process of looking for a venue to hold a large crowd.

Councilwoman Johnson said many of these questions were addressed years ago at several town hall meetings under the affordable housing issues to discuss the development of this property. They are just coming up again to the Land Use Board. The council just approved the plan and Land Use approved the plan. Those are zoning matters. There are many other things the development must go through for example DEP, DOT, Highlands Council and the bald eagle issue. Many other things have to happen before start project.

Mr. Jeff Hedden asked council how many affordable housing units Clinton still needs to have. Mayor Kovach said we need about another 30 more unites and this development helps with that. We will get about 10 units that the developer has to provide toward affordable housing. All these obligations are court mandated from Fair Share Housing.

Ms. Norma Kania said to her understanding is it true that our obligations can change in 2025 for the new mandates on affordable housing. Mayor Kovach said 2025 would be the next round but that does not mean we get new housing obligations. There is not much property left that is zoned and we have restrictions on out water and sewer capacity. Mayor Kovach said we may wind up finding existing apartments to solve this issue.

Mr. Bonnell asked if we can send petitions to our representatives. He still has hope. Mayor Kovach said that would be great idea. Many legislators do not want to take on affordable housing. Mayor Kovach emphasized again that if anyone wishes to talk to her about this subject she is available. Mr. Bonnell thanked Mayor and Council for their answers.

MAYOR'S COMMENTS

1. Council is in receipt of a Citizen Involvement form from Amy De Vita. Mayor Kovach asked for a motion to appoint Amy De Vita to the Economic Development Committee. Motion made by Mr. Kashwick, seconded by Ms. Johnson to appoint.

2. Mayor Kovach announced that if all goes though 66% of the school funding that was cut will be restored. There was an agreement between the Legislature and the Governor's office.

- 3. The debris on Halstead Street Bridge will be cleaned up and removed in the next couple weeks. It may cost the county about \$17,000 to clean up.
- 4. Congressman Kane's State Director came out to look at the 78 overpass. Mayor Kovach said she has a call out to DOT and hopefully come to some resolutions or what we can do. Fingers crossed!!

GIRL SCOUTS OF AMERICA PROCLAMATION

Mayor Kovach read a proclamation on the importance of Girl Scouts to today's girls, declaring 22nd day of March 2023/March 12-18, 2023 to be Girl Scout Week. Girl Scouts Heart of New Jersey serves 11,000+ girls across New Jersey. Four girl scouts with their leader were present for the reading. A copy of the proclamation was presented to them.

CASA PROCLAMATION

Mayor Kovach read and presented a proclamation to a member of the Court Appointed Special Advocates (CASA). CASA programs have a record of public service, helping to protect the safety and wellbeing of abused and neglected children in Somerset, Hunterdon and Warren Counties who have been removed from their homes due to neglect and abuse. CASA volunteers serve as the court's eyes and ears in a child's life.

A copy of this Ordinance will be published in the Hunterdon Democrat edition of March 30, 2023. A public hearing will be held April 26, 2023.

Mayor Kovach stated the budget letter will be going out tomorrow. Also since the garbage collection is being a garbage utility the council wanted to reduce the municipal tax rate to address that. The average assessed home value is \$387,344.00 and homeowners will see a reduction of \$224.00 in their municipal tax. There is a reduction of 2.05% in our levy and a 6.54% reduction in our tax rate. Mayor Kovach reiterated we did everything we can financially to give back to the residents.

As far as trees in other areas, the commission needs to wait until the trees start blossoming to get a better determination. Per a request of a resident on Pond Ridge Drive, there are about 7 trees behind the townhomes where one is very big and others are small with several trunks coming off of them. The resident is asking the town to do something since they overhang the decks there. The commission is looking into the pruning of the cherry trees downtown.

- 2. Arbor Day is April 28. Mr. Dan Shea will be the honoree this year. He has worked many years on the Shade Tree Commission. It will be at Hunts Mill Park.
- 3. The Commission is in the process of getting quotes for trees to use the grant money the town received. There was an issue with the grant period but Mr. Rich Phelan, Business Administrator, helped with that. Letters are going to go out to residents to see if they would like any trees planted in front of their resident.
- 4. The Mr. John "Jack" Holt tree dedication will be on July 1st instead of the end of June.
- 5. The Environmental Commission will be having the River Clean Up on April 15th. Veronica Lambert reached out to the Raritan Headwaters and they said someone else from the town called to run the event. As of now the commission does not know who that person is. They will find out and report back.
