Another submission was made last week for additional federal funding for next year's project, the third and fourth phase of the West Main Street water project.

- 4. Mayor Kovach met with Zane Moore, the new CEO of Hunterdon County YMCA which recently merged with Bucks County, PA. YMCA. Mr. Moore is visiting municipalities and listening to the needs of kids and parent's requests. In Bucks County, they built an all inclusive center for all ages and we are welcomed to tour the newest ideas.
