The parade will be followed by the flag retirement ceremony at the Red Mill organized by the Scout Troop 191 and Councilman Traphagen. The Clinton Guild is also offering "Sponsor a Tree"! Mr. Traphagen is setting up the information on the website. Sponsors will get one of the coveted gold plaques placed on the box around the tree to show you helped support beautifying our downtown!

Rubber Ducky Race is July 10, 2022, the annual event sponsored by the Sunrise Rotary. The Guild is sponsoring the third place prize! Mr. Traphagen and Mayor Kovach will be in the water! Great event!!

The Superhero Race is hoping to make a return to Clinton, October 8, 2022! The Economic Development Commission is helping member Elizabeth Halpin apply for a County "Rediscover Hunterdon's Communities Grant Program".
