#### **PUBLIC COMMENTS**

John Bohnel, 76 Center Street, came before council to discuss two matters. Mr. Bohnel's first concern is the proliferation of political signs throughout town. Mr. Bohnel suggested removing the signs until October 1<sup>st</sup>.

Second concern: As a resident of 22 years with a love and support of the town, Mr. Bohnel is disturbed with opinions based on what he believes to be facts that the town wants to spend \$1M on a playground and spent \$25,000 in 2019 to Suburban Consulting for renderings of a playground. Mr. Bohnel was told the drawings were needed to attain grant money.

Mr. Bohnel reported that he visited Glassboro parks system with Councilman Perloff and was informed that their three playgrounds were community built. In previous discussions with council, Mr. Bohnel was told the playground could not be built by the community because of ADA compliance. Mr. Bohnel and Councilman Perloff chose to be proactive for the town. Mr. Bohnel spoke of floating tiles for the tennis courts from a company called Mataflex from Utica, New York, a company that drove four and a half hours to visit our playground and with a few repairs was given a quote of \$34,000. Mr. Bohnel said he attempted to give information to the town and in his opinion was "practically thrown out" dismissed, not by council. Mr. Bohnel continued to say the scheduling of the tennis court was for early September, however, the contractors showed up 8:00 a.m. today, August 28, 2022. Mr. Bohnel had Eagle Fence visit the site as well and was told the poles were fine, solid and slight repairs could be made to pull the ties at the top, price \$18,000.

Mr. Bohnel's opinion is "we could have gone down another course" and his motto is "never look back" but hopes the playground is going to be handled differently than the tennis courts.

Testimony submitted by Mr. Bohnel is attached to these minutes.

Mayor Kovach expressed her appreciation to Mr. Bohnel for taking the initiative and for doing the research for the renovations of the tennis courts at the Community Center. The Council meeting of September 28, 2022 will focus on the playground. A representative of Jake's Law has been invited. Mayor Kovach thanked everyone for their input regarding ideas and fundraising efforts.

Lisa Intrabartola, 19 Georges Place, gave an update of the newly formed Booster Club. Ms. Intrabartola talked about fundraising efforts that have been going very well! The club invited Councilman Perloff to jump in and join the group. The next meeting is September 19 @ 7:30 p.m. for anyone interested. Next event is Friday, August 26 at Sunken Silo on Route 22, "Pints for the Park" at 7:30 p.m. Ms. Intrabartola and the Booster Club is working hard to have an all inclusive park, ADA requirements are the bare minimum which passed 32 years ago. Hopes to take it a long way above the law. When all children, diverse in many ways, can play together, they grow to be wonderful human beings.

Molly Padmos, 16 Water Street, expressed her appreciation to Council and Councilwoman Johnson, for all their hard work and hope everyone can come together to continue to work for the Town, the park and the Booster Club.

Jonathan Donath, 9 Cypress Court, is a parent of two young children in CPS and offered to help in any way, to develop a park that will fit the family friendly town and to upgrade the playground. Residents "do want this" and Mr. Donath has every confidence in the elected official it will be done properly! Very exciting! Applaud everyone involved in fundraising.

Mayor Kovach reiterated her feelings of appreciation to everyone and ultimately all on the same page. Mayor Kovach reached out to the Mayor Wallace of Glassboro and their CFO and learned they have ADA park playgrounds. They have an extensive crew working on the parks. To quote former mayor and school teacher, Allie McGaheran, "you can continue to complain or step up and be part of the solution"!

Councilman Perloff explained he has three young girls, the youngest with three IEP's and 2 older daughters, Mexican born living in a non-Mexican neighborhood. Mr. Perloff is excited to have his

daughters enjoy the playground and made it clear he has never been against an all-inclusive playground. Mr. Perloff is grateful for all the work Councilwoman John and the Booster Club is doing and will continue doing. Mr. Perloff is grateful to learn and work with everyone and concurs the end game will work out.

Nicole Ayers, 18 Fairview, has bi-racial children and to echo Mr. Perloff's comment, they are in a minority position. One of her daughter's has sensory issues and agrees that anything less than all-inclusive would be a disservice to a portion of our community. Clinton would be the only all-inclusive playground in Hunterdon County and the greater area.

Councilwoman Johnson gave a brief background of her professionalism and the importance of an allinclusive playground. Councilwoman Johnson did comment for the record that since the beginning, she was pushing for the playground not the tennis courts. Research and working together is what everyone is working towards.

Ms. Intrabartola said the public meeting will be good but asked if people's comments will be limited? Mayor Kovach said we like to be respectful and give people a chance to speak and share their comments but would like to keep comments to a five minute timeframe.

Councilman Humphrey stated how important volunteerism is and if people did volunteer to step up earlier much more could be addressed early on.

Many good conversations took place and Senator Booker, heard how about the American Rescue money being spent. \$24,000,000 came to the County and \$250,000 was allocated for tourism and will continue to grow. Senator Booker heard of the initiatives being taken to increase tourism including the Beer Trail, the 579 Trail and lots of others. Frenchtown was named best downtown shopping and we need to support our sister towns.
- 2. Mayor Kovach proudly announced that the 1<sup>st</sup> Annual Hunterdon Games was a huge success!! Clinton came in second place, Union Township took first! Clinton Township and Bethlehem Township 3<sup>rd</sup> and 4<sup>th</sup>. Many municipalities took part in this fun packed day. Elvira Bruno was amazing how she corralled all the participants and so much more! A special thank you to Elvira for taking the reins. Councilmen Bruno and Humphrey suffered combat wounds but doing well! Mayor Kovach thanked everyone who participated in the awesome day!

## **INTRODUCTION OF ORDINANCE #22-10 AMENDMENT TO TOWING & STORAGE FEES**

A motion was made by Mr. Perloff, seconded by Mr. Humphrey, to introduce Ordinance #22-10 on first reading as submitted:

## ORDINANCE # 22-10 ORDINANCE AMENDING FEE SCHEDULES FOR TOWING AND STORAGE OF MOTOR VEHICLES

**WHEREAS**, Chapter 129 of the Code of the Town of Clinton provides for the establishment of a fee schedule for towing and storage of motor vehicles by ordinance based on recommendations received by the Mayor and Council from the Chief of Police; and

**WHEREAS**, Chief Kubinak has provided recommendations on the appropriate fees to be charged for towing and storage of motor vehicles within the Town of Clinton through 2023; and

WHEREAS, the Mayor and Council have reviewed and accept those recommendations;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Town of Clinton, the County of Hunterdon as follows:

**SECTION 1.** The towing and vehicle storage rate schedule, found in Chapter 129, Attachment 1 of the Code of the Town of Clinton, be amended as follows (deletions noted in strikethrough thus, and additions noted in bold italic *thus*):

## TOWN OF CLINTON TOWING RATE & STORAGE SCHEDULE

Rates and Fee Schedule

## 1. Light-duty day Rate (8:00 a.m. – 5:00 p.m. anytime)

For vehicles with a gross vehicle weight ("GVW") under 10,001 lbs, \$125.00 \$90.00 per towing vehicle dispatched, plus fees for any additional service performed and \$5.00 per mile after the first 6 miles from the scene to operator's garage. which includes towing up to six miles plus any fees for additional services performed.

(mileage fee for over 6 miles from scene to operator's garage) \$4.00 per mile.

- 2. Light-duty night rate (5:00 p.m. 8:00 a.m.)
  - \$125.00 per towing vehicle dispatched, which includes towing up to six miles from scene. The night rate shall also apply to all tows on Sundays and legal holidays in the State of New Jersey.

(mileage fee for over 6 miles from scene to operator's garage) \$4.50 per mile.

## 2. Road Service, Gas, Tire Change, Lockout, Battery Jump (Anytime):

\$75.00 (8:00 a.m. 5:00 p.m.)

\$90.00 (5:00 p.m. 8:00 a.m.) The night rate shall also apply to all tows on Sundays and legal holidays in the State of New Jersey.

*\$125* (plus cost of any material used, including but not limited to gasoline).

3. <u>Medium Towing</u> – For motor vehicles with a gross weight *GVW* between 10,001 pounds to 26,000 pounds:

\$215.00 per towing vehicle dispatched \$250.00 per hour with a minimum of one hour per towing vehicle dispatched regardless of the time of day, plus \$6.50 \$6.00 per mile from scene, after the first 6 miles.

- 4. <u>Heavy Duty Towing with Conventional-Wrecker (*any type*)</u> For motor vehicles with a gross weight *GVW* over 26,000 pounds which can be moved with a conventional wrecker: \$300.00 \$425.00 per hour with a minimum of one hour per towing vehicle dispatched regardless of the time of day, plus \$6.00 \$6.50 per mile from scene, after the first 6 miles.
  - 5. <u>For all Specialized Recovery Incidents requiring specialized Equipment</u> (aside from what' is listed above) for towing, storage or equipment, refer to Garden State Towing Association's Rate chart found at <u>www.gsta.org</u>, which are the rates established by the New Jersey State Police for tow operators on State highways,

6. Heavy Duty Towing with Under Reach Towing - For a motor vehicle with a gross weight over 26,000 pounds where under reach towing is required:

\$325.00 per hour with a minimum of one hour per towing vehicle dispatched regardless of the time of day, plus (\$6.00 per mile from scene, after the first 6 miles)

7. Vehicles that are locked and in park or in gear - Additional services fee: \$35.00

8. These rates do not apply to recovery which includes impales, over-turned, or off road.

6. <u>Additional Work</u>

Hourly rate, charged in quarterly increments (first 15 minutes is not billable) clean-ups, winch work, dolly work – \$75.00 per hour.

7. <u>Storage Fees</u>

Storage Fees become effective after the first 11 hours of a vehicle tow.

Vehicles with a GVW of less than 10,001 pounds - \$45.00 per day

All other vehicles with *a GVW* gross weight over 10,001 pounds - \$90.00 per day or part thereof.

Indoor storage - \$90 per day.

Vehicles will be released during normal business hours:

Monday Friday (8:00 a.m. 5:00 p.m.)

Saturday (8:00 a.m. 12:00 p.m.)

After hours vehicle release fee - \$75.00 per vehicle

All towing charges noted above are from *the* initial *scene* / incident to *the* towing garage. Any towing to alternate sites *shall* will be negotiated between *the* tow operator and *the* customer

**SECTION 2.** All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**<u>SECTION 4.</u>** This Ordinance shall take effect upon final passage and publication.

**WHEREAS**, on April 28, 2021, the Mayor and Council of the Town of Clinton (Town) ratified the Collective Bargaining Agreement between the Town and the Teamsters Local 469 (Teamsters) via Resolution #84-21; and

**WHEREAS**, the Town has required all employees within the Water/Road Department to possess a Commercial Driver's License (CDL), to which all current employees are compliant; and

**WHEREAS**, based on the new regulations imposed by the Federal Motor Carrier Safety Administration (FMCSA) on February 7, 2022, any new applicant wishing to obtain a CDL can no longer do so in the manner historically used to obtain this license and must complete a costly and lengthy training process; and

**WHEREAS**, as a direct result of this new Federal requirement, the Town had several vacancies within the Water/Roads Department that they have been unable to fill for over six (6) months; and

**WHEREAS**, the Town recognizes the need to have a sufficient number qualified and trained employees within their Department of Public Works in order to adequately provide services to the residents of Clinton; and

WHEREAS, the Town currently has a sufficient number of employees who possess CDL's; and

**WHEREAS**, the Town of Clinton and Teamsters Local have subsequently agreed to make certain changes to the terms and conditions of the Collective Bargaining Agreement, specifically amendments to "Schedule A" by creating a new, separate rate of pay for employees that do not possess a CDL who are assigned to the Water/Roads Department without penalizing existing employees in this department who have obtained their CDL already; and

**WHEREAS**, the Town and Teamsters have executed a Memorandum of Understanding approving the attached changes; and

WHEREAS, upon adoption of this resolution,

- 1. All references to "Schedule A" in the Collective Bargaining Agreement shall now refer to the amended version referenced herein.
- 2. All existing terms and conditions not referenced in this Resolution shall remain in full effect and cannot be altered or amended without the mutual consent of the Town of Clinton and the Teamsters Local 469.; and

**NOW THEREFORE BE IT RESOLVED**, that the Mayor and Council hereby authorize and ratify the amendments to the Collective Bargaining Agreement between the Town of Clinton and Teamsters Local 469 as more fully described in the preceding paragraphs in this Resolution, which are expressly incorporated herein by reference.

**BE IT FURTHER RESOLVED** that the Town of Clinton shall enter into and execute an amended Collective Bargaining Agreement incorporating the amendments set forth in this Resolution.

**BE IT FURTHER RESOLVED** that the provisions of this Resolution are expressly conditioned on Teamsters Local 469 having approved the aforesaid amendments to the Collective Bargaining Agreement, and the provisions contained herein shall have no force or effect absent such approval by Teamsters Local 469.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution be forwarded to the Town of Clinton Chief Financial Officer and the Teamsters Local 469.

**WHEREAS,** as the Town's Water Committee is satisfied with the information outlined by Suburban Consulting Engineers, the application is deemed complete, to which they have granted a final approval and have imposed the conditions listed in Suburban Consulting Engineers August 11, 2022 letter.

**NOW, THEREFORE BE IT RESOLVED,** that in accordance with Chapter 142, Section 1, Sub-section J(3) of the Town's Ordinances, the Mayor and Council hereby approves Water Reservation Application # L22-03 in the amount of 4,425 GPD for a period of twelve (12) months.

#### **RESOLUTION #129-22 – OPPOSING PROPOSED INCREASES IN SHBP**

#### **RESOLUTION 129-22**

#### **Resolution Opposing the Proposed Increases to the State Health Benefits Program**

WHEREAS, the State Health Benefits Program (SHBP), governed by N.J.S.A. 52:14-17.25 et seq., offers medical, prescription drug, and dental coverage to qualified State and participating local government public employees, retirees, and eligible dependents; and

WHEREAS, all SHBP plans are self-funded meaning that the money paid out for benefits comes directly from a SHBP fund supplied by the State, participating local employers, and member premiums; and

WHEREAS, the Division of Pensions and Benefits is responsible for the daily administrative activities of the SHPB, the State Health Benefits Commission is the executive organization responsible for overseeing the SHBP; and

WHEREAS, the State Health Benefits Commission, comprised of state officials and union representatives, annually consider the calendar year premium levels for the Local Government Employer Group of the SHBP based on recommendations found in the Rate Setting Recommendation Analysis of the Local Government Employee Group; and

WHEREAS, the preliminary rate increase for the 2023 Local Government Employer Group is 22.8%, which includes a 21.6% increase for Active, a 13% increase in Early Retiree, and a 0.7% increase for Medicare Retiree; and

WHEREAS, subsequent news accounts has Department of Treasury noting "rates for active members and early retirees would likely be increase between 12-20% across the various plans for the upcoming year"; and

WHEREAS, such proposed exorbitant rate increases will fall upon the local property taxpayer along with the local public employees at a time where there is record inflation, and

WHEREAS, the proposed premium increase for most active employees will take thousands more out of their paychecks annually and lead to huge costs for local governments that will translate into higher property tax bills for struggling families; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Town of Clinton in the County of Hunterdon call up the State Health Benefit Commission to reconsider the rate increase and strike a rate increase that is appropriate in the current economic conditions; and

BE IT FURTHER RESOVLED, that the governing body of the Town of Clinton in the County of Hunterdon, urge the legislature to adopt legislation expanding the composition of the State Health Benefits Commission to include representatives from both municipal and county government management; and

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to Governor Murphy, State Treasurer Muoio, Senate President Scutari, Assembly Speaker Coughlin, Michael Doherty, John DeMaio and Erik Peterson, and New Jersey State League of Municipalities.

Understanding that this is just one of many jobs you are required to perform and have limited time, I have reviewed the recording of the meeting and would suggest that the minutes are amended in this manner, as many of the points I made were left out, and I believe are important. John Bohnel, 76 Center Street, came before the council to discuss three matters.

Mr. Bohnel's first concern is the proliferation of political signs throughout town. Mr. Bohnel suggested removing the signs until October 1<sup>st</sup>.

Second concern: Stating that as a Town resident of 22 years and has demonstrated in many ways his love and support of the town, Mr. Bohnel is now deeply disturbed that the town is seriously entertaining the expense of \$1,000,000.00 on a new playground, and anticipating paying on top of that a consulting/design firm, for a second time, to design it.

He stated that he learned the Town had already spent \$25,000 in 2019, paid to Suburban Engineering, for a preliminary design and renderings of a playground. To the best of his knowledge, he said, nothing has been done to develop and act on what Suburban proposed. Mr. Bohnel stated that he was told by playground committee members and the Town Business Administrator that the drawings were needed at that time to attain grant money.

Mr. Bohnel reported that his research on community-build playgrounds, meaning he stated, that all the labor is done by volunteers, led him to the Town of Glassboro NJ. He shared that he and Councilman Perloff drove to Glassboro to tour their playgrounds at the invitation of Glassboro's Recreation Director and DPW Director and was informed that their three ADA playgrounds were community-built for a total cost of approximately \$175,000. He said the playground contractor Glassboro hired was already "state-approved" and did all the playground design work, plan drawings, and engineering free of charge.

In previous discussions with several Town of Clinton council people and administrators, Mr. Bohnel and Mr. Perloff had been told the playground could not be built as a community-build because of ADA compliance.

Third concern: Mr. Bohnel also addressed the \$137,000 the Town of Clinton Playground Committee and Town Council has approved to demolish the existing tennis court and fence and replace them in their entirety.

He stated in his opinion as a former building contractor, that from his observation of the existing court, that minor cracks could have been repaired easily by the Public Works Department, and put back into service before the gate to the court was locked last October. He said he observed no other surface irregularities, such as "heaving" which he said, implies that certain areas of the court had become unstable and shifted in terms of being level and causing potential 'tripping' hazards. Mr. Bohnel said he asked the Town Business Administrator if the town had requested an engineering study to determine that the court was in such poor condition that replacement was that an engineering report could not be provided because it wasn't done. Instead, Mr. Bohnel was told, the Town was

advised by their insurance accessor that the tennis court was "unsafe." Mr. Bohnel said he asked the Administrator if the accessor was questioned about what could be done to make it "safe," but that question was not answered

not answered. Mr. Bohnel stated that as a result of his research that the tennis court could be resurfaced by installing plastic modular floating tiles, available from a 36 year-old company called Mateflex from Utica, New York. He arranged for the Mateflex sales manager to visit our tennis court and was provided a written quote for resurfacing, which the sales manager said, according to Mr. Bohnel, was in better condition than most of the courts they resurface, for \$34,000 in material, as a community-build, with Mateflex onsite supervision. The sales manager, said Mr. Bohnel, told him they do many community build projects.

And because of the excellent condition of our court, granting that the cracks had to be filled, Mr Bohnel was told Mateflex would warrantee their product for 15 years, replace any faulty tiles for free for up to five years, and would be happy to provide locations of courts they resurfaced that were still in use after 20 years of service. Mr. Bohnel stated that Mateflex provided the same material for The Town of Glassboro, which did a community-build for a complex of eight tennis courts at a cost of \$185,000. Mr. Bohnel said he has been petitioning the Town over the last week to try to cancel the \$137,000 contract. For the reason, he said, that if it could be done, the savings would pay for a large portion of a new playground, if not all of it

all of it.

all of it. He claimed he attempted to discuss the cancellation, the reason for doing so, and how it might be done, with the Town's Business Administrator in his office on August 12th, and in his opinion, was "practically thrown out." Mr. Bohnel said he was told by the Business Administrator that day, that the tennis court demolition and new construction was scheduled for early September. But to Mr. Bohnel's amazement, he said, the contractors showed up to start the work at 8 a.m. today, August 24th. After hearing this news about 10:30 am today, he stated he visited the playground about noon, which was already 50% demolished, and he was told by the son of the owner of the contractor, Shore Top Construction, who was also the crew foreman, that (1) when the team showed up at the site they thought they were at the wrong tennis court because it appeared to be in great shape, and that (2) they were only told yesterday (Aug 23rd) that their scheduled changed and they were to mobilize to come to Clinton tomorrow (today). "How and why could this have happened?" Mr. Bohnel asked.

Mr. Bohnel also stated that he asked the owner of Eagle Fence Company, of Branchburg, to meet him at the site a week ago for an evaluation of the existing tennis court fencing. He stated he was told that the fence poles were in excellent condition, solid and plumb, and that repairs could be made on the lower portion of the fencing itself, which was bulging out from people running into it, by cutting the existing ties that hold it to the poles, pulling the fencing tight, and re-tying it. However, because he was asked for an estimate, the owner of Eagle Fencing submitted a written quote for \$18,000 to replace all the fencing, without poles. Mr Bohnel noted that he understood this was not a 'prevailing wage' price, and he estimated that perhaps \$5-10,000 could be tacked on to make it 'prevailing wage.' to make it 'prevailing wage

Mr. Bohnel's summarizing opinion was that the Town of Clinton could have gone down another road and saved in the vicinity of \$100,000 of hard-earned grant money by refurbishing the tennis court, not replacing it. In addition, he stated, the \$25,000 paid to Suburban Engineering in 2019 and the \$14,900 just paid to Suburban Engineering for tennis court blueprints and specifications, was in his opinion, unnecessary and wasteful, and that that money that could have been spent on actually constructing a new playground.

Mr Bohnel then shared that his motto is "never look back," and said that since the Town Council had already voted 6-1 in an Executive (private) Session against trying to cancel the contract, and that the existing tennis court is now virtually gone, we must now move on together as a town. He expressed that he hopes, and expects, the playground project is going to be handled in an entirely different manner than the tennis courts. He then complimented the Council members for their service, contributions, and hard work, but stated that in his opinion, they were misled by the information they were provided about both the tennis court and the playground.

Mayor Kovach expressed her appreciation to Mr. Bohnel for taking the initiative and for doing the research for the renovations of the tennis courts at the Community Center, and that Mr Bohnel will be given the opportunity by invitation to serve on a new playground committee she will be forming. The Council meeting of September 28, 2022 will focus on the playground. A representative of Jake's Law has been invited. Mayor Kovach thanked everyone for their input regarding ideas and fundraising efforts.
